A BILL

To provide equity in education funding for the States received under chapter 1 of title I of the Elementary and Secondary Education Act of 1965.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Equal Education
5 Funding Act”.

1 **SEC. 2. FORMULA CHANGES.**

2 (a) AMOUNT OF GRANTS.—Subsection (a) of section
3 1005 of the Elementary and Secondary Education Act of
4 1965 is amended—

5 (1) in paragraph (1)—

6 (A) by inserting “AND PUERTO RICO” after
7 “GRANTS FOR TERRITORIES”;

8 (B) by striking “1 percent” and inserting
9 “4.5 percent”; and

10 (C) by inserting “and Puerto Rico” after
11 “Virgin Islands” each place it appears;

12 (2) in paragraph (2)—

13 (A) by striking “AND PUERTO RICO” after
14 “GRANTS FOR LOCAL EDUCATIONAL AGEN-
15 CIES”;

16 (B) subparagraph (A), by striking “deter-
17 mined by multiplying” and all that follows
18 through the end of clause (ii) and inserting the
19 following:

20 “the sum of—

21 “(i) the product of—

22 “(I) 50 percent of the number of
23 children counted under subsection (c);

24 and

1 “(II) the average educational cost
2 factor of the State, except as provided
3 in subparagraph (C); and

4 “(ii) the product of—

5 “(I) 50 percent of the number of
6 children counted under subsection (c);
7 and

8 “(II) the average per pupil effort
9 factor of the State, except as provided
10 in subparagraph (C); and

11 (C) by amending subparagraph (C) to read
12 as follows:

13 “(C)(i) In determining the amount under
14 subparagraph (A)(i)—

15 “(I) if the amount of the average edu-
16 cational cost factor in the State is less
17 than 80 percent of the amount of the aver-
18 age educational cost factor in the United
19 States, the amount of the average edu-
20 cational cost factor shall be 80 percent of
21 the average educational cost factor in the
22 United States; or

23 “(II) if the amount of the average
24 educational cost factor in the State is more
25 than 120 percent of the amount of the av-

1 average educational cost factor in the United
2 States, the amount of the average edu-
3 cational cost factor shall be 120 percent of
4 the average educational cost factor in the
5 United States.

6 “(ii) In determining the amount under
7 subparagraph (A)(ii)—

8 “(I) if the amount of the average per
9 pupil effort factor in the State is less than
10 80 percent of the amount of the average
11 per pupil effort factor in the United
12 States, the amount of the average per
13 pupil effort shall be 80 percent of the aver-
14 age per pupil effort factor in the United
15 States; or

16 “(II) if the amount of the average per
17 pupil effort factor in the State is more
18 than 120 percent of the amount of the av-
19 erage per pupil effort factor in the United
20 States, the amount of the average per
21 pupil effort factor shall be 120 percent of
22 the average per pupil effort factor in the
23 United States.”

24 (3) in paragraph (4), by inserting “Puerto
25 Rico” after the “Virgin Islands”.

1 (b) DETERMINATION OF NUMBER OF CHILDREN.—
2 Subparagraph (A) of section 1005(c)(2) of the Elementary
3 and Secondary Education Act of 1965 is amended by
4 striking “on the basis of” and all that follows through “de-
5 cennial census” and inserting the following:

6 “for local educational agencies (or, if such data
7 are not available for such agencies, for coun-
8 ties) on the basis of—

9 “(i) if available, criteria developed by
10 the Department of Commerce to determine
11 annual poverty statistics by age; or

12 “(ii) if the information described in
13 clause (i) is not available, annual percent-
14 age adjustments to the most recent poverty
15 statistics available, derived by applying the
16 most recent calculation of the number of
17 students aged 5 to 17 determined by the
18 Bureau of Census in its annual Population
19 Statistics to the percentage in poverty in a
20 State from such poverty statistics.”.

21 **SEC. 3. DEFINITIONS.**

22 Part A of chapter 1 of title I of the Elementary and
23 Secondary Education Act of 1965 is amended by inserting
24 after section 1005, the following:

1 **“SEC. 1005a. TERMS DEFINED FOR BASIC GRANTS.**

2 “For purposes of section 1005—

3 “(1) the term ‘average per pupil expenditure’
4 means in the case of a State or the United States,
5 the aggregate current expenditures, during the fiscal
6 year for which the computation is made (or, if un-
7 available, the most recent fiscal year preceding the
8 fiscal year for which the computation is made,) of all
9 local educational agencies in the State plus any di-
10 rect current expenditures by the State or in the
11 United States (which for the purposes of this para-
12 graph means the 50 States and the District of Co-
13 lumbia), divided by the number of children enrolled
14 in schools of such agency on the closest school day
15 to October 1 of such fiscal year;

16 “(2) the term ‘average educational cost factor’
17 means the sum of 50 percent of the ratio of the av-
18 erage per pupil expenditure of a State in relation to
19 all States, and 50 percent of the average instruc-
20 tional staff salaries factor of such State;

21 “(3) The term ‘average instructional staff sala-
22 ries factor’ means the average salary of classroom
23 teachers in elementary and secondary schools in a
24 State divided by the average of such salaries for all
25 States;

1 “(4) The term ‘per pupil income’ means the
2 total gross personal income of a State during a spe-
3 cific year as reported by the Department of Com-
4 merce, Bureau of Economic Analysis, divided by the
5 total number of children aged 5 to 17 for such State
6 for the same year as reported by the Department of
7 Commerce, Bureau of Census.

8 “(5) The term ‘average per pupil effort factor’
9 means the average per pupil expenditure of the
10 State divided by the average per pupil income factor
11 of the State; divided by the quotient of the average
12 per pupil expenditure of the United States and the
13 average per pupil income factor of the United
14 States.”.
