## A BILL

To amend title V of Public Law 96–550, designating the Chaco Culture Archeological Protection Sites, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Chacoan Outliers Pro-  
5 tection Act of 1993”.

6 **SEC. 2. CONFORMING AMENDMENT.**

7 (a) Section 501 of Public Law 96–550 (16 U.S.C.  
8 410ii) is amended in the title by striking “Congressional  
9 findings” and inserting in lieu thereof “Congressional  
10 findings and purpose”.

1 (b) Section 501(b) of Public Law 96–550 (16 U.S.C.  
 2 410ii(b)) is amended by striking “San Juan Basin;” and  
 3 inserting in lieu thereof, “San Juan Basin and surround-  
 4 ing areas;”.

5 **SEC. 3. ADDITIONS TO CHACO CULTURE ARCHEOLOGICAL**  
 6 **PROTECTION SITES.**

7 Subsection 502(b) of Public Law 96–550 (16 U.S.C.  
 8 410ii–1(b)) is amended to read as follows:

9 “(b)(1) Thirty-eight outlying sites as generally de-  
 10 picted on a map entitled ‘Chaco Culture Archeological  
 11 Protection Sites’, numbered 310/80,033–B and dated Sep-  
 12 tember 1991, are hereby designated as ‘Chaco Culture Ar-  
 13 cheological Protection Sites’. The thirty-eight archeologi-  
 14 cal protection sites totaling approximately 14,287 acres  
 15 identified as follows:

1       “(2) The map referred to in paragraph (1) shall be  
2 kept on file and available for public inspection in the ap-  
3 propriate offices of the National Park Service, the office  
4 of the State Director of the Bureau of Land Management  
5 located in Santa Fe, New Mexico, the office of the Area  
6 Director of the Bureau of Indian Affairs located in Win-  
7 dow Rock, Arizona, and the offices of the Arizona and  
8 New Mexico State Historic Preservation Officers.”.

9       **SEC. 4. ASSISTANCE TO THE NAVAJO NATION.**

10       Section 506 of Public Law 96–550 (16 U.S.C. 410ii–  
11 5) is amended by adding the following new subsection at  
12 the end thereof:

13       “(f) The Secretary is directed, subject to appropria-  
14 tions, to assist the Navajo Nation in the protection and  
15 management of those Chaco Culture Archeological Protec-  
16 tion Sites located on lands under the jurisdiction of the  
17 Navajo Nation through a grant, contract, or cooperative

1 agreement entered into pursuant to the Indian Self-Deter-  
2 mination and Education Act (Public Law 93-638), as  
3 amended, to assist the Navajo Nation in site planning, re-  
4 source protection, interpretation, resource management  
5 actions, and such other purposes as may be identified in  
6 such grant, contract, or cooperative agreement.”.
