AN ACT

To designate the facility of the United States Postal Service located at 401 South Washington Street in Chillicothe, Missouri, as the “Jerry L. Litton United States Post Office Building”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DESIGNATION.**

4 The facility of the United States Postal Service lo-
5 cated at 401 South Washington Street in Chillicothe, Mis-
6 souri, is designated as the “Jerry L. Litton United States
7 Post Office Building”.

1 **SEC. 2. LEGAL REFERENCES.**

2 Any reference in a law, regulation, document, record,
3 map, or other paper of the United States to the facility
4 referred to in section 1 is deemed to be a reference to
5 the “Jerry L. Litton United States Post Office Building”.

6 **SEC. 3. TRAVEL AND TRANSPORTATION EXPENSES OF CER-**
7 **TAIN FEDERAL CAREER APPOINTEES.**

8 (a) *IN GENERAL.*—Section 5724(a)(3) of title 5,
9 United States Code, is amended by striking out “November
10 27, 1988” and inserting in lieu thereof “November 17,
11 1988”.

12 (b) *EFFECTIVE DATE.*—The amendment made by sub-
13 section (a) shall take effect as if included in the Technical
14 and Miscellaneous Civil Service Amendments Act of 1992
15 (Public Law 102–378; 106 Stat. 1346; 5 U.S.C. 1101 note).

Amend the title so as to read: “An Act to designate the facility of the United States Postal Service located at 401 South Washington Street in Chillicothe, Missouri, as the ‘Jerry L. Litton United States Post Office Building’, and to authorize travel and transportation expenses for certain Federal career appointees, and for other purposes.”.
