Mr. HUGHES introduced the following bill; which was referred to the
Committee on Post Office and Civil Service

A BILL

To amend title 5, United States Code, to include service during World War II in the United States merchant marine as military service for purposes of the Civil Service Retirement System.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CREDITABILITY OF SERVICE DURING WORLD**

4 **WAR II IN THE UNITED STATES MERCHANT**

5 **MARINE.**

6 Section 8331(13) of title 5, United States Code, is

7 amended—

1 (1) by striking “or” after the semicolon at the
2 end of subparagraph (B);

3 (2) by inserting “or” after the semicolon at the
4 end of subparagraph (C); and

5 (3) by adding at the end the following:

6 “(D) in the United States merchant ma-
7 rine after May 26, 1940, and before January 1,
8 1948;”.

9 **SEC. 2. APPLICABILITY.**

10 (a) IN GENERAL.—Subject to subsection (b), the
11 amendments made by this Act shall apply with respect to
12 annuities which commence before, on, or after the date
13 of the enactment of this Act, except that no monetary ben-
14 efit by reason of such amendments shall accrue for any
15 period before such date.

16 (b) ANNUITANTS.—

17 (1) RECOMPUTATION.—An annuity or survivor
18 annuity based on the service of an employee or
19 Member who performed service described in section
20 8331(13)(D) of title 5, United States Code, as
21 added by section 1, shall, upon application to the Of-
22 fice of Personnel Management, be recomputed to
23 take such service into account.

24 (2) PROSPECTIVE EFFECT.—Any recomputation
25 of an annuity under paragraph (1) shall apply with

1 respect to amounts accruing for months beginning
2 more than 30 days after the date on which applica-
3 tion for such recomputation is received by the Office.

4 (c) DUTIES OF OPM.—

5 (1) NOTICE.—The Office of Personnel Manage-
6 ment shall take such action as may be necessary and
7 appropriate to inform individuals entitled to have
8 any service credited under section 8331(13)(D) of
9 title 5, United States Code, as added by section 1,
10 or to have any annuity recomputed under subsection
11 (b), of their entitlement to such credit or recomputa-
12 tion.

13 (2) ASSISTANCE.—The Office shall, on request,
14 assist any individual referred to in paragraph (1) in
15 obtaining from any department, agency, or other in-
16 strumentality of the United States any information
17 in the possession of such instrumentality which may
18 be necessary to verify the entitlement of such indi-
19 vidual to have any service credited under such sec-
20 tion 8331(13)(D) or to have any annuity recom-
21 puted under subsection (b).

22 (3) INFORMATION.—Any department, agency,
23 or other instrumentality of the United States which
24 possesses any information with respect to an individ-
25 ual's performance of any service described in such

1 section 8331(13)(D) shall, at the request of the
2 Office, furnish such information to the Office.
