## A BILL

To authorize appropriations for the Martin Luther King, Jr. Federal Holiday Commission, extend such Commission, establish a National Service Day to promote community service, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “King Holiday and  
3 Service Act of 1993”.

4 **SEC. 2. MARTIN LUTHER KING, JR. FEDERAL HOLIDAY**  
5 **COMMISSION.**

6 The Act entitled “An Act to establish a commission  
7 to assist in the first observance of the Federal legal holi-  
8 day honoring Martin Luther King, Jr.”, approved August  
9 27, 1984 (36 U.S.C. 169j et seq.; Public Law 98–399;  
10 98 Stat. 1473) is amended—

11 (1) in section 3(1) by inserting “including serv-  
12 ice opportunities” after “activities”;

13 (2) in section 4 by adding at the end thereof  
14 the following new subsections:

15 “(e)(1) No less than 3 of the members appointed to  
16 the Commission under the provisions of subsection (a)(6)  
17 shall be under the age of 29 years on the date of such  
18 appointment.

19 “(2) The requirement under paragraph (1) shall  
20 apply with regard to appointments made during fiscal year  
21 1994 and each fiscal year thereafter.

22 “(f) The Chairperson of the Board of the Commission  
23 on National and Community Service established under  
24 section 190 of the National and Community Service Act  
25 of 1990 (42 U.S.C. 12651) shall be an ex officio member

1 of the Martin Luther King, Jr. Federal Holiday Commis-  
2 sion. Such ex officio member shall be a voting member.”;

3 (3) in section 6(a) by striking out “grade GS-  
4 18 of the General Schedule under section 5332” and  
5 inserting in lieu thereof “a position above GS-15 of  
6 the General Schedule under section 5108”;

7 (4) in section 7 by striking out “\$300,000 for  
8 fiscal year 1989 and each of the 4 succeeding fiscal  
9 years.” and inserting in lieu thereof “\$300,000 for  
10 each of fiscal years 1994 and 1995 and such funds  
11 as may be necessary for each of fiscal years 1996  
12 and 1997.”.

13 (5) in section 8 by inserting after “under this  
14 Act” the following: “or under section 168 of the Na-  
15 tional and Community Service Act of 1990”; and

16 (6) in section 9 of striking out “April 20,  
17 1994” and inserting in lieu thereof “until termi-  
18 nated by law”

19 **SEC. 3. NATIONAL SERVICE DAY.**

20 Part IV of subtitle E of title I of the National and  
21 Community Service Act of 1990 (42 U.S.C. 12621 et seq.)  
22 is amended by adding at the end thereof the following:

23 **“SEC. 168. NATIONAL SERVICE DAY.**

24 “(a) GRANTS.—The Commission may make grants  
25 under section 102 of eligible to pay for the Federal share

1 of the cost of planning and carrying out service opportuni-  
2 ties on the Federal legal holiday honoring the birthday of  
3 Martin Luther King, Jr.

4 “(b) ELIGIBLE ENTITIES.—To be eligible to receive  
5 a grant under subsection (a), an entity shall be a State,  
6 community, institution of higher education, local edu-  
7 cational agency, State educational agency, a private indus-  
8 try council established under section 102 of the Job Train-  
9 ing Partnership Act (29 U.S.C. 1512), or a community-  
10 based agency.

11 “(c) APPLICATION.—To be eligible to receive a grant  
12 under subsection (a), an entity shall submit an application  
13 at such time, in such manner, and containing such infor-  
14 mation as the Commission may require.

15 “(d) CONSIDERATION OF APPLICATIONS.—

16 “(1) CONSULTATION.—In making grants under  
17 subsection (a), the Commission shall consult with  
18 the Martin Luther King, Jr. Federal Holiday Com-  
19 mission.

20 “(2) RECOMMENDATIONS.—The Martin Luther  
21 King, Jr. Federal Holiday Commission shall review  
22 the application submitted under subsection (c) and  
23 make recommendations with respect to the entities  
24 that shall be eligible to receive a grant under sub-  
25 section (a).

1           “(3) SELECTION.—The Commission shall not  
2           make a grant under subsection (a) to an entity un-  
3           less the Martin Luther King, Jr. Federal Holiday  
4           Commission has recommended that the entity be eli-  
5           gible to receive such a grant.

6           “(e) FEDERAL SHARE.—

7           “(1) IN GENERAL.—The Federal share of the  
8           planning and carrying out the activities described in  
9           subsection (a) shall be 30 percent.

10           “(2) CALCULATION.—The State and local share  
11           of such cost may be in cash or in kind, fairly evalu-  
12           ated, including facilities, equipment, or services.”.

13           (b) DEFINITION.—Section 101(23) of such Act (42  
14           U.S.C. 12511(23)) is amended by striking out “students  
15           or out-of-school youth” and inserting in lieu thereof “par-  
16           ticipants or volunteers in programs under this Act”.

17           (c) REPORT.—Section 172(b)(2) of such Act (42  
18           U.S.C. 12632(b)(2)) is amended by adding at the end  
19           thereof the following: “Each such report shall also contain  
20           an evaluation, conducted under section 179, of the service  
21           opportunities carried out under section 168.”.

22           (d) EX OFFICIO MEMBER.—Section 190(b)(1)(B) of  
23           such Act (42 U.S.C. 12651(b)(1)(B)) is amended by strik-  
24           ing out “and the Director of the ACTION agency” and  
25           inserting in lieu thereof “the Director of the ACTION

1 Agency, and the chairperson of the Martin Luther King  
2 Jr. Federal Holiday Commission”.

3 (e) AUTHORIZATION OF APPROPRIATIONS.—Section  
4 501(a) of such Act (42 U.S.C. 12681(a)) is amended—

5 (1) in paragraph (1)(A), by striking out the pe-  
6 riod and inserting in lieu thereof “and such sums as  
7 may be necessary for each of the fiscal years 1994  
8 through 1999.”; and

9 (2) in paragraph (2)—

10 (A) at the end of subparagraph (C), by  
11 striking out “and”;

12 (B) by redesignating subparagraph (D) as  
13 subparagraph (E); and

14 (C) by inserting after subparagraph (C)  
15 the following;

16 “(D) \$300,000 shall be available to carry  
17 out section 168; and”.

18 (f) TABLE OF CONTENTS.—Section 1(b) of such Act  
19 (42 U.S.C. 12401 note) is amended by inserting after the  
20 item relating to section 167 the following:

“Sec. 168 National service day.”.
