Mr. CRAMER introduced the following bill; which was referred to the Committee on Armed Services

A BILL

To amend chapter 153 of title 10, United States Code, to permit the Secretary of Defense to provide certain property and services of the Department of Defense to certain educational entities.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PROVISION OF CERTAIN SERVICES AND PROP-**
4 **ERTY OF THE DEPARTMENT OF DEFENSE TO**
5 **CERTAIN EDUCATIONAL ENTITIES.**

6 (a) PROVISION OF PROPERTY AND SERVICES.—
7 Chapter 153 of title 10, United States Code, is amended

1 by adding at the end of the chapter the following new sec-
2 tion:

3 **“§2579. Property and services: certain educational**
4 **entities**

5 “(a)(1) Notwithstanding any other provision of law,
6 the Secretary of Defense may sell, lease, lend, or give to
7 an entity referred to in paragraph (2) any of the property
8 referred to in paragraph (3) that the Secretary determines
9 will assist that entity in achieving its educational goals.
10 The sale or lease of any property under this subsection
11 shall be for the fair market value or fair market rental
12 value, respectively, of such property (as determined by the
13 Secretary).

14 “(2) Entities eligible to receive property under para-
15 graph (1) are any of the following:

16 “(A) The United States Space Camp.

17 “(B) The United States Space Academy.

18 “(C) The Aviation Challenge.

19 “(3) Property that may be transferred under para-
20 graph (1) includes the following:

21 “(A) Aircraft, vehicles, communications equip-
22 ment, computer equipment, training equipment, or
23 other equipment of the Department of Defense.

24 “(B) Supplies or other materials of the Depart-
25 ment of Defense that the Secretary determines will

1 assist an entity in achieving its educational goals
2 and that the Secretary determines to be excess prop-
3 erty of the department.

4 “(b)(1) The Secretary may permit the use by an en-
5 tity referred to in subsection (a)(2), on a reimbursable
6 basis, of any facilities of the Department of Defense that
7 the Secretary determines will assist that entity in achiev-
8 ing its educational goals.

9 “(2) The Secretary shall prescribe reasonable rates
10 of reimbursement for the use of facilities under paragraph
11 (1).

12 “(c) The Secretary may make available to an entity
13 referred to in subsection (a)(2), without reimbursement,
14 the services of any member of the armed forces or em-
15 ployee of the Department of Defense who the Secretary
16 determines will assist that entity in achieving its education
17 goals.”.

18 (b) CLERICAL AMENDMENT.—The table of sections
19 at the beginning of such chapter is amended by adding
20 at the end the following new item:

“2579. Property and services: certain educational entities.”.
