Mr. EWING introduced the following bill; which was referred to the Committee on Ways and Means

A BILL

To reliquidate certain entries on which excessive countervailing duties were paid, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AUTHORITY FOR RELIQUIDATION AND PAY-**

4 **MENT OF INTEREST.**

5 Notwithstanding section 514 of the Tariff Act of
6 1930 (19 U.S.C. 1514) or any other provision of law, and
7 subject to section 2, upon proper request filed with the
8 appropriate customs officer within 180 days after the date
9 of the enactment of this Act—

1 (1) any entry listed in section 3 that was not
2 reliquidated as of such date of enactment shall be
3 reliquidated so as to reduce the amount of counter-
4 vailing duty imposed on such entry to the amount
5 found by the Secretary of Commerce to be owed as
6 a result of final review under title VII of the Tariff
7 Act of 1930 and a refund of any excess countervail-
8 ing duty so found shall be made to the importer of
9 record; and

10 (2) interest on the amount of any excess coun-
11 tervailing duty found as a result of—

12 (A) any reliquidation under paragraph (1);

13 or

14 (B) a reliquidation of any entry listed
15 under section 3 that occurred before such date
16 of enactment;

17 shall be paid to the importer of record.

18 **SEC. 2. ADMINISTRATION.**

19 (a) REQUEST INFORMATION.—A request filed under
20 section 1 shall contain sufficient information to enable the
21 United States Customs Service—

22 (1) to locate the entry in question; or

23 (2) to reconstruct the entry if it cannot be
24 located.

1 (b) INTEREST.—Interest shall be paid under para-
 2 graph (2) of section 1 on the excess countervailing duty
 3 imposed on an entry form from the date of the liquidation
 4 of the entry to the date of the reliquidation.

5 (c) TIME FOR MAKING REFUNDS AND PAYMENTS.—

6 (1) The refund of excess countervailing duties,
 7 and the payment of interest thereon, resulting from
 8 a reliquidation under section 1(1) shall be made
 9 within 90 days after the date of the reliquidation.

10 (2) The payment of interest on reliquidations
 11 described in section 1(2)(B) shall be made within 90
 12 days after the date on which the request therefore
 13 is filed under section 1.
