## A BILL

To make emergency supplemental appropriations and transfers for fiscal year 1993 to provide disaster assistance for areas of Florida damaged by Hurricane Andrew.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Hurricane Andrew  
5 Supplemental Appropriations Act for Fiscal Year 1993”.

6       **SEC. 2. EMERGENCY SUPPLEMENTAL APPROPRIATIONS.**

7       The following sums are appropriated, out of any  
8 money in the Treasury not otherwise appropriated, to pro-

1 vide emergency supplemental appropriations for fiscal year  
2 1993:

3 DEPARTMENT OF AGRICULTURE

4 FARMERS HOME ADMINISTRATION

5 RURAL HOUSING FOR DOMESTIC FARM LABOR

6 For an additional amount for “Rural housing for do-  
7 mestic farm labor” for the cost of repair and replacement  
8 of uninsured losses resulting from Hurricane Andrew in  
9 the southern portion of Dade County, Florida,  
10 \$30,000,000, to remain available until expended.

11 The Congress hereby designates the entire such  
12 amount as an emergency requirement for all purposes of  
13 the Balanced Budget and Emergency Deficit Control Act  
14 of 1985.

15 Such amount shall be available only to the extent of  
16 a specific dollar amount for such purpose that is included  
17 in an official budget request submitted by the President  
18 to the Congress and that is designated as an emergency  
19 requirement for all purposes of the Balanced Budget and  
20 Emergency Deficit Control Act of 1985.

21 DEPARTMENT OF COMMERCE

22 ECONOMIC DEVELOPMENT ADMINISTRATION

23 ECONOMIC DEVELOPMENT ASSISTANCE PROGRAMS

24 For an additional amount for “Economic develop-  
25 ment assistance programs” pursuant to the Public Works

1 and Economic Development Act of 1965 (42 U.S.C. 3121  
2 et seq.), to be used for grants to the State of Florida and  
3 local communities in recovering from the consequences of  
4 Hurricane Andrew, \$20,000,000, to remain available until  
5 expended.

6 The Congress hereby designates the entire such  
7 amount as an emergency requirement for all purposes of  
8 the Balanced Budget and Emergency Deficit Control Act  
9 of 1985.

10 Such amount shall be available only to the extent of  
11 a specific dollar amount for such purpose that is included  
12 in an official budget request submitted by the President  
13 to the Congress and that is designated as an emergency  
14 requirement for all purposes of the Balanced Budget and  
15 Emergency Deficit Control Act of 1985.

18 SUBSTANCE ABUSE AND MENTAL HEALTH SERVICES  
19 ADMINISTRATION  
20 ALCOHOL, DRUG ABUSE, AND MENTAL HEALTH

21 For an additional amount for “Alcohol, drug abuse,  
22 and mental health”, \$20,300,000, to remain available  
23 until expended, of which amount \$16,200,000 shall be  
24 available for the continuation of post-Hurricane Andrew  
25 mental health and substance abuse treatment programs

1 in Dade County, Florida, \$2,500,000 shall be available for  
2 a comprehensive multidisciplinary drug research, edu-  
3 cation, and training center in the Homestead, Florida,  
4 area to carry out a combined treatment and assessment  
5 program during a 3-year period, and \$1,600,000 shall be  
6 available for residential psychiatric services for children in  
7 the Homestead, Florida, area.

8 The Congress hereby designates the entire such  
9 amount as an emergency requirement for all purposes of  
10 the Balanced Budget and Emergency Deficit Control Act  
11 of 1985.

12 Such amount shall be available only to the extent of  
13 a specific dollar amount for such purpose that is included  
14 in an official budget request submitted by the President  
15 to the Congress and that is designated as an emergency  
16 requirement for all purposes of the Balanced Budget and  
17 Emergency Deficit Control Act of 1985.

18 DEPARTMENT OF EDUCATION

19 IMPACT AID

20 For an additional amount for “Impact Aid” for car-  
21 rying out disaster assistance activities authorized by sec-  
22 tion 7 of Public Law 81–874 (20 U.S.C. 241–1) with re-  
23 spect to the Dade County, Florida, public schools,  
24 \$38,000,000, to remain available until expended.

1       The Congress hereby designates the entire such  
2 amount as an emergency requirement for all purposes of  
3 the Balanced Budget and Emergency Deficit Control Act  
4 of 1985.

5       Such amount shall be available only to the extent of  
6 a specific dollar amount for such purpose that is included  
7 in an official budget request submitted by the President  
8 to the Congress and that is designated as an emergency  
9 requirement for all purposes of the Balanced Budget and  
10 Emergency Deficit Control Act of 1985.

11       The Secretary may waive or modify any requirement  
12 of law or regulation (except requirements relating to civil  
13 rights, discrimination, or safety) that the Secretary deter-  
14 mines is necessary in order to provide such disaster assist-  
15 ance as efficiently and expeditiously as possible. Any waiv-  
16 er or modification under the preceding sentence with re-  
17 spect to the Rehabilitation Act of 1973 shall be limited  
18 to requirements for the matching of Federal funds, main-  
19 tenance of effort, and the time period for the obligation  
20 of Federal funds, and may be made only if the recipient  
21 demonstrates to the satisfaction of the Secretary in its  
22 written application that such requirements impose a de-  
23 monstrable barrier to the progress of the recipient in over-  
24 coming the effects of Hurricane Andrew.

1 DEPARTMENT OF HOUSING AND URBAN  
2 DEVELOPMENT  
3 HOUSING PROGRAMS  
4 HOME INVESTMENT PARTNERSHIPS PROGRAM  
5 (TRANSFER OF FUNDS)

6 For an additional amount for the “HOME invest-  
7 ment partnerships program” for use only in areas of Flor-  
8 ida damaged by Hurricane Andrew, \$82,200,000, to re-  
9 main available until expended, and to be derived by trans-  
10 fer of \$62,000,000 from the amount made available by  
11 the 1st paragraph under the heading “Annual contribu-  
12 tions for assisted housing” in Public Law 102–368 (106  
13 Stat. 1157) and by transfer of \$20,200,000 from the  
14 amount made available by the 2d paragraph under such  
15 heading in such Public Law.

16 In administering such funds, the Secretary of Hous-  
17 ing and Urban Development may waive any provision of  
18 any statute or regulation administered by the Secretary  
19 (except requirements relating to fair housing, non-  
20 discrimination, the environment, or labor standards) if the  
21 Secretary finds that the waiver is required to facilitate the  
22 obligation or use of the funds and is consistent with the  
23 general purposes of the HOME Investment Partnerships  
24 Act (42 U.S.C. 12721 et seq.).

1       The Secretary of Housing and Urban Development  
2 shall not, as a condition of assisting a participating juris-  
3 diction with such funds, require any contribution by or  
4 in behalf of such jurisdiction, notwithstanding section 220  
5 of the HOME Investment Partnerships Act (42 U.S.C.  
6 12750).

7           COMMUNITY PLANNING AND DEVELOPMENT

8                   COMMUNITY DEVELOPMENT GRANTS

9                           (TRANSFER OF FUNDS)

10       For an additional amount for “Community develop-  
11 ment grants” for use only in Dade County, the City of  
12 Homestead, and Florida City, Florida, \$54,800,000, to re-  
13 main available until expended, and to be derived by trans-  
14 fer from the amount made available by the 2d paragraph  
15 under the heading “Annual contributions for assisted  
16 housing” in Public Law 102–368 (106 Stat. 1157).

17       In administering such funds, the Secretary of Hous-  
18 ing and Urban Development may waive any provision of  
19 any statute or regulation administered by the Secretary  
20 (except requirements relating to fair housing, non-  
21 discrimination, the environment, or labor standards) if the  
22 Secretary finds that the waiver is required to facilitate the  
23 obligation or use of the funds and is consistent with the  
24 general purposes of title I of the Housing and Community  
25 Development Act of 1974 (42 U.S.C. 5301 et seq.).
