Mr. FAZIO, from the Committee on Appropriations, reported the following bill; which was committed to the Committee of the Whole House on the State of the Union and ordered to be printed

A BILL

Making appropriations for the Legislative Branch for the fiscal year ending September 30, 1994, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 Legislative Branch for the fiscal year ending September
6 30, 1994, and for other purposes, namely:

1 TITLE I—CONGRESSIONAL OPERATIONS
2 HOUSE OF REPRESENTATIVES
3 SALARIES AND EXPENSES (PRIOR YEAR)
4 (RESCISSION)

5 Of the funds appropriated in the Legislative Branch
6 Appropriations Act, 1993, for the House of Representa-
7 tives under the heading “SALARIES AND EXPENSES”,
8 there is rescinded a total of \$1,500,000 in the amounts
9 specified for the following heading: “STANDING COMMIT-
10 TEES, SPECIAL AND SELECT”.

11 SALARIES AND EXPENSES

12 For salaries and expenses of the House of Represent-
13 atives, \$692,118,000, as follows:

14 HOUSE LEADERSHIP OFFICES

15 For salaries and expenses, as authorized by law,
16 \$5,871,000, including: Office of the Speaker, \$1,395,000,
17 including \$25,000 for official expenses of the Speaker; Of-
18 fice of the Majority Floor Leader, \$1,003,000, including
19 \$10,000 for official expenses of the Majority Leader; Of-
20 fice of the Minority Floor Leader, \$1,383,000, including
21 \$10,000 for official expenses of the Minority Leader; Of-
22 fice of the Majority Whip, \$1,235,000, including \$5,000
23 for official expenses of the Majority Whip and not to ex-
24 ceed \$539,600, for the Chief Deputy Majority Whips; and
25 Office of the Minority Whip, \$855,000, including \$5,000

1 for official expenses of the Minority Whip and not to ex-
2 ceed \$97,980, for the Chief Deputy Minority Whip.

3 MEMBERS' CLERK HIRE

4 For staff employed by each Member in the discharge
5 of official and representative duties, \$225,004,000.

6 COMMITTEE EMPLOYEES

7 For professional and clerical employees of standing
8 committees, including the Committee on Appropriations
9 and the Committee on the Budget, \$70,445,000.

10 COMMITTEE ON THE BUDGET (STUDIES)

11 For salaries, expenses, and studies by the Committee
12 on the Budget, and temporary personal services for such
13 committee to be expended in accordance with sections
14 101(c), 606, 703, and 901(e) of the Congressional Budget
15 Act of 1974, and to be available for reimbursement to
16 agencies for services performed, \$389,000.

17 STANDING COMMITTEES, SPECIAL AND SELECT

18 For salaries and expenses of standing committees,
19 special and select, authorized by the House, \$52,662,000.

20 COMMITTEE ON HOUSE ADMINISTRATION

21 HOUSE INFORMATION SYSTEMS

22 For salaries, expenses and temporary personal serv-
23 ices of House Information Systems, under the direction
24 of the Committee on House Administration, \$22,885,000,
25 of which \$14,557,000 is provided herein: *Provided*, That
26 House Information Systems is authorized to receive reim-

1 CHILD CARE CENTER

2 For salaries and expenses of the House of Represent-
3 atives Child Care Center, such amounts as are deposited
4 in the account established by section 312(d)(1) of the Leg-
5 islative Branch Appropriations Act, 1992 (40 U.S.C.
6 184g(d)(1)), subject to the level specified in the budget
7 of the Center, as submitted to the Committee on Appro-
8 priations of the House of Representatives.

9 COMMITTEE ON APPROPRIATIONS (STUDIES AND
10 INVESTIGATIONS)

11 For salaries and expenses, studies and examinations
12 of executive agencies, by the Committee on Appropria-
13 tions, and temporary personal services for such committee,
14 to be expended in accordance with section 202(b) of the
15 Legislative Reorganization Act of 1946, and to be avail-
16 able for reimbursement to agencies for services performed,
17 \$6,431,000.

18 OFFICIAL MAIL COSTS

19 For expenses necessary for official mail costs of the
20 House of Representatives, as authorized by law,
21 \$45,800,000.

22 SALARIES, OFFICERS AND EMPLOYEES

23 For compensation and expenses of officers and em-
24 ployees, as authorized by law, \$50,147,000, including: Of-
25 fice of the Clerk, including not to exceed \$1,000 for official
26 representation and reception expenses, \$11,947,000; Of-

1 fice of the Sergeant at Arms, including not to exceed \$500
2 for official representation and reception expenses,
3 \$1,384,000; Office of the Doorkeeper, including overtime,
4 as authorized by law, \$10,101,000; Office of Director of
5 Non-legislative and Financial Services, \$14,402,000; for
6 the salaries and expenses of the Office of General Counsel,
7 \$674,000; Office of the Chaplain, \$123,000; Office of the
8 Parliamentarian, including the Parliamentarian and
9 \$2,000 for preparing the Digest of Rules, \$898,000; for
10 salaries and expenses of the Office of the Historian,
11 \$310,000; for salaries and expenses of the Office of the
12 Law Revision Counsel of the House, \$1,453,000; for sala-
13 ries and expenses of the Office of the Legislative Counsel
14 of the House, \$4,071,000; six minority employees,
15 \$738,000; the House Democratic Steering and Policy
16 Committee and the Democratic Caucus, \$1,474,000; the
17 House Republican Conference, \$1,474,000; and other au-
18 thorized employees, \$1,098,000.

19 ADMINISTRATIVE PROVISION

20 SEC. 101. (a) Upon the transfer of any function to
21 the Director of Non-legislative and Financial Services by
22 the authority of the Committee on House Administration
23 pursuant to rule X of the House of Representatives and
24 upon the commencement of operation of the Office of In-
25 spector General, the applicable amounts appropriated by

1 the Legislative Branch Appropriations Act, 1992, or by
2 this Act, for the purposes specified in subsection (b) shall
3 be available to the Director and the Office of Inspector
4 General for the carrying out of such function or operation,
5 upon the approval of the Committee on Appropriations of
6 the House of Representatives. In no case shall the transfer
7 of any function referred to in the preceding sentence in-
8 clude the transfer of any function of the Capitol Guide
9 Service.

10 (b) The purposes referred to in subsection (a) are sal-
11 aries and expenses of the House of Representatives under
12 the headings "ALLOWANCES AND EXPENSES" and "SALA-
13 RIES, OFFICERS AND EMPLOYEES".

14 JOINT ITEMS

15 For joint committees, as follows:

16 JOINT ECONOMIC COMMITTEE

17 For salaries and expenses of the Joint Economic
18 Committee, \$3,980,000, to be disbursed by the Secretary
19 of the Senate.

20 JOINT COMMITTEE ON PRINTING

21 For salaries and expenses of the Joint Committee on
22 Printing, \$1,377,000, to be disbursed by the Secretary of
23 the Senate.

1 JOINT COMMITTEE ON TAXATION

2 For salaries and expenses of the Joint Committee on
3 Taxation, \$5,701,000, to be disbursed by the Clerk of the
4 House.

5 For other joint items, as follows:

6 OFFICE OF THE ATTENDING PHYSICIAN

7 For medical supplies, equipment, and contingent ex-
8 penses of the emergency rooms, and for the Attending
9 Physician and his assistants, including (1) an allowance
10 of \$1,500 per month to the Attending Physician; (2) an
11 allowance of \$500 per month each to two medical officers
12 while on duty in the Attending Physician's office; (3) an
13 allowance of \$500 per month each to two assistants and
14 \$400 per month each to not to exceed nine assistants on
15 the basis heretofore provided for such assistance; and (4)
16 \$1,002,000 for reimbursement to the Department of the
17 Navy for expenses incurred for staff and equipment as-
18 signed to the Office of the Attending Physician, which
19 shall be advanced and credited to the applicable appropria-
20 tion or appropriations from which such salaries, allow-
21 ances, and other expenses are payable and shall be avail-
22 able for all the purposes thereof, \$1,502,000, to be dis-
23 bursed by the Clerk of the House.

1 CAPITOL POLICE BOARD

2 CAPITOL POLICE

3 SALARIES

4 For the Capitol Police Board for salaries, including
5 overtime, and Government contributions to employees'
6 benefits funds, as authorized by law, of officers, members,
7 and employees of the Capitol Police, \$62,255,000, of
8 which \$29,453,000 is provided to the Sergeant at Arms
9 of the House of Representatives, to be disbursed by the
10 Clerk of the House, and \$32,802,000 is provided to the
11 Sergeant at Arms and Doorkeeper of the Senate, to be
12 disbursed by the Secretary of the Senate: *Provided*, That
13 of the amounts appropriated for fiscal year 1994 for sala-
14 ries, including overtime, and Government contributions to
15 employees' benefits funds under this heading, such
16 amounts as may be necessary may be transferred between
17 the Sergeant at Arms of the House of Representatives and
18 the Sergeant at Arms and Doorkeeper of the Senate, upon
19 approval of the Committee on Appropriations of the House
20 of Representatives and the Committee on Appropriations
21 of the Senate.

22 GENERAL EXPENSES

23 For the Capitol Police Board for necessary expenses
24 of the Capitol Police, including motor vehicles, commu-
25 nications and other equipment, uniforms, weapons, sup-

1 plies, materials, training, medical services, the employee
2 assistance program, not more than \$2,000 for the awards
3 program, postage, telephone service, travel advances, relo-
4 cation of instructor and liaison personnel for the Federal
5 Law Enforcement Training Center, and \$85 per month
6 for extra services performed for the Capitol Police Board
7 by an employee of the Sergeant at Arms of the Senate
8 or the House of Representatives designated by the Chair-
9 man of the Board, \$1,977,000, to be disbursed by the
10 Clerk of the House of Representatives: *Provided*, That,
11 notwithstanding any other provision of law, the cost of
12 basic training for the Capitol Police at the Federal Law
13 Enforcement Training Center for fiscal year 1994 shall
14 be paid by the Secretary of the Treasury from funds avail-
15 able to the Department of the Treasury.

16 ADMINISTRATIVE PROVISION

17 SEC. 102. Amounts appropriated for fiscal year 1994
18 for the Capitol Police Board under the heading "CAPITOL
19 POLICE" may be transferred between the headings "SALA-
20 RIES" and "GENERAL EXPENSES", upon approval of the
21 Committees on Appropriations of the Senate and the
22 House of Representatives.

23 CAPITOL GUIDE SERVICE

24 For salaries and expenses of the Capitol Guide Serv-
25 ice, \$1,628,000, to be disbursed by the Secretary of the

1 Senate: *Provided*, That none of these funds shall be used
2 to employ more than thirty-three individuals: *Provided fur-*
3 *ther*, That the Capitol Guide Board is authorized, during
4 emergencies, to employ not more than two additional indi-
5 viduals for not more than one hundred twenty days each,
6 and not more than ten additional individuals for not more
7 than six months each, for the Capitol Guide Service.

8 SPECIAL SERVICES OFFICE

9 For salaries and expenses of the Special Services Of-
10 fice, \$363,000, to be disbursed by the Secretary of the
11 Senate.

12 OFFICE OF TECHNOLOGY ASSESSMENT

13 SALARIES AND EXPENSES

14 For salaries and expenses necessary to carry out the
15 provisions of the Technology Assessment Act of 1972
16 (Public Law 92-484), including official reception and rep-
17 resentation expenses (not to exceed \$5,500 from the Trust
18 Fund), and expenses incurred in administering an em-
19 ployee incentive awards program (not to exceed \$2,500),
20 rental of space in the District of Columbia, \$20,815,000:
21 *Provided*, That none of the funds in this Act shall be avail-
22 able for salaries or expenses of any employee of the Office
23 of Technology Assessment in excess of 143 staff employ-
24 ees: *Provided further*, That no part of this appropriation
25 shall be available for assessments or activities not initiated

1 and approved in accordance with section 3(d) of Public
2 Law 92-484: *Provided further*, That none of the funds in
3 this Act shall be available for salaries or expenses of em-
4 ployees of the Office of Technology Assessment in connec-
5 tion with any reimbursable study for which funds are pro-
6 vided from sources other than appropriations made under
7 this Act, or shall be available for any other administrative
8 expenses incurred by the Office of Technology Assessment
9 in carrying out such a study.

10 CONGRESSIONAL BUDGET OFFICE

11 SALARIES AND EXPENSES

12 For salaries and expenses necessary to carry out the
13 provisions of the Congressional Budget Act of 1974 (Pub-
14 lic Law 93-344), including not to exceed \$2,500 to be ex-
15 pended on the certification of the Director of the Congres-
16 sional Budget Office in connection with official representa-
17 tion and reception expenses, \$22,317,000: *Provided*, That
18 none of these funds shall be available for the purchase or
19 hire of a passenger motor vehicle: *Provided further*, That
20 none of the funds in this Act shall be available for salaries
21 or expenses of any employee of the Congressional Budget
22 Office in excess of 226 staff employees: *Provided further*,
23 That any sale or lease of property, supplies, or services
24 to the Congressional Budget Office shall be deemed to be
25 a sale or lease of such property, supplies, or services to

1 the Congress subject to section 903 of Public Law
2 98-63.

3 ARCHITECT OF THE CAPITOL

4 OFFICE OF THE ARCHITECT OF THE CAPITOL

5 SALARIES

6 For the Architect of the Capitol; the Assistant Archi-
7 tect of the Capitol; and other personal services; at rates
8 of pay provided by law, \$8,762,000.

9 TRAVEL

10 Appropriations under the control of the Architect of
11 the Capitol shall be available for expenses of travel on offi-
12 cial business not to exceed in the aggregate under all
13 funds the sum of \$20,000.

14 CONTINGENT EXPENSES

15 To enable the Architect of the Capitol to make sur-
16 veys and studies, and to meet unforeseen expenses in con-
17 nection with activities under his care, \$100,000, to remain
18 available until expended.

19 CAPITOL BUILDINGS AND GROUNDS

20 CAPITOL BUILDINGS

21 For all necessary expenses for the maintenance, care
22 and operation of the Capitol and electrical substations of
23 the Senate and House office buildings, under the jurisdic-
24 tion of the Architect of the Capitol, including furnishings
25 and office equipment; including not to exceed \$1,000 for
26 official reception and representation expenses, to be ex-

1 plants in any of such buildings; heating the Government
2 Printing Office and Washington City Post Office; and
3 heating and chilled water for air conditioning for the Su-
4 preme Court Building, Union Station complex, Thurgood
5 Marshall Federal Judiciary Building and the Folger
6 Shakespeare Library, expenses for which shall be ad-
7 vanced or reimbursed upon request of the Architect of the
8 Capitol and amounts so received shall be deposited into
9 the Treasury to the credit of this appropriation,
10 \$32,777,000, of which \$665,000 shall remain available
11 until expended: *Provided*, That not to exceed \$3,200,000
12 of the funds credited or to be reimbursed to this appro-
13 priation as herein provided shall be available for obligation
14 during fiscal year 1994.

15 LIBRARY OF CONGRESS

16 CONGRESSIONAL RESEARCH SERVICE

17 SALARIES AND EXPENSES

18 For necessary expenses to carry out the provisions
19 of section 203 of the Legislative Reorganization Act of
20 1946, (2 U.S.C. 166) and to revise and extend the Anno-
21 tated Constitution of the United States of America,
22 \$56,718,000: *Provided*, That no part of this appropriation
23 may be used to pay any salary or expense in connection
24 with any publication, or preparation of material therefor
25 (except the Digest of Public General Bills), to be issued

1 by the Library of Congress unless such publication has
2 obtained prior approval of either the Committee on House
3 Administration of the House of Representatives or the
4 Committee on Rules and Administration of the Senate:
5 *Provided further*, That, notwithstanding any other provi-
6 sion of law, the compensation of the Director of the Con-
7 gressional Research Service, Library of Congress, shall be
8 at an annual rate which is equal to the annual rate of
9 basic pay for positions at level IV of the Executive Sched-
10 ule under section 5315 of title 5, United States Code.

11 GOVERNMENT PRINTING OFFICE

12 CONGRESSIONAL PRINTING AND BINDING

13 For authorized printing and binding for the Congress
14 and the distribution of Congressional information in any
15 format; printing and binding for the Architect of the Cap-
16 itol; expenses necessary for preparing the semimonthly
17 and session index to the Congressional Record, as author-
18 ized by law (44 U.S.C. 902); printing and binding of Gov-
19 ernment publications authorized by law to be distributed
20 to Members of Congress; and printing, binding, and dis-
21 tribution of Government publications authorized by law to
22 be distributed without charge to the recipient,
23 \$88,404,000: *Provided*, That this appropriation shall not
24 be available for printing and binding part 2 of the annual
25 report of the Secretary of Agriculture (known as the Year-

1 book of Agriculture) nor for copies of the permanent edi-
2 tion of the Congressional Record for individual Represent-
3 atives, Resident Commissioners or Delegates authorized
4 under 44 U.S.C. 906: *Provided further*, That this appro-
5 priation shall be available for the payment of obligations
6 incurred under the appropriations for similar purposes for
7 preceding fiscal years.

8 This title may be cited as the “Congressional Oper-
9 ations Appropriations Act, 1994”.

10 TITLE II—OTHER AGENCIES

11 BOTANIC GARDEN

12 SALARIES AND EXPENSES

13 For all necessary expenses for the maintenance, care
14 and operation of the Botanic Garden and the nurseries,
15 buildings, grounds, and collections; and purchase and ex-
16 change, maintenance, repair, and operation of a passenger
17 motor vehicle; all under the direction of the Joint Commit-
18 tee on the Library, \$3,008,000.

19 LIBRARY OF CONGRESS

20 SALARIES AND EXPENSES

21 For necessary expenses of the Library of Congress,
22 not otherwise provided for, including development and
23 maintenance of the Union Catalogs; custody and custodial
24 care of the Library Buildings; special clothing; cleaning,
25 laundering and repair of uniforms; preservation of motion

1 pictures in the custody of the Library; operation and
2 maintenance of the American Folklife Center in the Li-
3 brary; preparation and distribution of catalog cards and
4 other publications of the Library; hire or purchase of one
5 passenger motor vehicle; and expenses of the Library of
6 Congress Trust Fund Board not properly chargeable to
7 the income of any trust fund held by the Board,
8 \$201,231,000, of which not more than \$7,500,000 shall
9 be derived from collections credited to this appropriation
10 during fiscal year 1994 under the Act of June 28, 1902
11 (chapter 1301; 32 Stat. 480; 2 U.S.C. 150): *Provided*,
12 That the total amount available for obligation shall be re-
13 duced by the amount by which collections are less than
14 the \$7,500,000: *Provided further*, That of the total
15 amount appropriated, \$8,127,000 is to remain available
16 until expended for acquisition of books, periodicals, and
17 newspapers, and all other materials including subscrip-
18 tions for bibliographic services for the Library, including
19 \$40,000 to be available solely for the purchase, when spe-
20 cifically approved by the Librarian, of special and unique
21 materials for additions to the collections.

22 COPYRIGTH OFFICE

23 SALARIES AND EXPENSES

24 For necessary expenses of the Copyright Office, in-
25 cluding publication of the decisions of the United States

1 courts involving copyrights, \$26,244,000, of which not
2 more than \$14,500,000 shall be derived from collections
3 credited to this appropriation during fiscal year 1994
4 under 17 U.S.C. 708(c), and not more than \$2,333,000
5 shall be derived from collections during fiscal year 1994
6 under 17 U.S.C. 111(d)(2), 119(b)(2), and 1005: *Pro-*
7 *vided*, That the total amount available for obligation shall
8 be reduced by the amount by which collections are less
9 than \$16,833,000: *Provided further*, That \$100,000 of the
10 amount appropriated is available for the maintenance of
11 an “International Copyright Institute” in the Copyright
12 Office of the Library of Congress for the purpose of train-
13 ing nationals of developing countries in intellectual prop-
14 erty laws and policies: *Provided further*, That not to exceed
15 \$2,250 may be expended on the certification of the Librar-
16 ian of Congress or his designee, in connection with official
17 representation and reception expenses for activities of the
18 International Copyright Institute.

19 BOOKS FOR THE BLIND AND PHYSICALLY HANDICAPPED
20 SALARIES AND EXPENSES

21 For salaries and expenses to carry out the provisions
22 of the Act of March 3, 1931 (chapter 400; 406 Stat. 1487;
23 2 U.S.C. 135a), \$43,144,000, of which \$10,377,000 shall
24 remain available until expended.

1 FURNITURE AND FURNISHINGS

2 For necessary expenses for the purchase and repair
3 of furniture, furnishings, office and library equipment,
4 \$3,939,000: *Provided*, That of those funds that remain
5 available until expended, up to \$593,000 may be trans-
6 ferred to the Architect of the Capitol appropriation “Li-
7 brary Buildings and Grounds, Structural and Mechanical
8 Care” to complete renovation and restoration work on the
9 Thomas Jefferson and John Adams Buildings.

10 ADMINISTRATIVE PROVISIONS

11 SEC. 201. Appropriations in this Act available to the
12 Library of Congress shall be available, in an amount not
13 to exceed \$175,690, of which \$54,800 is for the Congres-
14 sional Research Service, when specifically authorized by
15 the Librarian, for attendance at meetings concerned with
16 the function or activity for which the appropriation is
17 made.

18 SEC. 202. (a) No part of the funds appropriated in
19 this Act shall be used by the Library of Congress to ad-
20 minister any flexible or compressed work schedule which—

21 (1) applies to any manager or supervisor in a
22 position the grade or level of which is equal to or
23 higher than GS-15; and

24 (2) grants such manager or supervisor the right
25 to not be at work for all or a portion of a workday

1 because of time worked by the manager or super-
2 visor on another workday.

3 (b) For purposes of this section, the term “manager
4 or supervisor” means any management official or super-
5 visor, as such terms are defined in section 7103(a) (10)
6 and (11) of title 5, United States Code.

7 SEC. 203. Appropriated funds received by the Library
8 of Congress from other Federal agencies to cover general
9 and administrative overhead costs generated by perform-
10 ing reimbursable work for other agencies under the au-
11 thority of 31 U.S.C. 1535 and 1536 shall not be used to
12 employ more than 65 employees and may be expended or
13 obligated—

14 (1) in the case of a reimbursement, only to such
15 extent or in such amounts as are provided in appro-
16 priations Acts; or

17 (2) in the case of an advance payment, only—

18 (A) to pay for such general or administra-
19 tive overhead costs as are attributable to the
20 work performed for such agency; or

21 (B) to such extent or in such amounts as
22 are provided in appropriations Acts, with re-
23 spect to any purpose not allowable under sub-
24 paragraph (A).

1 SEC. 204. Not to exceed \$5,000 of any funds appro-
2 priated to the Library of Congress may be expended, on
3 the certification of the Librarian of Congress, in connec-
4 tion with official representation and reception expenses for
5 the Library of Congress incentive awards program.

6 Sec. 205. Not to exceed \$12,000 of funds appro-
7 priated to the Library of Congress may be expended, on
8 the certification of the Librarian of Congress or his des-
9 ignee, in connection with official representation and recep-
10 tion expenses for the Overseas Field Offices.

11 SEC. 206. (a) Effective for fiscal years beginning with
12 fiscal year 1995, no amount may be disbursed for any ac-
13 tivity of the Library of Congress, except to the extent and
14 in the amount provided (1) in the annual regular appro-
15 priations Act making appropriations for the legislative
16 branch, or (2) in a supplemental appropriations Act that
17 makes appropriations for the legislative branch.

18 (b) Subsection (a) applies to disbursement of
19 amounts derived from any source, including (1) amounts
20 from library and bibliographical services performed on a
21 reimbursable basis, under agency agreement or otherwise,
22 for any public or private entity, (2) amounts from grants
23 or similar payments for any purpose, and (3) amounts
24 from gifts, whether such amounts are in the form of trust

1 funds administered by the Library of Congress Trust
2 Fund Board or otherwise.

3 ARCHITECT OF THE CAPITOL

4 LIBRARY BUILDINGS AND GROUNDS

5 STRUCTURAL AND MECHANICAL CARE

6 For all necessary expenses for the mechanical and
7 structural maintenance, care and operation of the Library
8 buildings and grounds, \$9,543,000, of which \$1,060,000
9 shall remain available until expended: *Provided*, That, sub-
10 ject to approval by the Committee on Appropriations of
11 the House of Representatives and the Committee on Ap-
12 propriations of the Senate, the Librarian of Congress may
13 transfer from any appropriation under the heading “Li-
14 brary of Congress” amounts not to exceed in the aggre-
15 gate \$3,200,000 to the appropriation “Architect of the
16 Capitol, Library buildings and grounds, Structural and
17 mechanical care, No Year” to complete the renovation and
18 restoration of the Thomas Jefferson and John Adams
19 buildings.

20 COPYRIGHT ROYALTY TRIBUNAL

21 SALARIES AND EXPENSES

22 For necessary expenses of the Copyright Royalty Tri-
23 bunal, \$1,028,000, of which \$900,000 shall be derived by
24 collections from the appropriation “Payments to Copy-
25 right Owners” for the reasonable costs incurred in pro-

1 ceedings involving distribution of royalty fees as provided
2 by 17 U.S.C. 807.

3 GOVERNMENT PRINTING OFFICE
4 OFFICE OF SUPERINTENDENT OF DOCUMENTS
5 SALARIES AND EXPENSES

6 For expenses of the Office of Superintendent of Doc-
7 uments necessary to provide for the cataloging and index-
8 ing of Government publications and their distribution to
9 the public, Members of Congress, other Government agen-
10 cies, and designated depository and international exchange
11 libraries as authorized by law, \$29,082,000: *Provided,*
12 That travel expenses, including travel expenses of the De-
13 pository Library Council to the Public Printer, shall not
14 exceed \$130,000: *Provided further,* That funds, not to ex-
15 ceed \$2,000,000, from current year appropriations are au-
16 thorized for producing and disseminating Congressional
17 Serial Sets and other related Congressional/non-Congres-
18 sional publications for 1991 and 1992 to depository and
19 other designated libraries.

20 GOVERNMENT PRINTING OFFICE REVOLVING FUND

21 The Government Printing Office is hereby authorized
22 to make such expenditures, within the limits of funds
23 available and in accord with the law, and to make such
24 contracts and commitments without regard to fiscal year
25 limitations as provided by section 104 of the Government

1 Corporation Control Act as may be necessary in carrying
2 out the programs and purposes set forth in the budget
3 for the current fiscal year for the “Government Printing
4 Office revolving fund”: *Provided*, That not to exceed
5 \$2,500 may be expended on the certification of the Public
6 Printer in connection with official representation and re-
7 ception expenses: *Provided further*, That the revolving
8 fund shall be available for the hire or purchase of pas-
9 senger motor vehicles, not to exceed a fleet of twelve: *Pro-*
10 *vided further*, That expenditures in connection with travel
11 expenses of the advisory councils to the Public Printer
12 shall be deemed necessary to carry out the provisions of
13 title 44, United States Code: *Provided further*, That the
14 revolving fund shall be available for services as authorized
15 by 5 U.S.C. 3109 but at rates for individuals not to exceed
16 the per diem rate equivalent to the rate for level V of the
17 Executive Schedule (5 U.S.C. 5316): *Provided further*,
18 That the revolving fund and the funds provided under the
19 paragraph entitled “OFFICE OF SUPERINTENDENT OF
20 DOCUMENTS, SALARIES AND EXPENSES” together may not
21 be available for the full-time equivalent employment of
22 more than 4,850 workyears: *Provided further*, That the re-
23 volving fund shall be available for expenses not to exceed
24 \$500,000 for the development of plans and design of a
25 multi-purpose facility: *Provided further*, That activities fi-

1 nanced through the revolving fund may provide informa-
2 tion in any format: *Provided further*, That the revolving
3 fund shall not be used to administer any flexible or com-
4 pressed work schedule which applies to any manager or
5 supervisor in a position the grade or level of which is equal
6 to or higher than GS-15: *Provided further*, That expenses
7 for attendance at meetings shall not exceed \$75,000.

2 SALARIES AND EXPENSES

3 For necessary expenses of the General Accounting
4 Office, including not to exceed \$7,000 to be expended on
5 the certification of the Comptroller General of the United
6 States in connection with official representation and recep-
7 tion expenses; services as authorized by 5 U.S.C. 3109 but
8 at rates for individuals not to exceed the per diem rate
9 equivalent to the rate for level IV of the Executive Sched-
10 ule (5 U.S.C. 5315); hire of one passenger motor vehicle;
11 advance payments in foreign countries in accordance with
12 31 U.S.C. 3324; benefits comparable to those payable
13 under sections 901(5), 901(6) and 901(8) of the Foreign
14 Service Act of 1980 (22 U.S.C. 4081(5), 4081(6) and
15 4081(8)); and under regulations prescribed by the Comp-
16 troller General of the United States, rental of living quar-
17 ters in foreign countries and travel benefits comparable
18 with those which are now or hereafter may be granted sin-
19 gle employees of the Agency for International Develop-
20 ment, including single Foreign Service personnel assigned
21 to AID projects, by the Administrator of the Agency for
22 International Development—or his designee—under the
23 authority of section 636(b) of the Foreign Assistance Act
24 of 1961 (22 U.S.C. 2396(b)); \$430,815,000: *Provided*,
25 That not more than \$1,600,000 of reimbursements re-

1 ceived incident to the operation of the General Accounting
2 Office Building shall be available for use in fiscal year
3 1994: *Provided further*, That this appropriation and ap-
4 propriations for administrative expenses of any other de-
5 partment or agency which is a member of the Joint Finan-
6 cial Management Improvement Program (JFMIP) shall be
7 available to finance an appropriate share of JFMIP costs
8 as determined by the JFMIP, including the salary of the
9 Executive Director and secretarial support: *Provided fur-*
10 *ther*, That this appropriation and appropriations for ad-
11 ministrative expenses of any other department or agency
12 which is a member of the National Intergovernmental
13 Audit Forum or a Regional Intergovernmental Audit
14 Forum shall be available to finance an appropriate share
15 of Forum costs as determined by the Forum, including
16 necessary travel expenses of non-Federal participants.
17 Payments hereunder to either the Forum or the JFMIP
18 may be credited as reimbursements to any appropriation
19 from which costs involved are initially financed: *Provided*
20 *further*, That to the extent that funds are otherwise avail-
21 able for obligation, agreements or contracts for the re-
22 moval of asbestos, and renovation of the building and
23 building systems (including the heating, ventilation and
24 air conditioning system, electrical system and other major
25 building systems) of the General Accounting Office Build-

1 ing may be made for periods not exceeding five years: *Pro-*
2 *vided further*, That this appropriation and appropriations
3 for administrative expenses of any other department or
4 agency which is a member of the American Consortium
5 on International Public Administration (ACIPA) shall be
6 available to finance an appropriate share of ACIPA costs
7 as determined by the ACIPA, including any expenses at-
8 tributable to membership of ACIPA in the International
9 Institute of Administrative Sciences: *Provided further*,
10 That of the amount provided under this heading, not to
11 exceed \$500,000 shall be available for a broadbased orga-
12 nizational performance review of the General Accounting
13 Office, focused on agency structure, skills, staffing, sys-
14 tems, and its execution of its statutory and assigned re-
15 sponsibilities.

16 TITLE III—GENERAL PROVISIONS

17 SEC. 301. No part of the funds appropriated in this
18 Act shall be used for the maintenance or care of private
19 vehicles, except for emergency assistance and cleaning as
20 may be provided under regulations relating to parking fa-
21 cilities for the House of Representatives issued by the
22 Committee on House Administration and for the Senate
23 issued by the Committee on Rules and Administration.

1 SEC. 302. No part of any appropriation contained in
2 this Act shall remain available for obligation beyond the
3 current fiscal year unless expressly so provided herein.

4 SEC. 303. Whenever any office or position not specifi-
5 cally established by the Legislative Pay Act of 1929 is ap-
6 propriated for herein or whenever the rate of compensa-
7 tion or designation of any position appropriated for herein
8 is different from that specifically established for such posi-
9 tion by such Act, the rate of compensation and the des-
10 ignation of the position, or either, appropriated for or pro-
11 vided herein, shall be the permanent law with respect
12 thereto: *Provided*, That the provisions herein for the var-
13 ious items of official expenses of Members, officers, and
14 committees of the Senate and House of Representatives,
15 and clerk hire for Senators and Members of the House
16 of Representatives shall be the permanent law with respect
17 thereto.

18 SEC. 304. The expenditure of any appropriation
19 under this Act for any consulting service through procure-
20 ment contract, pursuant to 5 U.S.C. 3109, shall be limited
21 to those contracts where such expenditures are a matter
22 of public record and available for public inspection, except
23 where otherwise provided under existing law, or under ex-
24 isting Executive order issued pursuant to existing law.

1 SEC. 305. Notwithstanding any other provision of
2 law, and subject to approval by the Committee on Appro-
3 priations of the House of Representatives and the Com-
4 mittee on Appropriations of the Senate, amounts may be
5 transferred from the appropriation “Library of Congress,
6 Salaries and expenses” to the appropriation “Architect of
7 the Capitol, Library buildings and grounds, Structural
8 and mechanical care” for the purpose of purchase, rental,
9 lease, or other agreement, of storage and warehouse space
10 for use by the Library of Congress during fiscal year
11 1994, and to incur incidental expenses in connection with
12 such use.

13 SEC. 306. (a) The General Accounting Office, the
14 Government Printing Office, or the Library of Congress
15 may for such employees as it deems appropriate authorize
16 a payment to employees who voluntarily separate before
17 January 1, 1994, whether by retirement or resignation,
18 which payment shall be paid in accordance with the provi-
19 sions of section 5597(d) of title 5, United States Code.

20 (b) The number of employee positions authorized for
21 the General Accounting Office, the Government Printing
22 Office, or the Library of Congress, as the case may be,
23 shall be reduced by one position for each vacancy created
24 by reason of a separation under subsection (a). No funds
25 appropriated by this Act for salaries or expenses of any

1 position that is eliminated under the preceding sentence
2 may be used for any other purpose.

3 SEC. 307. (a) The number of employee positions, on
4 a full-time equivalent basis, for each covered entity shall
5 be reduced by at least 4 percent from the level as of Sep-
6 tember 30, 1992, or, with the approval of the Committee
7 on Appropriations of the House of Representatives and the
8 Committee on Appropriations of the Senate, as of a later
9 date, but not later than September 30, 1993. At least 10
10 percent of the positions eliminated shall be positions the
11 pay for which is equal to or greater than the annual rate
12 of basic pay payable for grade GS-14 of the General
13 Schedule.

14 (b) The reduction required by subsection (a) shall be
15 completed not later than September 30, 1995, with at
16 least 62.5 percent of the reduction for each covered entity
17 to be achieved by September 30, 1994.

18 (c) The Comptroller General shall carry out compli-
19 ance reporting under this section.

20 (d) As used in this section—

21 (1) the term “covered entity” means an entity
22 of the legislative branch with more than 100 em-
23 ployee positions, on a full-time equivalent basis, as
24 of September 30, 1992; and

1 (2) the term “entity of the legislative branch”
2 means the House of Representatives, the Senate, the
3 Office of the Architect of the Capitol (including the
4 Botanic Garden), the Capitol Police, the Congres-
5 sional Budget Office, the Copyright Royalty Tribu-
6 nal, the General Accounting Office, the Government
7 Printing Office, the Library of Congress, and the
8 Office of Technology Assessment.

9 SEC. 308. (a) For fiscal years 1995, 1996, and 1997,
10 the submissions in support of the amounts included in the
11 Budget for each entity of the legislative branch shall set
12 forth a separate category for administrative expenses. For
13 fiscal years 1993 and 1994, the administrative expenses
14 for each entity of the legislative branch shall be calculated
15 and submitted in a separate category in the same format
16 as if submitted in support of amounts included in the
17 Budget.

18 (b) For fiscal years 1994, 1995, 1996, and 1997, the
19 submissions under subsection (a) in the separate category
20 for administrative expenses for each entity of the legisla-
21 tive branch shall include reductions from the amount cal-
22 culated for administrative expenses for fiscal year 1993,
23 adjusted for inflation, as follows:

24 (1) Fiscal year 1994, reduction of not less than
25 3 percent.

1 (2) Fiscal year 1995, reduction of not less than
2 6 percent.

3 (3) Fiscal year 1996, reduction of not less than
4 9 percent.

5 (4) Fiscal year 1997, reduction of not less than
6 14 percent.

7 (c) The Comptroller General shall carry out compli-
8 ance reporting under this section.

9 (d) As used in this section—

10 (1) the term “administrative expenses” means
11 expenses of contractual services and supplies, other
12 than rental payments, programmatic mission-essen-
13 tial expenses, reimbursable expenses, and expenses
14 required by law;

15 (2) the term “Budget” means the budget of the
16 United States Government, submitted under section
17 1105 of title 31, United States Code; and

18 (3) the term “entity of the legislative branch”
19 means the House of Representatives, the Senate, the
20 Office of the Architect of the Capitol (including the
21 Botanic Garden), the Capitol Police, the Congres-
22 sional Budget Office, the Copyright Royalty Tribu-
23 nal, the General Accounting Office, the Government
24 Printing Office, the Library of Congress, and the
25 Office of Technology Assessment.

1 RETIREMENT CREDIT FOR CERTAIN PRIOR SERVICE WITH
2 THE HOUSE CHILD CARE CENTER

3 SEC. 309. (a) DEFINITIONS.—For the purpose of this
4 section—

5 (1) the term “House Child Care Center” means
6 the House of Representatives Child Care Center;
7 and

8 (2) the term “Congressional employee” has the
9 meaning given such term—

10 (A) in subchapter III of chapter 83 of title
11 5, United States Code, to the extent that this
12 section relates to the Civil Service Retirement
13 System; or

14 (B) in chapter 84 of title 5, United States
15 Code, to the extent that this section relates to
16 the Federal Employees’ Retirement System.

17 (b) CSRS.—(1) Subject to paragraph (2), any indi-
18 vidual who is an employee of the House Child Care Center
19 on the date of enactment of this Act shall be allowed credit
20 under subchapter III of chapter 83 of title 5, United
21 States Code, as a Congressional employee, for any service
22 if—

23 (A) such service was performed before October
24 1, 1991, as an employee of the House Child Care
25 Center (as constituted before that date); and

1 (B) the employee is subject to subchapter III of
2 chapter 83 of such title as of the date of enactment
3 of this Act.

4 (2) Credit for service described in paragraph (1)(A)
5 shall not be allowed under this section unless there is paid
6 into the Civil Service Retirement and Disability Fund, by
7 or on behalf of the employee involved, an amount equal
8 to the deductions from pay which would have been applica-
9 ble under section 8334(c) of title 5, United States Code,
10 for the period of service involved, if such employee were
11 then a Congressional employee, including interest. Retire-
12 ment credit may not be allowed under this section for any
13 such service unless the full amount of the deposit required
14 under the preceding sentence has been paid.

15 (c) FERS.—(1) Subject to paragraph (2), any indi-
16 vidual who is an employee of the House Child Care Center
17 on the date of enactment of this Act shall be allowed credit
18 under chapter 84 of title 5, United States Code, as a Con-
19 gressional employee, for any service if—

20 (A) such service was performed before October
21 1, 1991, as an employee of the House Child Care
22 Center (as constituted before that date); and

23 (B) the employee is subject to chapter 84 of
24 such title as of the date of enactment of this Act.

1 (2) Credit for service described in paragraph (1)(A)
2 shall not be allowed under this section unless there is paid
3 into the Civil Service Retirement and Disability Fund, by
4 or on behalf of the employee involved, an amount equal
5 to the deductions from pay which would have been payable
6 under applicable provisions of law, for the period of service
7 involved, if such employee were then a Congressional em-
8 ployee, including interest (computed in the same way as
9 interest under subsection (b)(2)). Retirement credit may
10 not be allowed under this section for any such service un-
11 less the full amount of the deposit required under the pre-
12 ceding sentence has been paid.

13 (d) CLARIFICATION.—Nothing in this section shall be
14 considered to relate to the Thrift Savings Plan.

15 (e) OPM FUNCTIONS.—The Office of Personnel
16 Management shall—

17 (1) prescribe any regulations which may be nec-
18 essary to carry out this section; and

19 (2) with respect to any service for which credit
20 is sought under this section, accept the certification
21 of the Clerk of the House of Representatives con-
22 cerning the period of such service and the amount
23 of pay which was paid for such service.

24 SEC. 310. (a) Section 17 of the Act entitled “An Act
25 making Appropriations for sundry Civil Expenses of the

1 Government for the Year ending June thirtieth, eighteen
2 hundred and sixty-seven, and for other purposes”, ap-
3 proved July 28, 1866 (2 U.S.C. 43), is amended by insert-
4 ing after “mileage” the first place it appears the following:
5 “for each Senator”.

6 (b) The amendment made by subsection (a) shall take
7 effect on October 1, 1993.

8 This Act may be cited as the “Legislative Branch Ap-
9 propriations Act, 1994”.
