in Government.

Mr. MCCANDLESS introduced the following bill; which was referred to the  
Committee on Government Operations

---

## A BILL

To establish a Second National Blue Ribbon Commission  
to Eliminate Waste in Government.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Second National Blue  
5 Ribbon Commission to Eliminate Waste in Government  
6 Act”.

7 **SEC. 2. ESTABLISHMENT.**

8 There is established a commission known as the Sec-  
9 ond National Blue Ribbon Commission to Eliminate

1 Waste in Government (in this Act referred to as the  
2 “Commission”).

3 **SEC. 3. DUTIES.**

4 (a) IN GENERAL.—It shall be the duty of the Com-  
5 mission—

6 (1) to conduct a private sector survey on man-  
7 agement and cost control in the Federal Govern-  
8 ment;

9 (2) to conduct in-depth reviews of the oper-  
10 ations of the executive agencies;

11 (3) to review existing Government Accounting  
12 Office (GAO), Congressional Budget Office (CBO),  
13 Inspector General Reports, and other existing gov-  
14 ernmental and nongovernmental recommendations  
15 for reducing waste including recommendations from  
16 the President’s Private Sector Survey on Cost Con-  
17 trol, and, based on this review, to periodically submit  
18 a report to the President and Congress a list of such  
19 recommendations with estimated savings the Com-  
20 mission determines are most significant and to in-  
21 clude in the report a determination of whether the  
22 recommendation can be implemented by Executive  
23 Order or whether it requires legislative action; and

24 (4) to submit to the President and the Congress  
25 recommendations for improving the budget process

1 and management and for reducing waste and costs  
2 in the Federal Government.

3 (b) PARTICULAR AREAS TO BE EXAMINED.—In ful-  
4 filling the duties described in subsection (a), the Commis-  
5 sion shall identify and address—

6 (1) opportunities for increased efficiency and  
7 reduced costs in the Federal Government that can  
8 be realized by executive action or legislation;

9 (2) areas in the Federal Government where  
10 managerial accountability can be enhanced and ad-  
11 ministrative control can be improved;

12 (3) specific Federal programs that have accom-  
13 plished their objectives and ought to be terminated;

14 (4) specific Federal program services that could  
15 be provided at a lower cost by the private sector;

16 (5) specific reforms of the budget process that  
17 would yield savings, increase accountability and effi-  
18 ciency, and enhance public confidence in the budget  
19 process; and

20 (6) specific areas in the Federal Government  
21 where further study can be justified by potential sav-  
22 ings.

23 **SEC. 4. MEMBERSHIP.**

24 (a) NUMBER AND APPOINTMENT.—The Commission  
25 shall be composed of 12 members appointed by the Presi-

1 dent from among individuals who are not officers or em-  
2 ployees of any government and who are especially qualified  
3 to serve on the Commission by virtue of their education,  
4 training or experience. The majority leader and minority  
5 leader of the Senate and the Speaker and minority leader  
6 of the House of Representatives may submit recommenda-  
7 tions to the President concerning appointments to the  
8 Commission. Not more than 6 members of the Commis-  
9 sion shall be of the same political party.

10 (b) CONTINUATION OF MEMBERSHIP.—If an individ-  
11 ual is appointed to the Commission, and later becomes an  
12 officer or employee of a government, such individual may  
13 continue as a member of the Commission for not longer  
14 than the 30-day period beginning on the date such individ-  
15 ual becomes such an officer or employee.

16 (c) APPOINTMENT OF MEMBERS.—Appointments  
17 shall be made within 30 days of the date of the enactment  
18 of this Act.

19 (d) TERMS.—Each member shall be appointed for the  
20 life of the Commission.

21 (e) VACANCIES.—A vacancy in the Commission shall  
22 be filled within 30 days in the manner in which the origi-  
23 nal appointment was made.

24 (f) COMPENSATION.—

1           (1) RATES OF PAY.—Except as provided in  
2 paragraph (2), members of the Commission shall  
3 serve without pay.

4           (2) TRAVEL EXPENSES.—Each member of the  
5 Commission shall receive travel expenses, including  
6 per diem in lieu of subsistence, in accordance with  
7 sections 5702 and 5703 of title 5, United States  
8 Code.

9           (g) QUORUM.—5 members of the Commission shall  
10 constitute a quorum, but a lesser number may hold hear-  
11 ings.

12          (h) CHAIRPERSON.—The Chairperson of the Com-  
13 mission shall be elected by the members from among the  
14 members.

15          (i) MEETINGS.—The Commission shall meet at least  
16 once each month at the call of the Chairperson of the  
17 Commission.

18 **SEC. 5. STAFF AND SUPPORT SERVICES.**

19          (a) DIRECTOR.—The Commission shall have a Direc-  
20 tor appointed by the Chairperson of the Commission and  
21 paid by a rate determined by the Commission.

22          (b) STAFF.—With the approval of the Commission,  
23 the Director of the Commission may appoint personnel as  
24 the Director considers appropriate.

1 **SEC. 6. POWERS.**

2 (a) HEARINGS AND SESSIONS.—The Commission  
3 may, for the purpose of carrying out this Act, hold hear-  
4 ings, sit and act at times and places, take testimony, and  
5 receive evidence as the Commission considers appropriate.

6 (b) DELEGATION OF AUTHORITY.—Any member or  
7 agent of the Commission may, if authorized by the Com-  
8 mission, take any action which the Commission is author-  
9 ized to take by this section.

10 (c) INFORMATION.—The Commission may secure di-  
11 rectly from any Federal agency information necessary to  
12 enable it to carry out this Act. Upon request of the Chair-  
13 person of the Commission, the head of the Federal agency  
14 shall furnish the information to the Commission.

15 (d) CONTRACT AUTHORITY.—The Commission may  
16 contract with and compensate government and private  
17 agencies or persons for supplies or services without regard  
18 to section 3709 of the Revised Statutes (41 U.S.C. 5).

19 **SEC. 7. REPORTS.**

20 (a) PERIODIC REPORTS.—Pursuant to section  
21 3(a)(3) the Commission shall issue periodic reports to the  
22 President and the Congress.

23 (b) FINAL REPORT.—Not later than the expiration  
24 of the 24-month period beginning on the date of enact-  
25 ment of this Act, the Commission shall submit to the  
26 President and the Congress a final report setting forth

1 the finding and conclusions of the Commission and specific  
2 recommendations for legislative and administrative actions  
3 that the Commission determines to be appropriate.

4 **SEC. 8. TERMINATION.**

5 The Commission shall terminate not later than the  
6 expiration of the 30-day period beginning on the date on  
7 which the Commission submits its final report under sec-  
8 tion 7(b).

9 **SEC. 9. FUNDING AND SUPPORT.**

10 The Commission is to be funded, staffed and  
11 equipped, to the extent practicable and permitted by law,  
12 by the private sector without cost to the Federal Govern-  
13 ment. To accomplish this objective, it is expected that the  
14 Secretary of Commerce will engage in a joint project with  
15 a nonprofit organization pursuant to the first section of  
16 Public Law 91-412 (15 U.S.C. 1525) for the purpose of  
17 providing support for the Commission.
