A BILL

Making appropriations for Agriculture, Rural Development, Food and Drug Administration, and Related Agencies programs for the fiscal year ending September 30, 1994, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for Ag-
5 riculture, Rural Development, Food and Drug Administra-

tion, and Related Agencies programs for the fiscal year ending September 30, 1994, and for other purposes, namely:

TITLE I—AGRICULTURAL PROGRAMS

PRODUCTION, PROCESSING, AND MARKETING

OFFICE OF THE SECRETARY

(INCLUDING TRANSFERS OF FUNDS)

For necessary expenses of the Office of the Secretary of Agriculture, and not to exceed \$50,000 for employment under 5 U.S.C. 3109, \$2,320,000: *Provided*, That not to exceed \$8,000 of this amount shall be available for official reception and representation expenses, not otherwise provided for, as determined by the Secretary: *Provided further*, That the Secretary may transfer salaries and expenses funds in this Act sufficient to finance a total of not to exceed 35 staff years between agencies of the Department of Agriculture to meet workload requirements.

OFFICE OF THE DEPUTY SECRETARY

For necessary expenses of the Office of the Deputy Secretary of Agriculture, including not to exceed \$25,000 for employment under 5 U.S.C. 3109, \$553,000: *Provided*, That not to exceed \$3,000 of this amount shall be available for official reception and representation expenses, not otherwise provided for, as determined by the Deputy Secretary.

1 OFFICE OF BUDGET AND PROGRAM ANALYSIS

2 For necessary expenses of the Office of Budget and
3 Program Analysis, including employment pursuant to the
4 second sentence of section 706(a) of the Organic Act of
5 1944 (7 U.S.C. 2225), of which not to exceed \$5,000 is
6 for employment under 5 U.S.C. 3109, \$5,954,000.

7 OFFICE OF THE ASSISTANT SECRETARY FOR
8 ADMINISTRATION

9 For necessary expenses of the Office of the Assistant
10 Secretary for Administration to carry out the programs
11 funded in this Act, \$808,000.

12 RENTAL PAYMENTS (USDA)
13 (INCLUDING TRANSFERS OF FUNDS)

14 For payment of space rental and related costs pursu-
15 ant to Public Law 92–313 for programs and activities of
16 the Department of Agriculture which are included in this
17 Act, \$135,503,000, of which \$30,804,000 shall be re-
18 tained by the Department of Agriculture for the operation,
19 maintenance, and repair of Agriculture buildings and for
20 non-recurring repairs as determined by the Department
21 of Agriculture, and an additional \$19,700,000 shall be re-
22 tained by the Department of Agriculture for renovation
23 and repair of facilities at the Beltsville Agricultural Re-
24 search Center: *Provided*, That in the event an agency with-
25 in the Department of Agriculture should require modifica-
26 tion of space needs, the Secretary of Agriculture may

1 transfer a share of that agency's appropriation made
2 available by this Act to this appropriation, or may transfer
3 a share of this appropriation to that agency's appropria-
4 tion, but such transfers shall not exceed 5 per centum of
5 the funds made available for space rental and related costs
6 to or from this account.

7 ADVISORY COMMITTEES (USDA)

8 For necessary expenses for activities of advisory com-
9 mittees of the Department of Agriculture which are in-
10 cluded in this Act, \$940,000: *Provided*, That no other
11 funds appropriated to the Department of Agriculture in
12 this Act shall be available to the Department of Agri-
13 culture for support of activities of advisory committees.

14 HAZARDOUS WASTE MANAGEMENT

15 (INCLUDING TRANSFERS OF FUNDS)

16 For necessary expenses of the Department of Agri-
17 culture, to comply with the requirement of section 107g
18 of the Comprehensive Environmental Response, Com-
19 pensation, and Liability Act, as amended, 42 U.S.C.
20 9607g, and section 6001 of the Resource Conservation
21 and Recovery Act, as amended, 42 U.S.C. 6961,
22 \$15,802,000, to remain available until expended: *Pro-*
23 *vided*, That appropriations and funds available herein to
24 the Department of Agriculture for hazardous waste man-
25 agement may be transferred to any agency of the Depart-

1 ment for its use in meeting all requirements pursuant to
2 the above Acts on Federal and non-Federal lands.

3 DEPARTMENTAL ADMINISTRATION

4 (INCLUDING TRANSFERS OF FUNDS)

5 For Personnel, Finance and Management, Oper-
6 ations, Information Resources Management, Advocacy and
7 Enterprise, Administrative Law Judges and Judicial Offi-
8 cer, and Emergency Programs, \$26,301,000, for Depart-
9 mental Administration to provide for necessary expenses
10 for management support services to offices of the Depart-
11 ment of Agriculture and for general administration and
12 emergency preparedness of the Department of Agri-
13 culture, repairs and alterations, and other miscellaneous
14 supplies and expenses not otherwise provided for and nec-
15 essary for the practical and efficient work of the Depart-
16 ment of Agriculture, including employment pursuant to
17 the second sentence of section 706(a) of the Organic Act
18 of 1944 (7 U.S.C. 2225), of which not to exceed \$10,000
19 is for employment under 5 U.S.C. 3109: *Provided*, That
20 this appropriation shall be reimbursed from applicable ap-
21 propriations in this Act for travel expenses incident to the
22 holding of hearings as required by 5 U.S.C. 551–558.

1 OFFICE OF THE ASSISTANT SECRETARY FOR
2 CONGRESSIONAL RELATIONS

3 For necessary expenses of the Office of the Assistant
4 Secretary for Congressional Relations to carry out the pro-
5 grams funded in this Act, \$1,333,000.

6 OFFICE OF PUBLIC AFFAIRS

7 For necessary expenses to carry on services relating
8 to the coordination of programs involving public affairs,
9 and for the dissemination of agricultural information and
10 the coordination of information, work and programs au-
11 thorized by Congress in the Department, \$8,629,000, in-
12 cluding employment pursuant to the second sentence of
13 section 706(a) of the Organic Act of 1944 (7 U.S.C.
14 2225), of which not to exceed \$10,000 shall be available
15 for employment under 5 U.S.C. 3109, and not to exceed
16 \$2,000,000 may be used for farmers' bulletins: *Provided,*
17 That none of the funds in this Act may be used to produce
18 part 2 of the annual report of the Secretary (known as
19 the Yearbook of Agriculture).

20 INTERGOVERNMENTAL AFFAIRS

21 For necessary expenses for programs involving inter-
22 governmental affairs and liaison within the executive
23 branch, \$478,000.

24 OFFICE OF THE INSPECTOR GENERAL

25 For necessary expenses of the Office of the Inspector
26 General, including employment pursuant to the second

1 sentence of section 706(a) of the Organic Act of 1944 (7
2 U.S.C. 2225), and the Inspector General Act of 1978, as
3 amended, \$65,932,000, including such sums as may be
4 necessary for contracting and other arrangements with
5 public agencies and private persons pursuant to section
6 6(a)(8) of the Inspector General Act of 1978, as amended,
7 and including a sum not to exceed \$50,000 for employ-
8 ment under 5 U.S.C. 3109; and including a sum not to
9 exceed \$95,000 for certain confidential operational ex-
10 penses including the payment of informants, to be ex-
11 pended under the direction of the Inspector General pur-
12 suant to Public Law 95–452 and section 1337 of Public
13 Law 97–98.

14 OFFICE OF THE GENERAL COUNSEL

15 For necessary expenses of the Office of the General
16 Counsel, \$26,149,000.

17 OFFICE OF THE ASSISTANT SECRETARY FOR ECONOMICS

18 For necessary expenses of the Office of the Assistant
19 Secretary for Economics to carry out the programs funded
20 in this Act, \$589,000.

21 ECONOMIC RESEARCH SERVICE

22 For necessary expenses of the Economic Research
23 Service in conducting economic research and service relat-
24 ing to agricultural production, marketing, and distribu-
25 tion, as authorized by the Agricultural Marketing Act of

1 1946 (7 U.S.C. 1621–1627) and other laws, including eco-
2 nomics of marketing; analyses relating to farm prices, in-
3 come and population, and demand for farm products, use
4 of resources in agriculture, adjustments, costs and returns
5 in farming, and farm finance; research relating to the eco-
6 nomic and marketing aspects of farmer cooperatives; and
7 for analysis of supply and demand for farm products in
8 foreign countries and their effect on prospects for United
9 States exports, progress in economic development and its
10 relation to sales of farm products, assembly and analysis
11 of agricultural trade statistics and analysis of inter-
12 national financial and monetary programs and policies as
13 they affect the competitive position of United States farm
14 products, \$57,702,000; of which \$500,000 shall be avail-
15 able for investigation, determination, and finding as to the
16 effect upon the production of food and upon the agricul-
17 tural economy of any proposed action affecting such sub-
18 ject matter pending before the Administrator of the Envi-
19 ronmental Protection Agency for presentation, in the pub-
20 lic interest, before said Administrator, other agencies or
21 before the courts: *Provided*, That this appropriation shall
22 be available to continue to gather statistics and conduct
23 a special study on the price spread between the farmer
24 and the consumer: *Provided further*, That this appropria-
25 tion shall be available for employment pursuant to the sec-

1 ond sentence of section 706(a) of the Organic Act of 1944
2 (7 U.S.C. 2225): *Provided further*, That this appropriation
3 shall be available for analysis of statistics and related facts
4 on foreign production and full and complete information
5 on methods used by other countries to move farm com-
6 modities in world trade on a competitive basis.

7 NATIONAL AGRICULTURAL STATISTICS SERVICE

8 For necessary expenses of the National Agricultural
9 Statistics Service in conducting statistical reporting and
10 service work, including crop and livestock estimates, sta-
11 tistical coordination and improvements, and marketing
12 surveys, as authorized by the Agricultural Marketing Act
13 of 1946 (7 U.S.C. 1621–1627) and other laws,
14 \$82,069,000: *Provided*, That this appropriation shall be
15 available for employment pursuant to the second sentence
16 of section 706(a) of the Organic Act of 1944 (7 U.S.C.
17 2225), and not to exceed \$40,000 shall be available for
18 employment under 5 U.S.C. 3109.

19 WORLD AGRICULTURAL OUTLOOK BOARD

20 For necessary expenses of the World Agricultural
21 Outlook Board to coordinate and review all commodity
22 and aggregate agricultural and food data used to develop
23 outlook and situation material within the Department of
24 Agriculture, as authorized by the Agricultural Marketing
25 Act of 1946 (7 U.S.C. 1622g), \$2,582,000: *Provided*, That

1 this appropriation shall be available for employment pur-
2 suant to the second sentence of section 706(a) of the
3 Organic Act of 1944 (7 U.S.C. 2225).

4 OFFICE OF THE ASSISTANT SECRETARY FOR SCIENCE
5 AND EDUCATION

6 For necessary salaries and expenses of the Office of
7 the Assistant Secretary for Science and Education to ad-
8 minister the laws enacted by the Congress for the Agricul-
9 tural Research Service, Cooperative State Research Serv-
10 ice, Extension Service, and National Agricultural Library,
11 \$569,000.

12 ALTERNATIVE AGRICULTURAL RESEARCH AND
13 COMMERCIALIZATION

14 For necessary expenses to carry out the Alternative
15 Agricultural Research and Commercialization Act of 1990
16 (7 U.S.C. 5901–5908), \$7,250,000 is appropriated to the
17 Alternative Agricultural Research and Commercialization
18 Revolving Fund.

19 AGRICULTURAL RESEARCH SERVICE
20 (INCLUDING TRANSFERS OF FUNDS)

21 For necessary expenses to enable the Agricultural Re-
22 search Service to perform agricultural research and dem-
23 onstration relating to production, utilization, marketing,
24 and distribution (not otherwise provided for), home eco-
25 nomics or nutrition and consumer use, and for acquisition

1 of lands by donation, exchange, or purchase at a nominal
2 cost not to exceed \$100, \$688,805,000: *Provided*, That ap-
3 propriations hereunder shall be available for temporary
4 employment pursuant to the second sentence of section
5 706(a) of the Organic Act of 1944 (7 U.S.C. 2225), and
6 not to exceed \$115,000 shall be available for employment
7 under 5 U.S.C. 3109: *Provided further*, That appropria-
8 tions hereunder can be used to provide financial assistance
9 to the organizers of national and international con-
10 ferences, if such conferences are in support of agency pro-
11 grams: *Provided further*, That appropriations hereunder
12 shall be available for the operation and maintenance of
13 aircraft and the purchase of not to exceed one for replace-
14 ment only: *Provided further*, That appropriations here-
15 under shall be available to conduct marketing research:
16 *Provided further*, That appropriations hereunder shall be
17 available pursuant to 7 U.S.C. 2250 for the construction,
18 alteration, and repair of buildings and improvements, but
19 unless otherwise provided the cost of constructing any one
20 building shall not exceed \$250,000, except for headhouses
21 or greenhouses which shall each be limited to \$1,000,000,
22 and except for ten buildings to be constructed or improved
23 at a cost not to exceed \$500,000 each, and the cost of
24 altering any one building during the fiscal year shall not
25 exceed 10 per centum of the current replacement value

1 of the building or \$250,000, whichever is greater: *Provided*
2 *further*, That the limitations on alterations contained in
3 this Act shall not apply to modernization or replacement
4 of existing facilities at Beltsville, Maryland: *Provided fur-*
5 *ther*, That the foregoing limitations shall not apply to re-
6 placement of buildings needed to carry out the Act of April
7 24, 1948 (21 U.S.C. 113a): *Provided further*, That the
8 foregoing limitations shall not apply to the purchase of
9 land or the construction of facilities as may be necessary
10 for the relocation of the United States Horticultural Crops
11 Research Laboratory at Fresno to Parlier, California, and
12 the relocation of the laboratories at Behoust, France and
13 Rome, Italy to Montpelier, France, including the sale or
14 exchange at fair market value of existing land and facili-
15 ties at Fresno, California and Behoust, France; and the
16 Agricultural Research Service may lease such existing land
17 and facilities from the purchasers until completion of the
18 replacement facilities and the foregoing limitations shall
19 not apply to the purchase of land at Weslaco, Texas: *Pro-*
20 *vided further*, That not to exceed \$190,000 of this appro-
21 priation may be transferred to and merged with the appro-
22 priation for the Office of the Assistant Secretary for
23 Science and Education for the scientific review of inter-
24 national issues involving agricultural chemicals and food
25 additives: *Provided further*, That funds may be received

1 from any State, other political subdivision, organization,
2 or individual for the purpose of establishing or operating
3 any research facility or research project of the Agricul-
4 tural Research Service, as authorized by law.

5 Special fund: To provide for additional labor,
6 subprofessional, and junior scientific help to be employed
7 under contracts and cooperative agreements to strengthen
8 the work at Federal research installations in the field,
9 \$2,500,000.

10 BUILDINGS AND FACILITIES

11 For acquisition of land, construction, repair, improve-
12 ment, extension, alteration, and purchase of fixed equip-
13 ment or facilities as necessary to carry out the agricultural
14 research programs of the Department of Agriculture,
15 where not otherwise provided, \$29,387,000, to remain
16 available until expended (7 U.S.C. 2209b): *Provided*, That
17 facilities to house bonsai collections at the National Arbo-
18 retum may be constructed with funds accepted under the
19 provisions of Public Law 94–129 (20 U.S.C. 195) and the
20 limitation on construction contained in the Act of August
21 24, 1912 (40 U.S.C. 68) shall not apply to the construc-
22 tion of such facilities: *Provided further*, That funds may
23 be received from any State, other political subdivision, or-
24 ganization, or individual for the purpose of establishing

1 any research facility of the Agricultural Research Service,
2 as authorized by law.

3 COOPERATIVE STATE RESEARCH SERVICE

4 For payments to agricultural experiment stations, for
5 cooperative forestry and other research, for facilities, and
6 for other expenses, including \$171,304,000 to carry into
7 effect the provisions of the Hatch Act approved March 2,
8 1887, as amended, including administration by the United
9 States Department of Agriculture, penalty mail costs of
10 agricultural experiment stations under section 6 of the
11 Hatch Act of 1887, as amended, and payments under sec-
12 tion 1361(c) of the Act of October 3, 1980 (7 U.S.C.
13 301n.); \$18,809,000 for grants for cooperative forestry re-
14 search under the Act approved October 10, 1962 (16
15 U.S.C. 582a–582–a7), as amended, including administra-
16 tive expenses, and payments under section 1361(c) of the
17 Act of October 3, 1980 (7 U.S.C. 301n.); \$28,157,000 for
18 payments to the 1890 land-grant colleges, including
19 Tuskegee University, for research under section 1445 of
20 the National Agricultural Research, Extension, and
21 Teaching Policy Act of 1977 (7 U.S.C. 3222), as amend-
22 ed, including administration by the United States Depart-
23 ment of Agriculture, and penalty mail costs of the 1890
24 land-grant colleges, including Tuskegee University;
25 \$50,070,000 for contracts and grants for agricultural re-

1 search under the Act of August 4, 1965, as amended (7
2 U.S.C. 450i); \$114,000,000 for competitive research
3 grants under section 2(b) of the Act of August 4, 1965,
4 as amended (7 U.S.C. 450i(b)), including administrative
5 expenses; \$5,551,000 for the support of animal health and
6 disease programs authorized by section 1433 of Public
7 Law 95–113, including administrative expenses;
8 \$2,168,000 for supplemental and alternative crops and
9 products as authorized by the National Agricultural Re-
10 search, Extension, and Teaching Policy Act of 1977 (7
11 U.S.C. 3319d); \$400,000 for grants for research pursuant
12 to the Critical Agricultural Materials Act of 1984 (7
13 U.S.C. 178) and section 1472 of the Food and Agriculture
14 Act of 1977, as amended (7 U.S.C. 3318), to remain avail-
15 able until expended; \$475,000 for rangeland research
16 grants as authorized by subtitle M of the National Agri-
17 cultural Research, Extension, and Teaching Policy Act of
18 1977, as amended; \$3,500,000 for higher education grad-
19 uate fellowships grants under section 1417(b)(6) of the
20 National Agricultural Research, Extension, and Teaching
21 Policy Act of 1977, as amended (7 U.S.C. 3152(b)(6)),
22 including administrative expenses; \$1,500,000 for higher
23 education challenge grants under section 1417(b)(1) of
24 the National Agricultural Research, Extension, and
25 Teaching Policy Act of 1977, as amended (7 U.S.C.

1 3152(b)(1)), including administrative expenses;
2 \$1,000,000 for a higher education minority scholar pro-
3 gram under section 1417(b)(5) of the National Agricul-
4 tural Research, Extension, and Teaching Policy Act of
5 1977, as amended (7 U.S.C. 3152(b)(5)), including ad-
6 ministrative expenses; \$4,000,000 for grants as author-
7 ized by section 1475 of the National Agricultural Re-
8 search, Extension, and Teaching Policy Act of 1977 and
9 other Acts; \$6,825,000 for sustainable agriculture re-
10 search and education, as authorized by section 1621 of
11 Public Law 101–624 (7 U.S.C. 5811), including adminis-
12 trative expenses; and \$20,827,000 for necessary expenses
13 of Cooperative State Research Service activities, including
14 coordination and program leadership for higher education
15 work of the Department, administration of payments to
16 State agricultural experiment stations, funds for employ-
17 ment pursuant to the second sentence of section 706(a)
18 of the Organic Act of 1944 (7 U.S.C. 2225), of which
19 \$10,550,000 shall be for a program of capacity building
20 grants to colleges eligible to receive funds under the Act
21 of August 30, 1890 (7 U.S.C. 321–326 and 328), includ-
22 ing Tuskegee University, of which not to exceed \$100,000
23 shall be for employment under 5 U.S.C. 3109; in all,
24 \$428,586 ,000.

1 BUILDINGS AND FACILITIES

2 For acquisition of land, construction, repair, improve-
3 ment, extension, alteration, and purchase of fixed equip-
4 ment or facilities and for grants to States and other eligi-
5 ble recipients for such purposes, as necessary to carry out
6 the agricultural research, extension, and teaching pro-
7 grams of the Department of Agriculture, where not other-
8 wise provided, \$37,750,000, to remain available until ex-
9 pended (7 U.S.C. 2209b).

10 EXTENSION SERVICE

11 Payments to States, the District of Columbia, Puerto
12 Rico, Guam, the Virgin Islands, Micronesia, Northern
13 Marianas, and American Samoa: For payments for coop-
14 erative agricultural extension work under the Smith-Lever
15 Act, as amended, to be distributed under sections 3(b) and
16 3(c) of said Act, and under section 208(c) of Public Law
17 93-471, for retirement and employees' compensation costs
18 for extension agents and for costs of penalty mail for coop-
19 erative extension agents and State extension directors,
20 \$274,582,000; payments for the nutrition and family edu-
21 cation program for low-income areas under section 3(d)
22 of the Act, \$64,961,000; payments for the pest manage-
23 ment program under section 3(d) of the Act, \$8,459,000;
24 payments for the farm safety and rural health programs
25 under section 3(d) of the Act, \$2,698,000; payments for

1 the pesticide impact assessment program under section
2 3(d) of the Act, \$3,363,000; payments to upgrade 1890
3 land-grant college research and extension facilities as au-
4 thorized by section 1447 of Public Law 95–113, as
5 amended (7 U.S.C. 3222b), \$7,901,000, to remain avail-
6 able until expended; payments for the rural development
7 centers under section 3(d) of the Act, \$938,000; payments
8 for a groundwater quality program under section 3(d) of
9 the Act, \$11,234,000; payments for the Agricultural Tele-
10 communications Program, as authorized by Public Law
11 101–624 (7 U.S.C. 5926), \$1,206,000; payments for
12 youth-at-risk programs under section 3(d) of the Act,
13 \$10,000,000; payments for a food safety program under
14 section 3(d) of the Act, \$1,975,000; payments for carrying
15 out the provisions of the Renewable Resources Extension
16 Act of 1978, \$3,341,000; payments for Indian reservation
17 agents under section 3(d) of the Act, \$1,750,000; pay-
18 ments for sustainable agriculture programs under section
19 3(d) of the Act, \$2,963,000; and payments for extension
20 work by the colleges receiving the benefits of the second
21 Morrill Act (7 U.S.C. 321–326, 328) and Tuskegee Uni-
22 versity, \$25,414,000; in all, \$420,785,000: *Provided*, That
23 funds hereby appropriated pursuant to section 3(c) of the
24 Act of June 26, 1953, and section 506 of the Act of June
25 23, 1972, as amended, shall not be paid to any State, the

1 District of Columbia, Puerto Rico, Guam, or the Virgin
2 Islands, Micronesia, Northern Marianas, and American
3 Samoa prior to availability of an equal sum from non-Fed-
4 eral sources for expenditure during the current fiscal year.

5 Federal administration and coordination: For admin-
6 istration of the Smith-Lever Act, as amended, and the Act
7 of September 29, 1977 (7 U.S.C. 341–349), as amended,
8 and section 1361(c) of the Act of October 3, 1980 (7
9 U.S.C. 301n.), and to coordinate and provide program
10 leadership for the extension work of the Department and
11 the several States and insular possessions, \$8,390,000.

12 NATIONAL AGRICULTURAL LIBRARY

13 For necessary expenses of the National Agricultural
14 Library, \$17,682,000: *Provided*, That this appropriation
15 shall be available for employment pursuant to the second
16 sentence of section 706(a) of the Organic Act of 1944 (7
17 U.S.C. 2225), and not to exceed \$35,000 shall be available
18 for employment under 5 U.S.C. 3109: *Provided further*,
19 That not to exceed \$900,000 shall be available pursuant
20 to 7 U.S.C. 2250 for the alteration and repair of buildings
21 and improvements.

22 OFFICE OF THE ASSISTANT SECRETARY FOR
23 MARKETING AND INSPECTION SERVICES

24 For necessary salaries and expenses of the Office of

1 Services to administer programs under the laws enacted
2 by the Congress for the Animal and Plant Health Inspec-
3 tion Service, Food Safety and Inspection Service, Federal
4 Grain Inspection Service, Agricultural Marketing Service,
5 and Packers and Stockyards Administration, \$691,000.

6 ANIMAL AND PLANT HEALTH INSPECTION SERVICE

7 SALARIES AND EXPENSES

8 (INCLUDING TRANSFERS OF FUNDS)

9 For expenses, not otherwise provided for, including
10 those pursuant to the Act of February 28, 1947, as
11 amended (21 U.S.C. 114b–c), necessary to prevent, con-
12 trol, and eradicate pests and plant and animal diseases;
13 to carry out inspection, quarantine, and regulatory activi-
14 ties; to discharge the authorities of the Secretary of Agri-
15 culture under the Act of March 2, 1931 (46 Stat. 1468;
16 7 U.S.C. 426–426b); and to protect the environment, as
17 authorized by law, \$439,042,000, of which \$91,460,000
18 shall be derived from user fees deposited in the Agricul-
19 tural Quarantine Inspection User Fee Account, and of
20 which \$4,938,000 shall be available for the control of out-
21 breaks of insects, plant diseases, animal diseases and for
22 control of pest animals and birds to the extent necessary
23 to meet emergency conditions: *Provided*, That if the de-
24 mand for Agricultural Quarantine Inspection (AQI) user
25 fee financed services is greater than expected and/or other

1 uncontrollable events occur, the Agency may exceed the
2 AQI User Fee limitation by up to 10 per centum, provided
3 such funds are available in the Agricultural Quarantine
4 Inspection User Fee Account, and with notification to the
5 Appropriations Committees: *Provided further*, That no
6 funds shall be used to formulate or administer a brucel-
7 losis eradication program for the current fiscal year that
8 does not require minimum matching by the States of at
9 least 40 per centum: *Provided further*, That this appro-
10 priation shall be available for field employment pursuant
11 to the second sentence of section 706(a) of the Organic
12 Act of 1944 (7 U.S.C. 2225), and not to exceed \$40,000
13 shall be available for employment under 5 U.S.C. 3109:
14 *Provided further*, That this appropriation shall be available
15 for the operation and maintenance of aircraft and the pur-
16 chase of not to exceed four, of which two shall be for re-
17 placement only: *Provided further*, That, in addition, in
18 emergencies which threaten any segment of the agricul-
19 tural production industry of this country, the Secretary
20 may transfer from other appropriations or funds available
21 to the agencies or corporations of the Department such
22 sums as he may deem necessary, to be available only in
23 such emergencies for the arrest and eradication of con-
24 tagious or infectious disease or pests of animals, poultry,
25 or plants, and for expenses in accordance with the Act

1 of February 28, 1947, as amended, and section 102 of
2 the Act of September 21, 1944, as amended, and any un-
3 expended balances of funds transferred for such emer-
4 gency purposes in the next preceding fiscal year shall be
5 merged with such transferred amounts.

6 BUILDINGS AND FACILITIES

7 For plans, construction, repair, improvement, exten-
8 sion, alteration, and purchase of fixed equipment or facili-
9 ties, as authorized by 7 U.S.C. 2250, and acquisition of
10 land as authorized by 7 U.S.C. 428a, \$10,145,000, to re-
11 main available until expended (7 U.S.C. 2209b).

12 FOOD SAFETY AND INSPECTION SERVICE

13 For necessary expenses to carry on services author-
14 ized by the Federal Meat Inspection Act, as amended, and
15 the Poultry Products Inspection Act, as amended,
16 \$516,738,000, and in addition, \$1,000,000 may be cred-
17 ited to this account from fees collected for the cost of lab-
18 oratory accreditation as authorized by section 1017 of
19 Public Law 102-237: *Provided*, That this appropriation
20 shall be available for field employment pursuant to section
21 706(a) of the Organic Act of 1944 (7 U.S.C. 2225), and
22 not to exceed \$75,000 shall be available for employment
23 under 5 U.S.C. 3109: *Provided further*, That this appro-
24 priation shall be available pursuant to law (7 U.S.C. 2250)
25 for the alteration and repair of buildings and improve-
26 ments, but the cost of altering any one building during

1 the fiscal year shall not exceed 10 per centum of the cur-
2 rent replacement value of the building.

3 FEDERAL GRAIN INSPECTION SERVICE

4 SALARIES AND EXPENSES

5 For necessary expenses to carry out the provisions
6 of the United States Grain Standards Act, as amended,
7 and the standardization activities related to grain under
8 the Agricultural Marketing Act of 1946, as amended, in-
9 cluding field employment pursuant to section 706(a) of the
10 Organic Act of 1944 (7 U.S.C. 2225), and not to exceed
11 \$20,000 for employment under 5 U.S.C. 3109,
12 \$11,554,000: *Provided*, That this appropriation shall be
13 available pursuant to law (7 U.S.C. 2250) for the alter-
14 ation and repair of buildings and improvements, but the
15 cost of altering any one building during the fiscal year
16 shall not exceed 10 per centum of the current replacement
17 value of the building: *Provided further*, That none of the
18 funds provided by this Act may be used to pay the salaries
19 of any person or persons who require, or who authorize
20 payments from fee-supported funds to any person or per-
21 sons who require nonexport, nonterminal interior elevators
22 to maintain records not involving official inspection or offi-
23 cial weighing in the United States under Public Law 94-
24 582 other than those necessary to fulfill the purposes of
25 such Act.

1 INSPECTION AND WEIGHING SERVICES

2 LIMITATION ON INSPECTION AND WEIGHING SERVICES

3 EXPENSES

4 Not to exceed \$42,784,000 (from fees collected) shall
5 be obligated during the current fiscal year for Inspection
6 and Weighing Services: *Provided*, That if grain export ac-
7 tivities require additional supervision and oversight, or
8 other uncontrollable factors occur, this limitation may be
9 exceeded by up to 10 per centum with notification to the
10 Appropriations Committees.

11 AGRICULTURAL MARKETING SERVICE

12 MARKETING SERVICES

13 For necessary expenses to carry on services related
14 to consumer protection, agricultural marketing and dis-
15 tribution, transportation, agricultural cooperatives, and
16 regulatory programs, as authorized by law, and for admin-
17 istration and coordination of payments to States; includ-
18 ing field employment pursuant to section 706(a) of the
19 Organic Act of 1944 (7 U.S.C. 2225), and not to exceed
20 \$90,000 for employment under 5 U.S.C. 3109,
21 \$61,614,000; including \$2,346,000 for the Wholesale
22 Market Development Program for the design and develop-
23 ment of wholesale and farmer market facilities for the
24 major metropolitan areas of the country: *Provided*, That
25 this appropriation shall be available pursuant to law (7
26 U.S.C. 2250) for the alteration and repair of buildings

1 and improvements, but the cost of altering any one build-
2 ing during the fiscal year shall not exceed 10 per centum
3 of the current replacement value of the building.

4 Fees may be collected for the cost of standardization
5 activities, as established by regulation pursuant to law (31
6 U.S.C. 9701).

7 LIMITATION ON ADMINISTRATIVE EXPENSES

8 Not to exceed \$55,953,000 (from fees collected) shall
9 be obligated during the current fiscal year for administra-
10 tive expenses: *Provided*, That if crop size is understated
11 and/or other uncontrollable events occur, the agency may
12 exceed this limitation by up to 10 per centum with notifi-
13 cation to the Appropriations Committees.

14 FUNDS FOR STRENGTHENING MARKETS, INCOME, AND

15 SUPPLY (SECTION 32)

16 (INCLUDING TRANSFERS OF FUNDS)

17 Funds available under section 32 of the Act of Au-
18 gust 24, 1935 (7 U.S.C. 612c) shall be used only for com-
19 modity program expenses as authorized therein, and other
20 related operating expenses, except for: (1) transfers to the
21 Department of Commerce as authorized by the Fish and
22 Wildlife Act of August 8, 1956; (2) transfers otherwise
23 provided in this Act; and (3) not more than \$10,309,000
24 for formulation and administration of Marketing Agree-
25 ments and Orders pursuant to the Agricultural Marketing

1 Agreement Act of 1937, as amended, and the Agricultural
2 Act of 1961.

3 PAYMENTS TO STATES AND POSSESSIONS

4 For payments to departments of agriculture, bureaus
5 and departments of markets, and similar agencies for
6 marketing activities under section 204(b) of the Agricul-
7 tural Marketing Act of 1946 (7 U.S.C. 1623(b)),
8 \$1,735,000.

9 PACKERS AND STOCKYARDS ADMINISTRATION

10 For necessary expenses for administration of the
11 Packers and Stockyards Act, as authorized by law, and
12 for certifying procedures used to protect purchasers of
13 farm products, including field employment pursuant to
14 section 706(a) of the Organic Act of 1944 (7 U.S.C.
15 2225), and not to exceed \$5,000 for employment under
16 5 U.S.C. 3109, \$12,194,000.

17 FARM INCOME STABILIZATION

18 OFFICE OF THE UNDER SECRETARY FOR

19 INTERNATIONAL AFFAIRS AND COMMODITY PROGRAMS

20 For necessary salaries and expenses of the Office of
21 the Under Secretary for International Affairs and Com-
22 modity Programs to administer the laws enacted by Con-
23 gress for the Agricultural Stabilization and Conservation
24 Service, Foreign Agricultural Service, and the Commodity
25 Credit Corporation, \$563,000.

1 AGRICULTURAL STABILIZATION AND CONSERVATION

2 SERVICE

3 SALARIES AND EXPENSES

4 (INCLUDING TRANSFERS OF FUNDS)

5 For necessary administrative expenses of the Agricul-
6 tural Stabilization and Conservation Service, including ex-
7 penses to formulate and carry out programs authorized
8 by title III of the Agricultural Adjustment Act of 1938,
9 as amended (7 U.S.C. 1301–1393); the Agricultural Act
10 of 1949, as amended (7 U.S.C. 1421 et seq.); sections 7
11 to 15, 16(a), 16(f), and 17 of the Soil Conservation and
12 Domestic Allotment Act, as amended (16 U.S.C. 590g–
13 590o, 590p(a), 590p(f), and 590q); sections 1001 to 1004,
14 1006 to 1008, and 1010 of the Agricultural Act of 1970,
15 as amended (16 U.S.C. 1501 to 1504, 1506 to 1508, and
16 1510); the Water Bank Act, as amended (16 U.S.C.
17 1301–1311); the Cooperative Forestry Assistance Act of
18 1978 (16 U.S.C. 2101); sections 202(c) and 205 of title
19 II of the Colorado River Basin Salinity Control Act of
20 1974, as amended (43 U.S.C. 1592(c), 1595); sections
21 401, 402, and 404 to 406 of the Agricultural Credit Act
22 of 1978 (16 U.S.C. 2201 to 2205); the United States
23 Warehouse Act, as amended (7 U.S.C. 241–273); title XII
24 of the Food Security Act of 1985, as amended (16 U.S.C.
25 3811 et seq.); and laws pertaining to the Commodity Cred-
26 it Corporation, \$732,467,000; of which \$730,842,000 is

1 hereby appropriated, and \$1,036,000 is transferred from
2 the Public Law 480 Program Account in this Act and
3 \$589,000 is transferred from the Commodity Credit Cor-
4 poration Program Account in this Act: *Provided*, That
5 other funds made available to the Agricultural Stabiliza-
6 tion and Conservation Service for authorized activities
7 may be advanced to and merged with this account: *Pro-*
8 *vided further*, That these funds shall be available for em-
9 ployment pursuant to the second sentence of section
10 706(a) of the Organic Act of 1944 (7 U.S.C. 2225), and
11 not to exceed \$100,000 shall be available for employment
12 under 5 U.S.C. 3109: *Provided further*, That no part of
13 the funds made available under this Act shall be used (1)
14 to influence the vote in any referendum; (2) to influence
15 agricultural legislation, except as permitted in 18 U.S.C.
16 1913; or (3) for salaries or other expenses of members
17 of county and community committees established pursuant

23 CORPORATIONS

24 The following corporations and agencies are hereby
25 authorized to make expenditures, within the limits of

1 funds and borrowing authority available to each such cor-
2 poration or agency and in accord with law, and to make
3 contracts and commitments without regard to fiscal year
4 limitations as provided by section 104 of the Government
5 Corporation Control Act, as amended, as may be necessary
6 in carrying out the programs set forth in the budget for
7 the current fiscal year for such corporation or agency, ex-
8 cept as hereinafter provided:

9 FEDERAL CROP INSURANCE CORPORATION

10 ADMINISTRATIVE AND OPERATING EXPENSES

11 For administrative and operating expenses, as au-
12 thorized by the Federal Crop Insurance Act, as amended
13 (7 U.S.C. 1516), \$290,116,000: *Provided*, That not to ex-
14 ceed \$700 shall be available for official reception and rep-
15 resentation expenses, as authorized by 7 U.S.C. 1506(i):
16 *Provided further*, That none of the funds in this Act may
17 be used to offer a Federal crop insurance policy in coun-
18 ties on crops where a loss ratio, that has already been
19 recalculated pursuant to law to reflect the premium rates
20 issued by the Corporation for the 1993 crop year, is in
21 excess of 1.10 more than 70 percent of the years that a
22 policy has been offered since 1980: *Provided further*, That
23 none of the funds in this Act may be used to pay operating
24 and administrative costs that exceed 31 per centum of pre-
25 mium to insurers of policies on which the Corporation pro-

1 vides reinsurance, except to reimburse said insurers for
2 excess loss adjustment expenses as provided for in the
3 Standard Reinsurance Agreement issued by the Corpora-
4 tion.

5 FEDERAL CROP INSURANCE CORPORATION FUND

6 For payments as authorized by section 508(b) of the
7 Federal Crop Insurance Act, as amended, \$235,794,000,
8 to remain available until expended (7 U.S.C. 2209b); of
9 which \$47,072,000 is to reimburse the Federal Crop In-
10 surance Corporation Fund for agents' commissions and
11 loss adjustment obligations incurred during prior years,
12 but not previously reimbursed, as authorized by section
13 516(a) of the Act, as amended.

14 COMMODITY CREDIT CORPORATION FUND

15 REIMBURSEMENT FOR NET REALIZED LOSSES

16 For fiscal year 1994, such sums as may be necessary
17 to reimburse the Commodity Credit Corporation for net
18 realized losses sustained, but not previously reimbursed
19 (estimated to be \$20,896,614,000 in the President's fiscal
20 year 1994 Budget Request (H. Doc. 103-3)), but not to
21 exceed \$18,000,000,000, pursuant to section 2 of the Act
22 of August 17, 1961, as amended (15 U.S.C. 713a-11).

23 OPERATIONS AND MAINTENANCE FOR HAZARDOUS WASTE

24 MANAGEMENT

25 For fiscal year 1994, the Commodity Credit Corpora-
26 tion shall not expend more than \$4,000,000 for expenses

1 to comply with the requirement of section 107(g) of the
2 Comprehensive Environmental Response, Compensation,
3 and Liability Act, as amended, 42 U.S.C. 9607(g), and
4 section 6001 of the Resource Conservation and Recovery
5 Act, as amended, 42 U.S.C. 6961: *Provided*, That ex-
6 penses shall be for operations and maintenance costs only
7 and that other hazardous waste management costs shall
8 be paid for by the USDA Hazardous Waste Management
9 appropriation in this Act.

10 **TITLE II—CONSERVATION PROGRAMS**

11 OFFICE OF THE ASSISTANT SECRETARY FOR NATURAL 12 RESOURCES AND ENVIRONMENT

13 For necessary salaries and expenses of the Office of
14 the Assistant Secretary for Natural Resources and Envi-
15 ronment to administer the laws enacted by the Congress
16 for the Forest Service and the Soil Conservation Service,
17 \$578,000.

18 SOIL CONSERVATION SERVICE

19 CONSERVATION OPERATIONS

20 For necessary expenses for carrying out the provi-
21 sions of the Act of April 27, 1935 (16 U.S.C. 590a–590f)
22 including preparation of conservation plans and establish-
23 ment of measures to conserve soil and water (including
24 farm irrigation and land drainage and such special meas-
25 ures for soil and water management as may be necessary

1 to prevent floods and the siltation of reservoirs and to con-
2 trol agricultural related pollutants); operation of conserva-
3 tion plant materials centers; classification and mapping of
4 soil; dissemination of information; acquisition of lands by
5 donation, exchange, or purchase at a nominal cost not to
6 exceed \$100; purchase and erection or alteration or im-
7 provement of permanent and temporary buildings; and op-
8 eration and maintenance of aircraft, \$588,262,000, to re-
9 main available until expended (7 U.S.C. 2209b); of which
10 not less than \$5,820,000 is for snow survey and water
11 forecasting and not less than \$8,214,000 is for operation
12 and establishment of the plant materials centers: *Provided*,
13 That except for \$2,399,000 for improvements of the plant
14 materials centers, the cost of any permanent building pur-
15 chased, erected, or as improved, exclusive of the cost of
16 constructing a water supply or sanitary system and con-
17 necting the same to any such building and with the excep-
18 tion of buildings acquired in conjunction with land being
19 purchased for other purposes, shall not exceed \$10,000,
20 except for one building to be constructed at a cost not
21 to exceed \$100,000 and eight buildings to be constructed
22 or improved at a cost not to exceed \$50,000 per building
23 and except that alterations or improvements to other exist-
24 ing permanent buildings costing \$5,000 or more may be

1 per building: *Provided further*, That when buildings or
2 other structures are erected on non-Federal land that the

10 ganic Act of 1944 (7 U.S.C. 2225) and not to exceed
11 \$25,000 shall be available for employment under 5 U.S.C.
12 3109: *Provided further*, That qualified local engineers may
13 be temporarily employed at per diem rates to perform
14 the technical planning work of the Service (16 U.S.C.
15 590e–2).

16 RIVER BASIN SURVEYS AND INVESTIGATIONS

17 For necessary expenses to conduct research, inves-
18 tigation, and surveys of watersheds of rivers and other wa-
19 terways, in accordance with section 6 of the Watershed
20 Protection and Flood Prevention Act approved August 4,
21 1954, as amended (16 U.S.C. 1006–1009), \$13,482,000:
22 *Provided*, That this appropriation shall be available for
23 employment pursuant to the second sentence of section
24 706(a) of the Organic Act of 1944 (7 U.S.C. 2225), and
25 not to exceed \$60,000 shall be available for employment
26 under 5 U.S.C. 3109.

1 WATERSHED PLANNING

2 For necessary expenses for small watershed investiga-
3 tions and planning, in accordance with the Watershed Pro-
4 tection and Flood Prevention Act, as amended (16 U.S.C.
5 1001–1008), \$9,721,000: *Provided*, That this appropria-
6 tion shall be available for employment pursuant to the sec-
7 ond sentence of section 706(a) of the Organic Act of 1944
8 (7 U.S.C. 2225), and not to exceed \$50,000 shall be avail-
9 able for employment under 5 U.S.C. 3109.

10 WATERSHED AND FLOOD PREVENTION OPERATIONS

11 For necessary expenses to carry out preventive meas-
12 ures, including but not limited to research, engineering op-
13 erations, methods of cultivation, the growing of vegetation,
14 rehabilitation of existing works and changes in use of land,
15 in accordance with the Watershed Protection and Flood
16 Prevention Act approved August 4, 1954, as amended (16
17 U.S.C. 1001–1005, 1007–1009), the provisions of the Act
18 of April 27, 1935 (16 U.S.C. 590a–f), and in accordance
19 with the provisions of laws relating to the activities of the
20 Department, \$228,915,000 to remain available until ex-
21 pended (7 U.S.C. 2209b), of which \$40,386,000 shall be
22 available for the watersheds authorized under the Flood
23 Control Act approved June 22, 1936 (33 U.S.C. 701, 16
24 U.S.C. 1006a), as amended and supplemented: *Provided*,
25 That this appropriation shall be available for employment
26 pursuant to the second sentence of section 706(a) of the

1 Organic Act of 1944 (7 U.S.C. 2225), and not to exceed
2 \$22,881,000 shall be available for emergency measures as
3 provided by sections 403–405 of the Agricultural Credit
4 Act of 1978 (16 U.S.C. 2203–2205), and not to exceed
5 \$200,000 shall be available for employment under 5
6 U.S.C. 3109: *Provided further*, That \$4,000,000 in loans
7 may be insured, or made to be sold and insured, under
8 the Agricultural Credit Insurance Fund of the Farmers
9 Home Administration (7 U.S.C. 1931): *Provided further*,
10 That not to exceed \$1,000,000 of this appropriation is
11 available to carry out the purposes of the Endangered Spe-
12 cies Act of 1973 (Public Law 93–205), as amended, in-
13 cluding cooperative efforts as contemplated by that Act
14 to relocate endangered or threatened species to other suit-
15 able habitats as may be necessary to expedite project con-
16 struction.

23 the provisions of the Act of April 27, 1935 (16 U.S.C.
24 590a–f), and the provisions of the Agriculture and Food
25 Act of 1981 (16 U.S.C. 3451–3461), \$32,945,000, to re-
26 main available until expended (7 U.S.C. 2209b): *Provided*,

1 That \$600,000 in loans may be insured, or made to be
2 sold and insured, under the Agricultural Credit Insurance
3 Fund of the Farmers Home Administration (7 U.S.C.
4 1931): *Provided further*, That this appropriation shall be
5 available for employment pursuant to the second sentence
6 of section 706(a) of the Organic Act of 1944 (7 U.S.C.
7 2225), and not to exceed \$50,000 shall be available for
8 employment under 5 U.S.C. 3109.

9 GREAT PLAINS CONSERVATION PROGRAM

10 For necessary expenses to carry into effect a program
11 of conservation in the Great Plains area, pursuant to sec-
12 tion 16(b) of the Soil Conservation and Domestic Allot-
13 ment Act, as added by the Act of August 7, 1956, as
14 amended (16 U.S.C. 590p(b)), \$25,658,000, to remain
15 available until expended (16 U.S.C. 590p(b)(7)).

16 AGRICULTURAL STABILIZATION AND CONSERVATION

17 SERVICE

18 AGRICULTURAL CONSERVATION PROGRAM

19 (INCLUDING TRANSFERS OF FUNDS)

20 For necessary expenses to carry into effect the pro-
21 gram authorized in sections 7 to 15, 16(a), 16(f), and 17
22 of the Soil Conservation and Domestic Allotment Act ap-
23 proved February 29, 1936, as amended and supplemented
24 (16 U.S.C. 590g–590o, 590p(a), 590p(f), and 590q), and
25 sections 1001–1004, 1006–1008, and 1010 of the Agricul-
26 tural Act of 1970, as added by the Agriculture and

1 Consumer Protection Act of 1973 (16 U.S.C. 1501–1504,
2 1506–1508, and 1510), and including not to exceed
3 \$15,000 for the preparation and display of exhibits, in-
4 cluding such displays at State, interstate, and inter-
5 national fairs within the United States, \$194,650,000, to
6 remain available until expended (16 U.S.C. 590o), for
7 agreements, excluding administration but including tech-
8 nical assistance and related expenses (16 U.S.C. 590o),
9 except that no participant in the Agricultural Conserva-
10 tion Program shall receive more than \$3,500 per year, ex-
11 cept where the participants from two or more farms or
12 ranches join to carry out approved practices designed to
13 conserve or improve the agricultural resources of the com-
14 munity, or where a participant has a long-term agreement,
15 in which case the total payment shall not exceed the an-
16 nual payment limitation multiplied by the number of years
17 of the agreement: *Provided*, That no portion of the funds
18 for the current year’s program may be utilized to provide
19 financial or technical assistance for drainage on wetlands
20 now designated as Wetlands Types 3 (III) through 20
21 (XX) in United States Department of the Interior, Fish
22 and Wildlife Circular 39, Wetlands of the United States,
23 1956: *Provided further*, That such amounts shall be avail-
24 able for the purchase of seeds, fertilizers, lime, trees, or
25 any other conservation materials, or any soil-terracing

1 services, and making grants thereof to agricultural pro-
2 ducers to aid them in carrying out approved farming prac-
3 tices as authorized by the Soil Conservation and Domestic
4 Allotment Act, as amended, as determined and rec-
5 ommended by the county committees, approved by the
6 State committees and the Secretary, under programs pro-
7 vided for herein: *Provided further*, That such assistance
8 will not be used for carrying out measures and practices
9 that are primarily production-oriented or that have little
10 or no conservation or pollution abatement benefits: *Pro-*
11 *vided further*, That not to exceed 5 per centum of the allo-
12 cation for the current year's program for any county may,
13 on the recommendation of such county committee and ap-
14 proval of the State committee, be withheld and allotted
15 to the Soil Conservation Service for services of its techni-
16 cians in formulating and carrying out the Agricultural
17 Conservation Program in the participating counties, and
18 shall not be utilized by the Soil Conservation Service for
19 any purpose other than technical and other assistance in
20 such counties, and in addition, on the recommendation of
21 such county committee and approval of the State commit-
22 tee, not to exceed 1 per centum may be made available
23 to any other Federal, State, or local public agency for the
24 same purpose and under the same conditions: *Provided*
25 *further*, That for the current year's program \$2,500,000

1 shall be available for technical assistance in formulating
2 and carrying out rural environmental practices: *Provided*
3 *further*, That no part of any funds available to the Depart-
4 ment, or any bureau, office, corporation, or other agency
5 constituting a part of such Department, shall be used in
6 the current fiscal year for the payment of salary or travel
7 expenses of any person who has been convicted of violating
8 the Act entitled “An Act to prevent pernicious political
9 activities” approved August 2, 1939, as amended, or who
10 has been found in accordance with the provisions of title
11 18 U.S.C. 1913 to have violated or attempted to violate
12 such section which prohibits the use of Federal appropria-
13 tions for the payment of personal services or other ex-
14 penses designed to influence in any manner a Member of

25 For necessary expenses, not otherwise provided for,
26 to carry out the program of forestry incentives, as author-

1 ized in the Cooperative Forestry Assistance Act of 1978
2 (16 U.S.C. 2101), including technical assistance and relat-
3 ed expenses, \$12,820,000, to remain available until ex-
4 pended, as authorized by that Act.

5 WATER BANK PROGRAM

6 For necessary expenses to carry into effect the provi-
7 sions of the Water Bank Act (16 U.S.C. 1301–1311),
8 \$18,620,000, to remain available until expended.

9 EMERGENCY CONSERVATION PROGRAM

10 For necessary expenses to carry into effect the pro-
11 gram authorized in sections 401, 402, and 404 of title IV
12 of the Agricultural Credit Act of 1978 (16 U.S.C. 2201–
13 2205), \$10,000,000, to remain available until expended,
14 as authorized by 16 U.S.C. 2204.

15 COLORADO RIVER BASIN SALINITY CONTROL PROGRAM

16 For necessary expenses for carrying out a voluntary
17 cooperative salinity control program pursuant to section
18 202(c) of title II of the Colorado River Basin Salinity Con-
19 trol Act, as amended (43 U.S.C. 1592(c)), to be used to
20 reduce salinity in the Colorado River and to enhance the
21 supply and quality of water available for use in the United
22 States and the Republic of Mexico, \$13,783,000, to re-
23 main available until expended (7 U.S.C. 2209b), to be
24 used for investigations and surveys, for technical assist-
25 ance in developing conservation practices and in the prepa-
26 ration of salinity control plans, for the establishment of

1 on-farm irrigation management systems, including related
2 lateral improvement measures, for making cost-share pay-
3 ments to agricultural landowners and operators, Indian
4 tribes, irrigation districts and associations, local govern-
5 mental and nongovernmental entities, and other land-
6 owners to aid them in carrying out approved conservation
7 practices as determined and recommended by the county
8 ASC committees, approved by the State ASC committees
9 and the Secretary, and for associated costs of program
10 planning, information and education, and program mon-
11 itoring and evaluation: *Provided*, That the Soil Conserva-
12 tion Service shall provide technical assistance and the Ag-

17 *further*, That such program shall be coordinated with the
18 regular Agricultural Conservation Program and with re-
19 search programs of other agencies.

21 (INCLUDING TRANSFERS OF FUNDS)

22 For necessary expenses to carry out the conservation
23 reserve program pursuant to the Food Security Act of
24 1985 (16 U.S.C. 3831–3845), \$1,743,274,000, to remain
25 available until expended, to be used for Commodity Credit

1 Corporation expenditures for cost-share assistance for the
2 establishment of conservation practices provided for in ap-
3 proved conservation reserve program contracts, for annual
4 rental payments provided in such contracts, and for tech-
5 nical assistance.

6 WETLANDS RESERVE PROGRAM
7 INCLUDING TRANSFERS OF FUNDS)

8 For necessary expenses to carry out the Wetlands Re-
9 serve Program pursuant to subchapter C of subtitle D of
10 title XII of the Food Security Act of 1985 (16 U.S.C.
11 3837), \$44,450,000, to remain available until expended:
12 *Provided*, That the Secretary is authorized to use the serv-
13 ices, facilities, and authorities of the Commodity Credit
14 Corporation for the purpose of carrying out the Wetlands
15 Reserve Program.

23 by the Congress for the Farmers Home Administration,
24 Rural Electrification Administration, Federal Crop Insur-
25 ance Corporation, and rural development activities of the

1 FARMERS HOME ADMINISTRATION

2 RURAL HOUSING INSURANCE FUND PROGRAM ACCOUNT

17 310B(j) (7 U.S.C. 1932) of the Consolidated Farm and
18 Rural Development Act to any qualified public or private
19 nonprofit organization, \$35,000,000: *Provided*, That
20 \$500,000 shall be available for grants to qualified non-

22 be available for this Office.

23 SALARIES AND EXPENSES

24 (INCLUDING TRANSFERS OF FUNDS)

25 For necessary expenses of the Farmers Home Admin-
26 istration, not otherwise provided for, in administering the

1 programs authorized by the Consolidated Farm and Rural
2 Development Act (7 U.S.C. 1921–2000), as amended; title
3 V of the Housing Act of 1949, as amended (42 U.S.C.
4 1471–1490o); the Rural Rehabilitation Corporation Trust

1 In addition, for administrative expenses necessary to
2 carry out the loan programs, \$8,794,000.

3 DISTANCE LEARNING AND MEDICAL LINK PROGRAMS

4 For necessary expenses to carry into effect the pro-
5 grams authorized in sections 2331–2335 of Public Law
6 101–624, \$10,000,000, to remain available until ex-
7 pended.

8 RURAL ECONOMIC DEVELOPMENT LOANS PROGRAM

9 ACCOUNT

10 For loans authorized under section 313 of the Rural
11 Electrification Act, for the purpose of promoting rural eco-
12 nomic development and job creation projects,
13 \$13,025,000.

14 For the cost, as defined in section 502 of the Con-
15 gressional Budget Act of 1974, of direct loans,
16 \$3,381,000.

17 SALARIES AND EXPENSES

18 (INCLUDING TRANSFERS OF FUNDS)

19 For administrative expenses to carry out the provi-
20 sions of the Rural Electrification Act of 1936, as amended
21 (7 U.S.C. 901–950(b)), and to administer the loan and
22 loan guarantee programs for Community Antenna Tele-
23 vision facilities as authorized by the Consolidated Farm

26 1994, including not to exceed \$7,000 for financial and

16 transferred to any other agency or office.

17 **TITLE IV—DOMESTIC FOOD PROGRAMS**

18 OFFICE OF THE ASSISTANT SECRETARY FOR FOOD AND
19 CONSUMER SERVICES

20 For necessary salaries and expenses of the Office of
21 the Assistant Secretary for Food and Consumer Services
22 to administer the laws enacted by the Congress for the
23 Food and Nutrition Service, \$554,000.

1 FOOD AND NUTRITION SERVICE

2 CHILD NUTRITION PROGRAMS

3 (INCLUDING TRANSFERS OF FUNDS)

4 For necessary expenses to carry out the National
5 School Lunch Act (42 U.S.C. 1751–1769b), and the appli-
6 cable provisions other than sections 3 and 17 of the Child
7 Nutrition Act of 1966 (42 U.S.C. 1773–1785, and 1788–
8 1789); \$7,497,131,000, to remain available through Sep-
9 tember 30, 1995, of which \$2,727,022,000 is hereby ap-
10 propriated and \$4,770,109,000 shall be derived by trans-
11 fer from funds available under section 32 of the Act of
12 August 24, 1935 (7 U.S.C. 612c): *Provided*, That funds
13 appropriated for the purpose of section 7 of the Child Nu-
14 trition Act of 1966 shall be allocated among the States
15 but the distribution of such funds to an individual State
16 is contingent upon that State’s agreement to participate
17 in studies and surveys of programs authorized under the
18 National School Lunch Act and the Child Nutrition Act
19 of 1966, when such studies and surveys have been directed
20 by the Congress and requested by the Secretary of Agri-
21 culture: *Provided further*, That if the Secretary of Agri-
22 culture determines that a State’s administration of any
23 program under the National School Lunch Act or the
24 Child Nutrition Act of 1966 (other than section 17), or
25 the regulations issued pursuant to these Acts, is seriously
26 deficient, and the State fails to correct the deficiency with-

1 in a specified period of time, the Secretary may withhold
2 from the State some or all of the funds allocated to the
3 State under section 7 of the Child Nutrition Act of 1966
4 and under section 13(k)(1) of the National School Lunch
5 Act; upon a subsequent determination by the Secretary
6 that the programs are operated in an acceptable manner
7 some or all of the funds withheld may be allocated: *Pro-*
8 *vided further*, That only final reimbursement claims for
9 service of meals, supplements, and milk submitted to State
10 agencies by eligible schools, summer camps, institutions,
11 and service institutions within sixty days following the
12 month for which the reimbursement is claimed shall be
13 eligible for reimbursement from funds appropriated under
14 this Act. States may receive program funds appropriated
15 under this Act for meals, supplements, and milk served
16 during any month only if the final program operations re-
17 port for such month is submitted to the Department with-
18 in ninety days following that month. Exceptions to these
19 claims or reports submission requirements may be made
20 at the discretion of the Secretary: *Provided further*, That
21 up to \$3,849,000 shall be available for independent ver-
22 ification of school food service claims: *Provided further*,
23 That \$1,706,000 shall be available to provide financial
24 and other assistance to operate the Food Service Manage-
25 ment Institute.

1 None of the funds in this Act may be used to require
2 schools participating in the school lunch program to offer
3 students fluid whole milk as otherwise required by 42
4 U.S.C. 1758(a)(2).

5 SPECIAL MILK PROGRAM

6 For necessary expenses to carry out the special milk
7 program, as authorized by section 3 of the Child Nutrition
8 Act of 1966 (42 U.S.C. 1772), \$20,277,000, to remain
9 available through September 30, 1995. Only final reim-
10 bursement claims for milk submitted to State agencies
11 within sixty days following the month for which the reim-
12 bursement is claimed shall be eligible for reimbursement
13 from funds appropriated under this Act. States may re-
14 ceive program funds appropriated under this Act only if
15 the final program operations report for such month is sub-
16 mitted to the Department within ninety days following
17 that month. Exceptions to these claims or reports submis-
18 sion requirements may be made at the discretion of the
19 Secretary.

20 SPECIAL SUPPLEMENTAL FOOD PROGRAM FOR WOMEN,
21 INFANTS, AND CHILDREN (WIC)

22 For necessary expenses to carry out the special sup-
23 plemental food program as authorized by section 17 of the
24 Child Nutrition Act of 1966 (42 U.S.C. 1786),
25 \$3,210,000,000, to remain available through September
26 30, 1995, of which up to \$4,000,000 may be used to carry

1 out the farmer's market coupon program: *Provided*, That
2 none of the funds in this Act shall be available to pay
3 administrative expenses of WIC clinics except those that
4 have an announced policy of prohibiting smoking within
5 the space used to carry out the program.

6 COMMODITY SUPPLEMENTAL FOOD PROGRAM

7 For necessary expenses to carry out the commodity
8 supplemental food program as authorized by section 4(a)
9 of the Agriculture and Consumer Protection Act of 1973
10 (7 U.S.C. 612c (note)), including not less than \$8,000,000
11 for the projects in Detroit, New Orleans, and Des Moines,
12 \$104,500,000 to remain available through September 30,
13 1995: *Provided*, That none of these funds shall be avail-
14 able to reimburse the Commodity Credit Corporation for
15 commodities donated to the program.

16 FOOD STAMP PROGRAM

17 (INCLUDING TRANSFERS OF FUNDS)

18 For necessary expenses to carry out the Food Stamp
19 Act (7 U.S.C. 2011–2029), \$28,136,655,000: *Provided*,
20 That funds provided herein shall remain available through
21 September 30, 1994, in accordance with section 18(a) of
22 the Food Stamp Act: *Provided further*, That
23 \$2,500,000,000 of the foregoing amount shall be placed
24 in reserve for use only in such amounts and at such times
25 as may become necessary to carry out program operations:
26 *Provided further*, That funds provided herein shall be ex-

1 pended in accordance with section 16 of the Food Stamp
2 Act: *Provided further*, That this appropriation shall be
3 subject to any work registration or work fare requirements
4 as may be required by law: *Provided further*, That
5 \$345,000,000 of the funds provided herein shall be avail-
6 able after the Secretary has employed the regulatory and
7 administrative methods available to him under the law to
8 curtail fraud, waste, and abuse in the program: *Provided*
9 *further*, That \$1,091,000,000 of the foregoing amount
10 shall be available for Nutrition Assistance for Puerto Rico
11 as authorized by 7 U.S.C. 2028, of which \$12,472,000
12 shall be transferred to the Animal and Plant Health In-
13 spection Service for the Cattle Tick Eradication Project.

14 FOOD DONATIONS PROGRAMS FOR SELECTED GROUPS

15 For necessary expenses to carry out section 4(a) of
16 the Agriculture and Consumer Protection Act of 1973 (7
17 U.S.C. 612c (note)), section 4(b) of the Food Stamp Act
18 (7 U.S.C. 2013(b)), and section 311 of the Older Ameri-
19 cans Act of 1965, as amended (42 U.S.C. 3030a),
20 \$218,641,000, to remain available through September 30,
21 1995.

22 For necessary expenses to carry out section 110 of
23 the Hunger Prevention Act of 1988, \$40,000,000.

24 THE EMERGENCY FOOD ASSISTANCE PROGRAM

25 For necessary expenses to carry out the Emergency
26 Food Assistance Act of 1983, as amended, \$40,000,000:

1 *Provided*, That, in accordance with section 202 of Public
2 Law 98–92, these funds shall be available only if the Sec-
3 retary determines the existence of excess commodities.

4 For purchases of commodities to carry out the Emer-
5 gency Food Assistance Act of 1983, as amended,
6 \$80,000,000.

7 FOOD PROGRAM ADMINISTRATION

8 For necessary administrative expenses of the domes-
9 tic food programs funded under this Act, \$107,767,000;
10 of which \$5,000,000 shall be available only for simplifying
11 procedures, reducing overhead costs, tightening regula-
12 tions, improving food stamp coupon handling, and assist-
13 ance in the prevention, identification, and prosecution of
14 fraud and other violations of law: *Provided*, That this ap-
15 propriation shall be available for employment pursuant to
16 the second sentence of section 706(a) of the Organic Act
17 of 1944 (7 U.S.C. 2225), and not to exceed \$150,000 shall
18 be available for employment under 5 U.S.C. 3109.

19 **TITLE V—FOREIGN ASSISTANCE AND**
20 **RELATED PROGRAMS**

21 FOREIGN AGRICULTURAL SERVICE

22 (INCLUDING TRANSFERS OF FUNDS)

23 For necessary expenses of the Foreign Agricultural
24 Service, including carrying out title VI of the Agricultural
25 Act of 1954, as amended (7 U.S.C. 1761–1768), market

1 development activities abroad, and for enabling the Sec-
2 retary to coordinate and integrate activities of the Depart-
3 ment in connection with foreign agricultural work, includ-
4 ing not to exceed \$128,000 for representation allowances
5 and for expenses pursuant to section 8 of the Act approved
6 August 3, 1956 (7 U.S.C. 1766), \$117,812,000: *Provided*,
7 That this appropriation shall be available to obtain statis-
8 tics and related facts on foreign production and full and
9 complete information on methods used by other countries
10 to move farm commodities in world trade on a competitive
11 basis: *Provided further*, That in addition, funds available
12 to the Department of Agriculture shall be available to as-
13 sist an international organization in meeting the costs, in-
14 cluding salaries, fringe benefits and other associated costs,
15 related to the employment by the organization of Federal
16 personnel that may transfer to the organization under the
17 provisions of 5 U.S.C. 3581–3584, or of other well-quali-
18 fied United States citizens, for the performance of activi-
19 ties that contribute to increased understanding of inter-
20 national agricultural issues, with transfer of funds for this
21 purpose from one appropriation to another or to a single
22 account authorized, such funds remaining available until
23 expended: *Provided further*, That the Office may utilize ad-
24 vances of funds, or reimburse this appropriation for ex-
25 penditures made on behalf of Federal agencies, public and

1 private organizations and institutions under agreements
2 executed pursuant to the agricultural food production as-
3 sistance programs (7 U.S.C. 1736) and the foreign assist-
4 ance programs of the International Development Coopera-
5 tion Administration (22 U.S.C. 2392).

6 None of the funds in the foregoing paragraph shall
7 be available to promote the sale or export of tobacco or
8 tobacco products.

9 GENERAL SALES MANAGER

10 (INCLUDING TRANSFERS OF FUNDS)

11 For necessary expenses of the Office of the General
12 Sales Manager, \$9,158,000, of which \$4,866,000 may be
13 transferred from Commodity Credit Corporation funds,
14 \$2,792,000 may be transferred from the Commodity Cred-
15 it Corporation Program Account in this Act, and
16 \$1,500,000 may be transferred from the Public Law 480
17 Program Account in this Act. The General Sales Manager
18 shall obtain, assimilate, and analyze all available informa-
19 tion on developments related to private sales, as well as
20 those funded by the Corporation, including grade and
21 quality as sold and as delivered, including information re-
22 lating to the effectiveness of greater reliance by the Gen-
23 eral Sales Manager upon loan guarantees as contrasted
24 to direct loans for financing commercial export sales of
25 agricultural commodities out of private stocks on credit
26 terms, as provided in titles I and II of the Agricultural

1 Trade Act of 1978, Public Law 95–501, and shall submit
2 quarterly reports to the appropriate committees of Con-
3 gress concerning such developments.

4 None of the funds in the foregoing paragraph shall
5 be available to promote the sale or export of tobacco or
6 tobacco products.

7 PUBLIC LAW 480 PROGRAM ACCOUNT

8 (INCLUDING TRANSFERS OF FUNDS)

9 For expenses during the current fiscal year, not oth-
10 erwise recoverable, and unrecovered prior years' costs, in-
11 cluding interest thereon, under the Agricultural Trade De-
12 velopment and Assistance Act of 1954, as amended (7
13 U.S.C. 1691, 1701–1715, 1721–1726, 1727–1727f,
14 1731–1736g), as follows: (1) \$450,446,000 for Public
15 Law 480 title I credit, including Food for Progress credit;
16 (2) \$45,927,000 is hereby appropriated for ocean freight
17 differential costs for the shipment of agricultural commod-
18 ities pursuant to title I of said Act and the Food for
19 Progress Act of 1985, as amended; (3) \$821,570,000 is
20 hereby appropriated for commodities supplied in connec-
21 tion with dispositions abroad pursuant to title II of said
22 Act; and (4) \$280,083,000 is hereby appropriated for
23 commodities supplied in connection with dispositions
24 abroad pursuant to title III of said Act: *Provided*, That
25 not to exceed 10 per centum of the funds made available

1 to carry out any title of said Act may be used to carry
2 out any other title of said Act: *Provided further*, That such
3 sums shall remain available until expended (7 U.S.C.
4 2209b).

5 For the cost, as defined in section 502 of the Con-
6 gressional Budget Act of 1974, of direct credit agreements
7 as authorized by the Agricultural Trade Development and
8 Assistance Act of 1954, as amended, and the Food for
9 Progress Act of 1985, as amended, including the cost of
10 modifying credit agreements under said Act,
11 \$346,889,000.

12 In addition, for administrative expenses to carry out
13 the Public Law 480 title I credit program, and the Food
14 for Progress Act of 1985, as amended, to the extent funds
15 appropriated for Public Law 480 are utilized, \$2,536,000.

16 SHORT-TERM EXPORT CREDIT

17 The Commodity Credit Corporation shall make avail-
18 able not less than \$5,000,000,000 in credit guarantees
19 under its export credit guarantee program for short-term
20 credit extended to finance the export sales of United
21 States agricultural commodities and the products thereof,
22 as authorized by section 211(b)(1) of the Agricultural
23 Trade Act of 1978 (7 U.S.C. 5641).

24 INTERMEDIATE EXPORT CREDIT

25 The Commodity Credit Corporation shall make avail-
26 able not less than \$500,000,000 in credit guarantees

1 under its export guarantee program for intermediate-term
2 credit extended to finance the export sales of United
3 States agricultural commodities and the products thereof,
4 as authorized by section 211(b)(2) of the Agricultural
5 Trade Act of 1978 (7 U.S.C. 5641).

6 EMERGING DEMOCRACIES EXPORT CREDIT

7 The Commodity Credit Corporation shall make avail-
8 able not less than \$200,000,000 in credit guarantees
9 under its Export Guarantee Program for credit expended
10 to finance the export sales of United States agricultural
11 commodities and the products thereof to emerging democ-
12 racies, as authorized by section 1542 of Public Law 101–
13 624 (7 U.S.C. 5622 note).

14 COMMODITY CREDIT CORPORATION EXPORT LOANS

15 PROGRAM ACCOUNT

16 (INCLUDING TRANSFERS OF FUNDS)

17 For administrative expenses to carry out CCC's Ex-
18 port Guarantee Program, GSM 102 and GSM 103,
19 \$3,381,000; to cover common overhead expenses as per-
20 mitted by section 11 of the Commodity Credit Corporation
21 Charter Act and in conformity with the Federal Credit Re-
22 form Act of 1990, of which not to exceed \$2,792,000 may
23 be transferred to and merged with the appropriation for
24 the salaries and expenses of the General Sales Manager,
25 and of which not to exceed \$589,000 may be transferred
26 to and merged with the appropriation for the salaries and

1 expenses of the Agricultural Stabilization and Conserva-
2 tion Service.

3 SCIENTIFIC ACTIVITIES OVERSEAS (FOREIGN CURRENCY
4 PROGRAM)
5 LIMITATION ON EXPENSES

6 For payments in foreign currencies owed to or owned
7 by the United States for research activities authorized by
8 section 104(c)(7) of the Agricultural Trade Development
9 and Assistance Act of 1954, as amended (7 U.S.C.
10 1704(c)(7)), not to exceed \$1,062,000: *Provided*, That not
11 to exceed \$25,000 of these funds shall be available for pay-
12 ments in foreign currencies for expenses of employment
13 pursuant to the second sentence of section 706(a) of the
14 Organic Act of 1944 (7 U.S.C. 2225), as amended by 5
15 U.S.C. 3109.

16 **TITLE VI—RELATED AGENCIES AND FOOD**
17 **AND DRUG ADMINISTRATION**

18 DEPARTMENT OF HEALTH AND HUMAN
19 SERVICES

20 FOOD AND DRUG ADMINISTRATION
21 SALARIES AND EXPENSES

22 For necessary expenses of the Food and Drug Ad-
23 ministration, including hire and purchase of passenger
24 motor vehicles; for rental of special purpose space in the
25 District of Columbia or elsewhere; and for miscellaneous
26 and emergency expenses of enforcement activities, author-

1 ized and approved by the Secretary and to be accounted
2 for solely on the Secretary's certificate, not to exceed
3 \$25,000; \$867,339,000, of which not to exceed
4 \$54,000,000 in fees pursuant to section 736 of the Fed-
5 eral Food, Drug, and Cosmetic Act may be credited to
6 this appropriation and remain available until expended:
7 *Provided*, That fees derived from applications received
8 during fiscal year 1994 shall be subject to the fiscal year
9 1994 limitation: *Provided further*, That none of these
10 funds shall be used to develop, establish, or operate any
11 program of user fees authorized by 31 U.S.C. 9701: *Pro-*
12 *vided further*, That none of the funds in this Act may be
13 used to pay for expenses of the Board of Experts on Tea.

14 BUILDINGS AND FACILITIES

15 For plans, construction, repair, improvement, exten-
16 sion, alteration, and purchase of fixed equipment or facili-
17 ties of or used by the Food and Drug Administration,
18 where not otherwise provided, \$8,350,000, to remain
19 available until expended (7 U.S.C. 2209b): *Provided*, That
20 the Food and Drug Administration may accept donated
21 land in Montgomery and/or Prince George's Counties,
22 Maryland.

23 RENTAL PAYMENTS (FDA)

24 (INCLUDING TRANSFERS OF FUNDS)

25 For payment of space rental and related costs pursu-
26 ant to Public Law 92-313 for programs and activities of

1 the Food and Drug Administration which are included in
2 this Act, \$48,575,000, of which \$15,000,000 shall be re-
3 tained by the Food and Drug Administration for repairs,
4 improvements, and non-recurring repairs as determined by
5 the Food and Drug Administration: *Provided*, That in the
6 event the Food and Drug Administration should require
7 modification of space needs, a share of the salaries and
8 expenses appropriation may be transferred to this appro-
9 priation, or a share of this appropriation may be trans-
10 ferred to the salaries and expenses appropriation, but such
11 transfers shall not exceed 5 per centum of the funds made
12 available for rental payments (FDA) to or from this
13 account.

14 DEPARTMENT OF THE TREASURY

15 FINANCIAL MANAGEMENT SERVICE

16 PAYMENTS TO THE FARM CREDIT SYSTEM FINANCIAL
17 ASSISTANCE CORPORATION

18 For necessary payments to the Farm Credit System
19 Financial Assistance Corporation by the Secretary of the
20 Treasury, as authorized by section 6.28(c) of the Farm
21 Credit Act of 1971, as amended, for reimbursement of in-
22 terest expenses incurred by the Financial Assistance Cor-
23 poration on obligations issued through 1993, as author-
24 ized, \$62,696,000.

1 INDEPENDENT AGENCIES

2 COMMODITY FUTURES TRADING COMMISSION

3 For necessary expenses to carry out the provisions
4 of the Commodity Exchange Act, as amended (7 U.S.C.
5 1 et seq.), including the purchase and hire of passenger
6 motor vehicles; the rental of space (to include multiple
7 year leases) in the District of Columbia and elsewhere; and
8 not to exceed \$25,000 for employment under 5 U.S.C.
9 3109; \$47,485,000, including not to exceed \$700 for offi-
10 cial reception and representation expenses.

11 FARM CREDIT ADMINISTRATION

12 LIMITATION ON ADMINISTRATIVE EXPENSES

13 Not to exceed \$40,426,000 (from assessments col-
14 lected from farm credit institutions and from the Federal
15 Agricultural Mortgage Corporation) shall be obligated
16 during the current fiscal year for administrative expenses
17 as authorized under 12 U.S.C. 2249.

18 **TITLE VII—GENERAL PROVISIONS**

19 SEC. 701. Within the unit limit of cost fixed by law,
20 appropriations and authorizations made for the Depart-
21 ment of Agriculture for the fiscal year 1994 under this
22 Act shall be available for the purchase, in addition to those
23 specifically provided for, of not to exceed 657 passenger
24 motor vehicles, of which 653 shall be for replacement only,
25 and for the hire of such vehicles.

1 SEC. 702. Funds in this Act available to the Depart-
2 ment of Agriculture shall be available for uniforms or al-
3 lowances therefor as authorized by law (5 U.S.C. 5901–
4 5902).

5 SEC. 703. Not less than \$1,500,000 of the appropria-
6 tions of the Department of Agriculture in this Act for re-
7 search and service work authorized by the Acts of August
8 14, 1946, and July 28, 1954, and (7 U.S.C. 427, 1621–
9 1629), and by chapter 63 of title 31, United States Code,
10 shall be available for contracting in accordance with said
11 Acts and chapter.

12 SEC. 704. No part of the funds contained in this Act
13 may be used to make production or other payments to a
14 person, persons, or corporations upon a final finding by
15 court of competent jurisdiction that such party is guilty
16 of growing, cultivating, harvesting, processing or storing
17 marijuana, or other such prohibited drug-producing plants
18 on any part of lands owned or controlled by such persons
19 or corporations.

20 SEC. 705. The cumulative total of transfers to the
21 Working Capital Fund for the purpose of accumulating
22 growth capital for data services and National Finance
23 Center operations shall not exceed \$2,000,000: *Provided*,
24 That no funds in this Act appropriated to an agency of
25 the Department shall be transferred to the Working Cap-

1 ital Fund without the approval of the agency adminis-
2 trator.

3 SEC. 706. New obligational authority provided for the
4 following appropriation items in this Act shall remain
5 available until expended (7 U.S.C. 2209b): Animal and
6 Plant Health Inspection Service, the contingency fund to
7 meet emergency conditions, and Integrated Systems Ac-
8 quisition Project; Agricultural Stabilization and Conserva-
9 tion Service, salaries and expenses funds made available
10 to county committees; Foreign Agricultural Service, Mid-
11 dle-Income Country Training Program; higher education
12 graduate fellowships grants under section 1417(b)(6) of
13 the National Agricultural Research, Extension, and
14 Teaching Policy Act of 1977, as amended (7 U.S.C.
15 3152(b)(6)); and capacity building grants to colleges eligi-
16 ble to receive funds under the Act of August 30, 1890,
17 including Tuskegee University.

18 New obligational authority for the Boll Weevil Pro-
19 gram; up to 10 per centum of the Screwworm Program
20 of the Animal and Plant Health Inspection Service; funds
21 appropriated for Rental Payments; and higher education
22 minority scholars programs under section 1417(b)(5) of
23 the National Agricultural Research, Extension, and
24 Teaching Policy Act of 1977, as amended (7 U.S.C.
25 3152(b)(5)) shall remain available until expended.

1 SEC. 707. No part of any appropriation contained in
2 this Act shall remain available for obligation beyond the
3 current fiscal year unless expressly so provided herein.

4 SEC. 708. Not to exceed \$50,000 of the appropria-
5 tions available to the Department of Agriculture in this
6 Act shall be available to provide appropriate orientation
7 and language training pursuant to Public Law 94-449.

8 SEC. 709. No funds appropriated by this Act may be
9 used to pay negotiated indirect cost rates on cooperative
10 agreements or similar arrangements between the United
11 States Department of Agriculture and nonprofit institu-
12 tions in excess of 10 per centum of the total direct cost
13 of the agreement when the purpose of such cooperative
14 arrangements is to carry out programs of mutual interest
15 between the two parties. This does not preclude appro-
16 priate payment of indirect costs on grants and contracts
17 with such institutions when such indirect costs are com-
18 puted on a similar basis for all agencies for which appro-
19 priations are provided in this Act.

20 SEC. 710. Notwithstanding any other provision of
21 this Act, commodities acquired by the Department in con-
22 nection with Commodity Credit Corporation and section
23 32 price support operations may be used, as authorized
24 by law (15 U.S.C. 714c and 7 U.S.C. 612c), to provide

1 commodities to individuals in cases of hardship as deter-
2 mined by the Secretary of Agriculture.

3 SEC. 711. None of the funds in this Act shall be avail-
4 able to reimburse the General Services Administration for
5 payment of space rental and related costs in excess of the
6 amounts specified in this Act; nor shall this or any other
7 provision of law require a reduction in the level of rental
8 space or services below that of fiscal year 1993 or prohibit
9 an expansion of rental space or services with the use of
10 funds otherwise appropriated in this Act. Further, no
11 agency of the Department of Agriculture, from funds oth-
12 erwise available, shall reimburse the General Services Ad-
13 ministration for payment of space rental and related costs
14 provided to such agency at a percentage rate which is
15 greater than is available in the case of funds appropriated
16 in this Act.

17 SEC. 712. None of the funds provided in this Act may
18 be used to reduce programs by establishing an end-of-year
19 employment ceiling on full-time equivalent staff years
20 below the level set herein for the following agencies: Food
21 and Drug Administration, 9,824; Farmers Home Adminis-
22 tration, 12,225; Agricultural Stabilization and Conserva-
23 tion Service, 2,550; Rural Electrification Administration,
24 550; and Soil Conservation Service, 14,177.

1 SEC. 713. Funds appropriated by this Act shall be
2 applied only to the objects for which appropriations were
3 made except as otherwise provided by law, as required by
4 31 U.S.C. 1301.

5 SEC. 714. None of the funds in this Act shall be avail-
6 able to restrict the authority of the Commodity Credit
7 Corporation to lease space for its own use or to lease space
8 on behalf of other agencies of the Department of Agri-
9 culture when such space will be jointly occupied.

10 SEC. 715. None of the funds provided in this Act may
11 be expended to release information acquired from any han-
12 dler under the Agricultural Marketing Agreement Act of
13 1937, as amended: *Provided*, That this provision shall not
14 prohibit the release of information to other Federal agen-
15 cies for enforcement purposes: *Provided further*, That this
16 provision shall not prohibit the release of aggregate statis-
17 tical data used in formulating regulations pursuant to the
18 Agricultural Marketing Agreement Act of 1937, as amend-
19 ed: *Provided further*, That this provision shall not prohibit
20 the release of information submitted by milk handlers.

21 SEC. 716. Unless otherwise provided in this Act, none
22 of the funds appropriated or otherwise made available in
23 this Act may be used by the Farmers Home Administra-
24 tion to employ or otherwise contract with private debt col-

1 lection agencies to collect delinquent payments from
2 Farmers Home Administration borrowers.

3 SEC. 717. None of the funds in this Act, or otherwise
4 made available by this Act, shall be used to sell loans made
5 by the Agricultural Credit Insurance Fund. Further,
6 Rural Development Insurance Fund loans offered for sale
7 in fiscal year 1994 shall be first offered to the borrowers
8 for prepayment.

9 SEC. 718. None of the funds in this Act may be used
10 to establish any new office, organization, or center for
11 which funds have not been provided in advance in Appro-
12 priations Acts, except the Department may carry out plan-
13 ning activities.

14 SEC. 719. None of the funds in this Act shall be avail-
15 able to pay indirect costs on research grants awarded com-
16 petitively by the Cooperative State Research Service that
17 exceed 14 per centum of total Federal funds provided
18 under each award.

19 SEC. 720. Appropriations to the Department of Agri-
20 culture for the cost of direct and guaranteed loans made
21 available in fiscal years 1992, 1993, and 1994 shall re-
22 main available until expended to cover obligations made
23 in fiscal years 1992, 1993, and 1994 for the following ac-
24 counts: Rural Development Insurance Fund Program Ac-
25 count; the Rural Telephone Bank Program Account; the

1 Rural Electrification and Telephone Loans Program Ac-
2 count; and the Rural Economic Development Loans Pro-
3 gram Account.

4 SEC. 721. Notwithstanding any other provisions of
5 this Act, all loan levels provided in this Act shall be consid-
6 ered estimates, not limitations.

7 SEC. 722. Notwithstanding any other provision of
8 this Act, none of the funds in this Act may be used to
9 operate the seven regional offices of the Rural Develop-
10 ment Administration after April 1, 1994.

11 SEC. 723. None of the funds appropriated or other-
12 wise made available by this Act shall be used to pay the
13 salaries of personnel who carry out a Market Promotion
14 Program pursuant to section 203 (7 U.S.C. 5623) of the
15 Agricultural Trade Act of 1978, with respect to tobacco
16 or if the aggregate amount of funds and/or commodities
17 under such program exceeds \$147,734,000.

18 SEC. 724. None of the funds appropriated or other-
19 wise made available by this Act shall be used to enroll
20 in excess of 50,000 acres in the fiscal year 1994 Wetlands
21 Reserve Program, as authorized by 16 U.S.C. 3837.

22 SEC. 725. None of the funds appropriated or other-
23 wise made available by this Act shall be used to enroll
24 additional acres in the Conservation Reserve Program au-
25 thorized by 16 U.S.C. 3831–3845.

1 SEC. 726. Such sums as may be necessary for fiscal
2 year 1994 pay raises for programs funded by this Act shall
3 be absorbed within the levels appropriated in this Act.

4 This Act may be cited as the “Agriculture, Rural De-
5 velopment, Food and Drug Administration, and Related
6 Agencies Appropriations Act, 1994”.
