## AN ACT

To extend certain programs relating to housing and  
community development, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Housing Programs  
5        Extension Act of 1993”.

1 **SEC. 2. NATIONAL COMMISSION ON MANUFACTURED HOUS-**  
2 **ING.**

3 (a) EXTENSION OF COMMISSION.—Section 943(g) of  
4 the Cranston-Gonzalez National Affordable Housing Act  
5 (Public Law 101–625; 104 Stat. 4415) is amended by  
6 striking “on October 1, 1993” and inserting “at the end  
7 of September 30, 1994”.

8 (b) FINAL REPORT.—Section 943(d)(2) of the Cran-  
9 ston-Gonzalez National Affordable Housing Act (Public  
10 Law 101–625; 104 Stat. 4414) is amended by striking  
11 “9 months after the Commission is established pursuant  
12 to subsection (b)” and inserting “August 1, 1994”.

13 (c) INTERIM REPORT.—Section 943(d) of the Cran-  
14 ston-Gonzalez National Affordable Housing Act (Public  
15 Law 101–625; 104 Stat. 4414) is amended—

16 (1) by redesignating paragraph (2) (as amend-  
17 ed by subsection (b) of this section) as paragraph  
18 (3); and

19 (2) by inserting after paragraph (1) the follow-  
20 ing new paragraph:

21 “(2) INTERIM REPORT.—Not later than March  
22 1, 1994, the Commission shall submit an interim re-  
23 port to the Secretary of Housing and Urban Devel-  
24 opment and the Congress. The report shall describe  
25 the activities of the Commission under paragraph  
26 (1) and shall contain any information specified in

1 such paragraph that is available to the Commission  
2 and any evaluations and recommendations specified  
3 in such paragraph that may be made by the Com-  
4 mission, at such time.”.

5 (d) AUTHORIZATION OF APPROPRIATIONS.—Section  
6 943(f) of the Cranston-Gonzalez National Affordable  
7 Housing Act (Public Law 101–625; 104 Stat. 4415) is  
8 amended by inserting after the first sentence the following  
9 new sentence: “There are authorized to be appropriated  
10 for fiscal year 1994 such sums as may be necessary to  
11 carry out this section.”.

12 **SEC. 3. RECIPROCITY IN APPROVAL OF HOUSING SUBDIVI-**  
13 **SIONS AMONG FEDERAL AGENCIES.**

14 (a) EXTENSION OF AUTHORITY.—Section 535(b) of  
15 the Housing Act of 1949 (42 U.S.C. 1490o(b)) is amended  
16 by striking “June 15, 1993” and inserting “September  
17 30, 1994”.

18 (b) RETROACTIVITY.—Any administrative approval of  
19 any housing subdivision made after June 15, 1993, and  
20 before the date of the enactment of this Act is approved  
21 and shall be considered to have been lawfully made, but  
22 only if otherwise made in accordance with the provisions  
23 of section 535(b) of the Housing Act of 1949.

1 **SEC. 4. FHA INSURANCE AUTHORITY.**

2 Section 531(b) of the National Housing Act (12  
3 U.S.C. 1735f-9(b)) is amended by striking  
4 “\$65,905,824,960” and inserting “\$92,146,000,000”.

5 **SEC. 5. GNMA GUARANTEE AUTHORITY.**

6 Section 306(g)(2) of the National Housing Act (12  
7 U.S.C. 1721(g)(2)) is amended by striking  
8 “\$88,000,000,000” and inserting “\$107,700,000,000”.
