14 *available until expended, may be transferred to and merged*  
15 *with the appropriations for “Salaries and Expenses”, and*  
16 *of which \$20,000,000 shall be available only to the extent*  
17 *an official budget request for a specific dollar amount, that*  
18 *includes designation of the entire amount of the request as*  
19 *an emergency requirement as defined in the Balanced*  
20 *Budget and Emergency Deficit Control Act of 1985, as*  
21 *amended, is transmitted by the President to the Congress:*  
22 *Provided further, That notwithstanding any other provision*  
23 *of law, the \$500,000 limitation on the amounts outstanding*  
24 *and committed to a borrower provided in paragraph 7(c)(6)*

1 *of the Small Business Act shall be increased to \$1,500,000*  
 2 *for disasters commencing on or after April 1, 1993.*

9 *floods in the Midwest, to remain available until September*  
10 *30, 1994,*
