## A BILL

To amend the Public Buildings Act of 1959 concerning the calculation of public building transactions.

1       *Be it enacted by the Senate and House of Representa-*  
 2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. PUBLIC BUILDING TRANSACTIONS.**

4       Section 7 of the Public Buildings Act of 1959 (40  
 5 U.S.C. 606) is amended by adding at the end the following  
 6 new subsection:

7       “(g) CALCULATION OF TRANSACTIONS.—For pur-  
 8 poses of calculating public building transactions, any con-  
 9 tract entered into by the Administrator under this Act for  
 10 the purchase, lease-purchase, or lease of a public building  
 11 approved pursuant to subsection (a) shall be treated in  
 12 the same manner as if the contract was entered into imme-  
 13 diately prior to fiscal year 1991.”.

1 **SECTION 1. PUBLIC BUILDING TRANSACTIONS.**

2 *Section 7 of the Public Buildings Act of 1959 (40*  
3 *U.S.C. 606) is amended by adding at the end the following*  
4 *new subsections:*

5 *“(g) CALCULATION OF TRANSACTIONS.—For purposes*  
6 *of the Balanced Budget and Emergency Deficit Control Act*  
7 *of 1985, the Congressional Budget Act of 1974, the Budget*  
8 *Enforcement Act of 1990, and scorekeeping guidelines, the*  
9 *Office of Management and Budget and the Congressional*  
10 *Budget Office shall score any contract entered into by the*  
11 *Administrator under this Act for the purchase, lease-pur-*  
12 *chase, or lease of any building and its site in the same man-*  
13 *ner as if the contract was entered into on September 30,*  
14 *1990.*

15 *“(h) LEASES.—The Administrator is authorized to*  
16 *enter into contracts for the lease-purchase or lease of any*  
17 *building and its site for periods of not to exceed 30 years.”.*
