AMENDMENTS

Resolved, That the bill from the House of Representatives (H.R. 2921) entitled “An Act to authorize appropriations for the preservation and restoration of historic buildings at historically black colleges and universities” do pass with the following

3 *(a) AUTHORITY TO MAKE GRANTS.—The Secretary of*
4 *the Interior shall administer a program of grants-in-aid*
5 *in accordance with this section to eligible historically black*
6 *colleges and universities for the preservation and restora-*
7 *tion of historic buildings and structures on the campuses*
8 *of these institutions. Such grants shall be made, subject to*
9 *the availability of appropriations therefore, from the*
10 *amounts authorized to be appropriated to carry out the Na-*
11 *tional Historic Preservation Act for the fiscal years 1995*
12 *through 1998.*

13 **(7)**Page 4, after line 23, insert:

14 *(4) If less than \$20,000,000 is made available in fiscal*
15 *year 1995 for the purpose of paragraph (1), such amount*
16 *shall be allocated as follows:*

17 *(A) 25 percent of such amount shall be made*
18 *available for grants to Fisk University as provided in*
19 *paragraph (2).*

20 *(B) 50 percent of such amount shall be made*
21 *available as provided in paragraphs (3).*

22 *(C) 25 percent of such amount shall be made*
23 *available for grants under subsection (a) to other eli-*
24 *gible historically black colleges and universities.*

7 **SEC. 201. AUTHORITY TO MAKE GRANTS.**

8 *The Secretary of the Interior (hereinafter in this title*
9 *referred to as the “Secretary”) is authorized to make grants*
10 *in accordance with this title to preserve and restore Cooper*
11 *Hall at Sterling College located in Sterling, Kansas and*
12 *Science Hall at Simpson College located in Indianola,*
13 *Iowa. Such grants shall be made, subject to the availability*
14 *of appropriations therefore, from the amounts authorized*
15 *to be appropriated to carry out the National Historic Pres-*
16 *ervation Act.*

17 **SEC. 202. MATCHING REQUIREMENT.**

18 *The Secretary may obligate funds made available*
19 *under this title only if the grantee agrees to match, from*
20 *funds derived from non-Federal sources, the amount of the*
21 *grant with an amount that is equal or greater than the*
22 *grant.*

23 **SEC. 203. FUNDING PROVISIONS.**

24 *Not more than \$3,600,000 may be made available for*
25 *grants for Cooper Hall and not more than \$1,500,000 may*

- 1 *be made available for grants for Science Hall under this*
- 2 *title.*
