1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Juvenile Justice and
5 Delinquency Prevention Act Technical Amendments of
6 1993”.

7 **SEC. 2. AMENDMENTS TO THE JUVENILE JUSTICE AND DE-**
8 **LINQUENCY PREVENTION ACT OF 1974.**

9 The Juvenile Justice and Delinquency Prevention Act
10 of 1974 (42 U.S.C. 5601–5785) is amended—

11 (1) in section 103—

12 (A) in paragraph (4) by inserting “title I
13 of” before “the Omnibus” each place it ap-
14 pears, and

1 (B) in paragraph (22) by redesignating
2 subparagraphs (i), (ii), and (iii) as subpara-
3 graphs (A), (B), and (C), respectively,

4 (2) in section 202(b) by striking “prescribed for
5 GS—18 of the General Schedule by section 5332”
6 and inserting “payable under section 5376”,

7 (3) in section 204 by redesignating subsections
8 (h) and (i) as subsections (f) and (g), respectively,

9 (4) in section 206(a)(2)—

10 (A) in subparagraph (A) by adding at the
11 end the following: “Except as provided in sub-
12 paragraph (C), all members shall be appointed
13 for a term of 3 years.”, and

14 (B) in subparagraph (C)(i) by striking
15 “appointed” the first place it appears and in-
16 serting “first appointed to the Council”,

17 (5) in section 223—

18 (A) in subsection (a)(14) by striking “, be-
19 ginning after the five-year period following De-
20 cember 8, 1980,”,

21 (B) in subsection (c)(3)—

22 (i) in the matter preceding subpara-
23 graph (A) by striking “the requirements of
24 subsection (a), (12)(A), (13), (14), or
25 (23)” and inserting “any requirement of

1 paragraph (12)(A), (13), (14), or (23) of
2 subsection (a)”, and

3 (ii) in subparagraph (B)(i) by striking
4 “section 222 (c) and (d)” and inserting
5 “subsections (c) and (d) of section 222”,
6 and

7 (C) in subsection (d) by striking “sub-
8 section (a) (12)(A), (13), (14) and (23)” each
9 place it appears and inserting “paragraphs
10 (12)(A), (13), (14), and (23) of subsection (a)”,
11 (6) in section 241(d)(2)—

12 (A) by inserting a comma after “person-
13 nel” the first place it appears, and

14 (B) by striking “personnel,,” and inserting
15 “personnel,”,

16 (7) in section 243(a)—

17 (A) in paragraph (3) by redesignating sub-
18 paragraphs (i) and (ii) as subparagraphs (A)
19 and (B), respectively,

20 (B) in paragraph (7)(D) by inserting “ac-
21 tivities)” after “recreational”,

22 (C) in paragraph (11) by striking “and” at
23 the end,

1 (D) by redesignating paragraphs (6)
2 through (14) as paragraphs (7) through (15),
3 respectively, and

4 (E) by redesignating the second paragraph
5 (5) as paragraph (6),
6 (8) in section 244(3)—

7 (A) by inserting a comma after “judges”,

8 (B) by inserting a comma after “prosecu-
9 tors”, and

10 (C) by striking “attorneys,,” and inserting
11 “attorneys,”,

12 (9) in section 248(a)(2)(B)(ii) by striking “for”
13 and inserting “For”,

14 (10) in section 261(a)—

15 (A) in paragraph (5)—

16 (i) by inserting “(including self-help
17 programs for parents)” after “programs”,
18 and

19 (ii) by inserting before the period at
20 the end the following:

21 “, including programs that work with families dur-
22 ing the incarceration of juvenile family members and
23 that take into consideration the special needs of
24 families with limited-English speaking ability”, and

1 (B) in paragraph (7) by striking “juve-
2 niles,” and all that follows through the end of
3 such paragraph, and inserting the following:

4 “juveniles;

5 “that targets juveniles who have had contact with
6 the juvenile justice system or who are likely to have
7 contact with such system.”,

8 (11) in section 261(b)(5) by inserting “, com-
9 munity service personnel,” after “law enforcement
10 personnel”,

11 (12) in section 281(a)(8) by striking “sub-
12 stances analogues” and inserting “substance ana-
13 logues”,

14 (13) in subpart II of part D by inserting before
15 section 282 the following:

16 “AUTHORITY TO MAKE GRANTS AND CONTRACTS”,

17 (14) in the first part I by inserting the follow-
18 ing before section 291:

19 “AUTHORITY TO CALL AND CONDUCT CONFERENCE”,

20 (15) in section 291(c) by striking “18 months”
21 and inserting “48 months”,

22 (16) by redesignating the second part I as
23 part J,

24 (17) in section 299(a)—

25 (A) in paragraph (1) by striking “years
26 1993,” and inserting “fiscal year 1993 and

1 such sums as may be necessary for fiscal
2 years”,

3 (B) in paragraph (2)(A) by moving the left
4 margin of clauses (i) and (ii) 2 ems to the left,
5 and

6 (C) in paragraph (5) by striking “(A) Sub-
7 ject to subparagraph (B)” and inserting “Sub-
8 ject to paragraph (2)(B)”, and

9 (18) in section 299C(c)(2) by striking “this
10 paragraph” and inserting “paragraph (1)”.

11 **SEC. 3. EFFECTIVE DATES.**

12 (a) GENERAL EFFECTIVE DATE.—Except as pro-
13 vided in subsection (b), this Act and the amendments
14 made by this Act shall take effect on the date of the enact-
15 ment of this Act.

16 (b) SPECIAL EFFECTIVE DATE.—The amendments
17 made by section 2(4) shall take effect on November 4,
18 1992.
