Mr. SAWYER (for himself, Mr. MYERS of Indiana, and Mr. PETRI) introduced the following bill; which was referred to the Committee on Post Office and Civil Service

A BILL

To provide that the provisions of chapters 83 and 84 of title 5, United States Code, relating to reemployed annuitants shall not apply with respect to postal retirees who are reemployed, on a temporary basis, to serve as rural letter carriers or rural postmasters.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXCLUSION FROM PROVISIONS RELATING TO**
4 **REEMPLOYED ANNUITANTS.**

5 (a) CIVIL SERVICE RETIREMENT SYSTEM.—Section
6 8344 of title 5, United States Code, is amended by adding
7 at the end the following:

1 “(m)(1) For the purpose of this subsection—

2 “(A) the term ‘postal annuitant’ means any in-
3 dividual who becomes an annuitant by reason of re-
4 tirement from the United States Postal Service;

5 “(B) the term ‘rural postmaster’ means the
6 postmaster of any post office which provides regular
7 postal services to any rural areas, communities, or
8 small towns; and

9 “(C) the term ‘rural letter carrier’ means an
10 employee of the United States Postal Service occu-
11 pying a position the regular duties of which involve
12 the collection and delivery of mail on a rural route.

13 “(2)(A) Subsections (a) and (b) shall not apply to
14 any postal annuitant receiving an annuity from the Fund
15 while such annuitant is employed by the United States
16 Postal Service, on a temporary basis, as a rural post-
17 master or rural letter carrier, subject to subparagraph
18 (B).

19 “(B) This subsection shall not, in the case of any
20 postal annuitant, have the effect of excluding from the ap-
21 plication of subsections (a) and (b) more than—

22 “(i) 90 days of service in any calendar year; or

23 “(ii) a total of 180 days of service.”.

1 (b) FEDERAL EMPLOYEES' RETIREMENT SYSTEM.—
2 Section 8468 of title 5, United States Code, is amended
3 by adding at the end the following:

4 “(j)(1) For the purpose of this subsection—

5 “(A) the term ‘postal annuitant’ means any in-
6 dividual who becomes an annuitant by reason of re-
7 tirement from the United States Postal Service;

8 “(B) the term ‘rural postmaster’ means the
9 postmaster of any post office which provides regular
10 postal services to any rural areas, communities, or
11 small towns; and

12 “(C) the term ‘rural letter carrier’ means an
13 employee of the United States Postal Service occu-
14 pying a position the regular duties of which involve
15 the collection and delivery of mail on a rural route.

16 “(2)(A) Subsections (a) and (b) shall not apply to
17 any postal annuitant receiving an annuity from the Fund
18 while such annuitant is employed by the United States
19 Postal Service, on a temporary basis, as a rural post-
20 master or rural letter carrier, subject to subparagraph
21 (B).

22 “(B) This subsection shall not, in the case of any
23 postal annuitant, have the effect of excluding from the ap-
24 plication of subsections (a) and (b) more than—

25 “(i) 90 days of service in any calendar year; or

1 “(ii) a total of 180 days of service.”.

2 (c) CLARIFICATION.—Nothing in this section shall have
3 the effect of causing any reemployed annuitant to be treat-
4 ed as an active employee for purposes of any provision
5 of chapter 83 or 84 of title 5, United States Code.

6 **SEC. 2. APPLICABILITY.**

7 This Act and the amendments made by this Act shall
8 apply with respect to temporary appointments commenc-
9 ing on or after the date of the enactment of this Act.
