AN ACT

To redesignate the postal facility located at 1401 West Fort Street, Detroit, Michigan, as the “George W. Young Post Office”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REDESIGNATION.**

4 The postal facility located at 1401 West Fort Street,
5 in Detroit, Michigan, shall be known and designated as
6 the “George W. Young Post Office”.

1 **SEC. 2. REFERENCES.**

2 Any reference in a law, map, regulation, document,
3 paper, or other record of the United States to the postal
4 facility referred to in section 1 shall be deemed to be a
5 reference to the “George W. Young Post Office”.

6 **SEC. 3. PAY ADJUSTMENTS FOR THE CHAIRMAN, MEMBERS,**
7 **AND GENERAL COUNSEL OF THE FEDERAL**
8 **LABOR RELATIONS AUTHORITY.**

9 (a) *IN GENERAL.*—Chapter 53 of title 5, United States
10 Code, is amended—

11 (1) in section 5314 by adding at the end thereof:

12 “Chairman, Federal Labor Relations Author-
13 ity.”;

14 (2) in section 5315 by striking out:

15 “Chairman, Federal Labor Relations Author-
16 ity.”;

17 (3) in section 5315 by adding at the end thereof:

18 “Members, Federal Labor Relations Authority
19 (2) and its General Counsel.”;

20 and

21 (4) in section 5316 by striking out:

22 “Members, Federal Labor Relations Authority
23 (2) and its General Counsel.”.

24 (b) *EFFECTIVE DATE.*—This section shall take effect
25 on the first day of the first applicable pay period beginning
26 on or after the date of the enactment of this Act.

1 **SEC. 4. CLOSING AND CONSOLIDATION OF COMMUNITY**
2 **POST OFFICES.**

3 *Section 404(b)(1) of title 39, United States Code, is*
4 *amended by inserting “(including any community post of-*
5 *fice operated under a contract entered into with the Post-*
6 *master General)” after “consolidation of any post office”.*

Amend the title so as to read: “An Act to redesignate the postal facility located at 1401 West Fort Street, Detroit, Michigan, as the ‘George W. Young Post Office’, to provide for a pay adjustment for the Chairman, Members, and General Counsel of the Federal Labor Relations Authority, to amend chapter 4 of title 39, United States Code, to apply consolidation and closing procedures to community post offices, and for other purposes.”.
