2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REVIVAL AND EXTENSION OF SUSPENSION OF**

4 **DUTY ON CERTAIN CHEMICALS.**

7 United States is amended by striking out “12/31/92” and
8 inserting “12/31/96”:

1 tions 1 through 3 apply, shall, if the entry or withdrawal
2 was made—

3 (1) after December 31, 1992; and

4 (2) before the 15th day after the date of enact-

6 be liquidated or reliquidated as though the applicable
7 amendments made by sections 1 through 3 applied to such
8 liquidation or reliquidation.
