AMENDMENTS

In the Senate of the United States,

September 21 (legislative day, September 12), 1994.

Resolved, That the bill from the House of Representatives (H.R. 3664) entitled “An Act to direct the Secretary of the Interior to convey to the State of Minnesota the New London National Fish Hatchery production facility”, do pass with the following

AMENDMENTS:

1 Page 2, after line 14, insert:

2 ***SEC. 2. CONVEYANCE OF THE FAIRPORT NATIONAL FISH***
3 ***HATCHERY TO THE STATE OF IOWA.***

4 *(a) CONVEYANCE.—The Secretary of the Interior shall*
5 *convey to the State of Iowa, without reimbursement and*
6 *by no later than December 31, 1994, all right, title, and*
7 *interest of the United States in and to the fish hatchery*
8 *described in subsection (b) for use by the State for purposes*
9 *of fishery resources management.*

10 *(b) HATCHERY DESCRIBED.—The fish hatchery de-*
11 *scribed in subsection (a) is the Fairport National Fish*

1 Hatchery located in Muscatine County, Iowa, adjacent to
2 State Highway 22 west of Davenport, Iowa, including all
3 real property, improvements to real property, and personal
4 property.

5 (c) *USE AND REVERSIONARY INTEREST.*—The prop-
6 erty conveyed to the State of Iowa pursuant to this section
7 shall be used by the State for purposes of fishery resources
8 management, and if it is used for any other purpose all
9 right, title, and interest in and to all property conveyed
10 pursuant to this section shall revert to the United States.

11 **SEC. 3. CONVEYANCE OF CORNING NATIONAL FISH HATCH-**
12 **ERY TO THE STATE OF ARKANSAS.**

13 (a) *CONVEYANCE REQUIREMENT.*—The Secretary of
14 the Interior shall convey to the State of Arkansas, without
15 reimbursement and by no later than December 31, 1994,
16 all right, title, and interest of the United States in and to
17 the property described in subsection (b), for use by the Ar-
18 kansas Game and Fish Commission as part of the State
19 of Arkansas fish culture program.

20 (b) *PROPERTY DESCRIBED.*—The property referred to
21 in subsection (a) is the property known as the Corning Na-
22 tional Fish Hatchery (popularly known as the William H.
23 Donham State Fish Hatchery), located one mile west of
24 Corning, Arkansas, on Arkansas State Highway 67 in Clay
25 County, Arkansas, consisting of 137.34 acres (more or less),

1 *and all improvements and related personal property under*
2 *the control of the Secretary that is located on that property,*
3 *including buildings, structures, and equipment.*

4 (c) *REVERSIONARY INTEREST OF UNITED STATES.—*
5 *All right, title, and interest in property described in sub-*
6 *section (b) shall revert to the United States if the property*
7 *ceases to be used as part of the State of Arkansas fish cul-*
8 *ture program. The State of Arkansas shall ensure that the*
9 *property reverting to the United States is in substantially*
10 *the same or better condition as at the time of transfer.*

Amend the title so as to read: “An Act to direct the Secretary of the Interior to transfer certain national fish hatcheries.”.
