AN ACT

To direct the Secretary of the Interior to convey to the State of Minnesota the New London National Fish Hatchery production facility.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CONVEYANCE OF NEW LONDON NATIONAL**
4 **FISH HATCHERY PRODUCTION FACILITY.**

5 (a) CONVEYANCE AUTHORIZED.—Notwithstanding
6 any other provision of law and within 180 days after the
7 date of the enactment of this Act, the Secretary of the

1 Interior shall convey to the State of Minnesota without
2 reimbursement all right, title, and interest of the United
3 States in and to the property comprising the New London
4 National Fish Hatchery production facility, located out-
5 side of downtown New London, Minnesota, including—

6 (1) all easements and water rights relating to
7 that property, and

8 (2) all land, improvements, and related personal
9 property comprising that production facility.

10 (b) USE OF PROPERTY.—All property and interests
11 conveyed under this section shall be used by the Minnesota
12 Department of Natural Resources for the Minnesota fish-
13 ery resources management program.

14 (c) REVERSIONARY INTEREST.—All right, title, and
15 interest in and to all property and interests conveyed
16 under this section shall revert to the United States on any
17 date on which any of the property or interests are used
18 other than for the Minnesota fishery resources manage-
19 ment program.

20 **SEC. 2. CONVEYANCE OF THE FAIRPORT NATIONAL FISH**
21 **HATCHERY TO THE STATE OF IOWA.**

22 (a) *CONVEYANCE.*—*The Secretary of the Interior shall*
23 *convey to the State of Iowa, without reimbursement and*
24 *by no later than December 31, 1994, all right, title, and*
25 *interest of the United States in and to the fish hatchery*

1 *described in subsection (b) for use by the State for purposes*
 2 *of fishery resources management.*

3 *(b) HATCHERY DESCRIBED.—The fish hatchery de-*
 4 *scribed in subsection (a) is the Fairport National Fish*
 5 *Hatchery located in Muscatine County, Iowa, adjacent to*
 6 *State Highway 22 west of Davenport, Iowa, including all*
 7 *real property, improvements to real property, and personal*
 8 *property.*

9 *(c) USE AND REVERSIONARY INTEREST.—The prop-*
 10 *erty conveyed to the State of Iowa pursuant to this section*
 11 *shall be used by the State for purposes of fishery resources*
 12 *management, and if it is used for any other purpose all*
 13 *right, title, and interest in and to all property conveyed*
 14 *pursuant to this section shall revert to the United States.*

15 **SEC. 3. CONVEYANCE OF CORNING NATIONAL FISH HATCH-**
 16 **ERY TO THE STATE OF ARKANSAS.**

17 *(a) CONVEYANCE REQUIREMENT.—The Secretary of*
 18 *the Interior shall convey to the State of Arkansas, without*
 19 *reimbursement and by no later than December 31, 1994,*
 20 *all right, title, and interest of the United States in and to*
 21 *the property described in subsection (b), for use by the Ar-*
 22 *kansas Game and Fish Commission as part of the State*
 23 *of Arkansas fish culture program.*

24 *(b) PROPERTY DESCRIBED.—The property referred to*
 25 *in subsection (a) is the property known as the Corning Na-*
