AN ACT

To authorize the Secretary of the Interior to carry out a
program to be known as the Junior Duck Stamp Con-
servation and Design Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Junior Duck Stamp
5 Conservation and Design Program Act of 1994”.

1 **SEC. 2. ESTABLISHMENT OF PROGRAM.**

2 (a) IN GENERAL.—The Secretary of the Interior (in
3 this Act referred to as the “Secretary”) may carry out
4 in accordance with this Act a program to be known as
5 the “Junior Duck Stamp Conservation and Design Pro-
6 gram” (in this Act referred to as the “Program”) to ac-
7 complish the goals of—

8 (1) providing to school children environmental
9 education opportunities relating to the conservation
10 and management of migratory birds; and

11 (2) increasing the capacity for schools, States,
12 and other educational programs to conduct conserva-
13 tion and education programs.

14 (b) PROGRAM FEATURES.—The Program shall con-
15 sist of—

16 (1) conducting in all interested States the ac-
17 tivities which on the day before the date of the en-
18 actment of this Act are conducted under the pro-
19 gram known as the Junior Duck Stamp Conserva-
20 tion and Design Program;

21 (2) other activities authorized under the Pro-
22 gram by this or any other Act; and

23 (3) any other activity necessary to carry out the
24 conservation and education goals of the Program.

25 (c) EFFORT TO CONDUCT PROGRAM IN ALL
26 STATES.—

1 (1) IN GENERAL.—The Secretary shall take ap-
2 propriate steps to seek to conduct the Program in all
3 of the 50 States.

4 (2) ANNUAL REPORT.—The Secretary shall an-
5 nually submit a report to the Congress on the status
6 of the Program in each of the 50 States.

7 **SEC. 3. JUNIOR DUCK STAMP.**

8 (a) COMPETITION.—As part of the Program, the Sec-
9 retary may annually conduct a competition to—

10 (1) solicit the submission by students at ele-
11 mentary and secondary schools of designs relating to
12 conservation of migratory birds; and

13 (2) select winning designs from among those
14 submissions for use for licensing and marketing
15 under subsection (b).

16 (b) LICENSING AND MARKETING OF DESIGN OF JUN-
17 IOR DUCK STAMPS.—As part of the Program, the Sec-
18 retary may—

19 (1) license and market winning designs selected
20 in competitions under subsection (a); and

21 (2) license and market stamps bearing those de-
22 signs, which shall be known as Junior Duck Stamps.

23 (c) USE OF PROCEEDS FROM LICENSING AND MAR-
24 KETING OF JUNIOR DUCK STAMPS AND JUNIOR DUCK

1 STAMP DESIGNS.—Amounts received under subsection
2 (b)—

3 (1) shall be available to the Secretary until ex-
4 pended, without further appropriations, solely for—

5 (A) awards and scholarships to individuals
6 who submit designs in competitions under sub-
7 section (a), that are—

8 (i) selected in such a competition as
9 winning designs; or

10 (ii) otherwise determined in such a
11 competition to be superior;

12 (B) awards to schools and other partici-
13 pants to further education activities related to
14 the conservation education goals of the Pro-
15 gram; and

16 (C) expenses for licensing and marketing
17 under subsection (b); and

18 (2) may not be used for administrative expenses
19 of the Program.

20 **SEC. 4. ACCEPTANCE OF GIFTS, DEVICES, AND BEQUESTS.**

21 The Secretary may accept and use any gift, devise,
22 or bequest of personal property, or proceeds thereof, for
23 the purpose of funding the activities described in section
24 3(c)(1) (A) and (B).

1 **SEC. 5. AUTHORIZATION OF APPROPRIATIONS.**

2 There are authorized to be appropriated to the Sec-
3 retary for administrative expenses of the Program
4 \$250,000 for each of the fiscal years 1995 through 2000.

5 **SEC. 6. ENVIRONMENTAL EDUCATION CENTER AND REF-**
6 **UGE HEADQUARTERS AT JOHN HEINZ NA-**
7 **TIONAL WILDLIFE REFUGE AT TINICUM.**

8 (a) IN GENERAL.—Notwithstanding other laws and
9 subject to subsection (b), the Secretary of the Interior,
10 acting through the Director of the United States Fish and
11 Wildlife Service, may transfer to the National Fish and
12 Wildlife Foundation the Cusano bequest.

13 (b) CONDITIONS OF TRANSFER.—As a condition of
14 transferring the Cusano bequest under subsection (a), the
15 Secretary of the Interior shall require the National Fish
16 and Wildlife Foundation to enter into an agreement under
17 which the Foundation is required to—

18 (1) solicit additional non-Federal contributions
19 to provide a dollar for dollar match of the Cusano
20 bequest;

21 (2) manage the Cusano bequest and those con-
22 tributions in accordance with all applicable require-
23 ments of the National Fish and Wildlife Foundation
24 Establishment Act (16 U.S.C. 3701 et seq.);

25 (3) use all amounts and proceeds from the
26 Cusano bequest and any non-Federal contributions

1 received pursuant to paragraph (1) for the purpose
2 of designing and constructing a facility for an envi-
3 ronmental education center and refuge headquarters
4 on lands located within the John Heinz National
5 Wildlife Refuge at Tinicum; and

6 (4) donate the facility to the United States Fish
7 and Wildlife Service upon completion of its construc-
8 tion.

9 (c) CUSANO BEQUEST DEFINED.—For purposes of
10 this section, the term “Cusano bequest” means the
11 amounts totaling approximately \$2,473,971 which were
12 donated to the Department of the Interior in 1994 by Mr.
13 Antonio Cusano of Crum Lynne, Pennsylvania, and in-
14 cludes all proceeds derived from such amounts in the pe-
15 riod since the donation was made.
