To designate the Federal building and United States courthouse located at 100 East Houston Street in Marshall,

Texas, as the “Sam B. Hall, Jr. Federal Building and United States Courthouse”.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. DESIGNATION.**

4        The Federal building located at 100 East Houston  
5        Street in Marshall, Texas, shall be known and designated  
6        as the “Sam B. Hall, Jr. Federal Building and United  
7        States Courthouse”.

8        **SEC. 2. REFERENCES.**

9        Any reference in a law, map, regulation, document,  
10       paper, or other record of the United States to the Federal  
11       building and United States courthouse referred to in sec-  
12       tion 1 shall be deemed to be a reference to the “Sam B.  
13       Hall, Jr. Federal Building and United States Court-  
14       house”.
