1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; REFERENCE.**

4 (a) SHORT TITLE.—This Act may be cited as the
5 “Miscellaneous Tariff Act of 1993”.

6 (b) REFERENCE.—Except as otherwise expressly pro-
7 vided, whenever in this Act an amendment or repeal is
8 expressed in terms of an amendment to, or repeal of, a
9 chapter, subchapter, note, additional U.S. note, heading,

1 subheading, or other provision, the reference shall be con-
 2 sidered to be made to a chapter, subchapter, note, addi-
 3 tional U.S. note, heading, subheading, or other provision
 4 of the Harmonized Tariff Schedule of the United States.
