A BILL

To establish the Lower East Side Tenement Museum
National Historic Site.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Lower East Side Tene-*
5 *ment National Historic Site Act of 1994”.*

6 **SEC. 2. DEFINITIONS.**

7 *As used in this Act:*

8 *(1) The term “historic site” means the Lower*
9 *East Side Tenement National Historic Site estab-*
10 *lished by section 4.*

11 *(2) The term “Museum” means the Lower East*
12 *Side Tenement Museum, an education corporation*
13 *chartered under the laws of the State of New York.*

14 *(3) The term “Secretary” means the Secretary of*
15 *the Interior.*

16 **SEC. 3. FINDINGS AND PURPOSES.**

17 *(a) FINDINGS.—The Congress finds that—*

18 *(1) the Lower East Side Tenement at 97 Or-*
19 *chard Street, New York, New York, is an outstanding*
20 *survivor of the vast number of humble buildings in*
21 *New York City that housed immigrants to the United*
22 *States during the greatest wave of immigration in*
23 *American history;*

1 (2) *the Lower East Side Tenement is well suited*
2 *to represent a profound social movement involving*
3 *great numbers of unexceptional but courageous people;*

4 (3) *between 1880 and 1921, almost three-quar-*
5 *ters of the immigrants to the United States entered*
6 *the country through New York Harbor, most passed*
7 *through immigration stations at Ellis Island and,*
8 *earlier, Castle Clinton, both of which have been des-*
9 *ignated as national monuments, and millions of these*
10 *immigrants made their way to the Lower East Side*
11 *of New York City;*

12 (4) *no other single identifiable neighborhood in*
13 *the United States absorbed a comparable number of*
14 *immigrants;*

15 (5) *the Museum is dedicated to interpreting im-*
16 *migrant life on the Lower East Side and its impor-*
17 *tance to United States history, and is located within*
18 *a neighborhood long associated with the immigrant*
19 *experience in America;*

20 (6) *the tenement building at 97 Orchard Street*
21 *has been designated as a National Historic Land-*
22 *mark, has been found to be historically significant,*
23 *and possesses a historic fabric of exceptional integrity*
24 *dating from the period of peak immigration to the*
25 *United States; and*

1 (7) *the National Park Service has found the*
2 *Lower East Side Tenement to be nationally signifi-*
3 *cant and to be best protected and interpreted through*
4 *designation as an affiliated area of the National Park*
5 *System while remaining under private ownership and*
6 *management.*

7 (b) *PURPOSES.—The purposes of this Act are—*

8 (1) *to assure the preservation, maintenance, and*
9 *interpretation of the Lower East Side Tenement and*
10 *to interpret, in the tenement and the surrounding*
11 *neighborhood, the themes of early tenement life, the*
12 *housing reform movement, and tenement architecture*
13 *in the United States;*

14 (2) *to assure the continuation at this site of the*
15 *Lower East Side Tenement, the preservation of which*
16 *is necessary for the continued interpretation of the*
17 *nationally significant immigrant phenomenon associ-*
18 *ated with the Lower East Side of New York City and*
19 *the role of the phenomenon in the history of immigra-*
20 *tion to the United States; and*

21 (3) *to enhance the interpretation of the Castle*
22 *Clinton National Monument and Ellis Island Na-*
23 *tional Monument through cooperation with the Lower*
24 *East Side Tenement National Historic Site.*

1 **SEC. 4. DESIGNATION OF HISTORIC SITE.**

2 *In order to further the purposes of this Act and the*
3 *Act of August 21, 1935 (49 Stat. 666; 16 U.S.C. 461 et*
4 *seq.), the Lower East Side Tenement at 97 Orchard Street,*
5 *New York, New York, is hereby designated as a national*
6 *historic site.*

7 **SEC. 5. COOPERATIVE AGREEMENT.**

8 *(a) IN GENERAL.—In furtherance of the purposes of*
9 *this Act and the Act of August 21, 1935 (49 Stat. 666; 16*
10 *U.S.C. 461 et seq.), the Secretary may enter into a coopera-*
11 *tive agreement with the Museum to effectuate the purposes*
12 *of this Act.*

13 *(b) TECHNICAL AND FINANCIAL ASSISTANCE.—Any*
14 *agreement entered into under subsection (a) may include*
15 *provisions by which the Secretary will provide technical as-*
16 *sistance to mark, restore, interpret, operate, and maintain*
17 *the historic site. Such an agreement may also include provi-*
18 *sions by which the Secretary will provide financial assist-*
19 *ance to mark, interpret, and restore the historic site (in-*
20 *cluding financial assistance for the making of preservation-*
21 *related capital improvements and repairs, but not includ-*
22 *ing financial assistance for other routine operations).*

23 *(c) ADDITIONAL PROVISIONS.—Any agreement entered*
24 *into under subsection (a) shall contain provisions that—*

25 *(1) the Secretary, acting through the National*
26 *Park Service, shall have the right of access at all rea-*

1 *sonable times to all public portions of the property*
2 *covered by such agreement for the purpose of conduct-*
3 *ing visitors through such property and interpreting*
4 *the property to the public; and*

5 *(2) no changes or alterations may be made in*
6 *property covered by the agreement except by mutual*
7 *agreement between the Secretary and the other parties*
8 *to the agreement entered into under subsection (a).*

9 **SEC. 6. REPORT.**

10 *The Museum shall, as a condition of the receipt of any*
11 *assistance under this Act, provide to the Secretary and to*
12 *the Congress an annual report documenting the activities*
13 *and expenditures for which any such assistance was used*
14 *during the fiscal year preceding the report.*

15 **SEC. 7. APPROPRIATIONS.**

16 *There is hereby authorized to be appropriated*
17 *\$6,400,000 to carry out the purposes of this Act, such sums*
18 *to remain available until expended.*

Amend the title so as to read: “A bill to establish
