A BILL

To authorize certain construction at military installations for fiscal year 1995, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Military Construction
5 Authorization Act for Fiscal Year 1995”.

1 **SEC. 103. IMPROVEMENTS TO MILITARY FAMILY HOUSING**
2 **UNITS.**

3 Subject to section 2825 of title 10, United States
4 Code, and using amounts appropriated pursuant to the
5 authorization of appropriations in section 104(a)(6)(A),
6 the Secretary of the Army may improve existing military
7 family housing in an amount not to exceed \$49,760,000.

8 **SEC. 104. AUTHORIZATION OF APPROPRIATIONS, ARMY.**

9 (a) IN GENERAL.—Funds are hereby authorized to
10 be appropriated for fiscal years beginning after September
11 30, 1994, for military construction, land acquisition, and
12 military family housing functions of the Department of the
13 Army in the total amount of \$1,964,186,000 as follows:

15 United States authorized by section 101(a),
16 \$584,250,000.

17 (2) For military construction projects outside
18 the United States authorized by section 101(b),
19 \$6,400,000.

20 (3) For unspecified minor military construction
21 projects authorized by section 2805 of title 10, Unit-
22 ed States Code, \$12,000,000.

23 (4) For architectural and engineering services
24 and construction design under section 2807 of title
25 10, United States Code, \$87,926,000.

26 (5) For military family housing functions:

1 (A) For construction and acquisition of
2 military family housing and facilities,
3 \$152,402,000.

4 (B) For support of military family housing
5 (including the functions described in section
6 2833 of title 10, United States Code),
7 \$1,121,208,000 of which not more than
8 \$243,442,000 may be obligated or expended for
9 the leasing of military family housing world-
10 wide.

11 (b) LIMITATION ON TOTAL COST OF CONSTRUCTION
12 PROJECTS.—Notwithstanding the cost variations author-
13 ized by section 2853 of title 10, United States Code, and
14 any other cost variation authorized by law, the total cost
15 of all projects carried out under section 101 of this Act
16 may not exceed the total amount authorized to be appro-
17 priated under paragraphs (1) and (2) of subsection (a).

23 may not exceed—

9 dorf Air Force Base, Alaska); and

10 (4) \$85,000,000 (the balance of the amount au-
11 thORIZED for construction of the Army Medical Cen-
12 ter at Fort Bragg, North Carolina).

13 **TITLE V—NORTH ATLANTIC**
14 **TREATY ORGANIZATION IN-**
15 **FRAStructure**

16 **SEC. 501. AUTHORIZED NATO CONSTRUCTION AND LAND**
17 **ACQUISITION PROJECTS.**

18 The Secretary of Defense may make contributions for
19 the North Atlantic Treaty Organization Infrastructure
20 Program as provided in section 2806 of title 10, United
21 States Code, in an amount not to exceed the sum of the
22 amount authorized to be appropriated for this purpose in
23 section 502 and the amount collected from the North At-
24 lantic Treaty Organization as a result of construction pre-
25 viously financed by the United States.

1 **SEC. 502. AUTHORIZATION OF APPROPRIATIONS, NATO.**

2 Funds are hereby authorized to be appropriated for
3 fiscal years beginning after September 30, 1994, for con-
4 tributions by the Secretary of Defense under section 2806
5 of title 10, United States Code, for the share of the United
6 States of the cost of projects for the North Atlantic Treaty
7 Organization Infrastructure Program, as authorized by
8 section 501, in the amount of \$219,000,000.

9 **TITLE VI—GUARD AND RESERVE**
10 **FORCES FACILITIES**

11 **SEC. 601. AUTHORIZED GUARD AND RESERVE CONSTRUC-**
12 **TION AND LAND ACQUISITION PROJECTS.**

13 There are authorized to be appropriated for fiscal
14 years beginning after September 30, 1994, for the costs
15 of acquisition, architectural and engineering services, and
16 construction of facilities for the Guard and Reserve
17 Forces, and for contributions therefor, under chapter 133
18 of title 10, United States Code (including the cost of ac-
19 quisition of land for those facilities), the following
20 amounts:

- 21 (1) For the Department of the Army—
22 (A) for the Army National Guard of the
23 United States, \$9,929,000; and
24 (B) for the Army Reserve, \$7,910,000.
25 (2) For the Department of the Navy, for the
26 Naval and Marine Corps Reserve, \$2,355,000.

- 1 (3) For the Department of the Air Force—
2 (A) for the Air National Guard of the
3 United States, \$122,770,000; and
4 (B) for the Air Force Reserve,
5 \$28,190,000.

6 **TITLE VII—EXPIRATION AND EX-**
7 **TENSION OF AUTHORIZA-**
8 **TIONS**

9 **SEC. 701. EXPIRATION OF AUTHORIZATIONS AND AMOUNTS**
10 **REQUIRED TO BE SPECIFIED BY LAW.**

11 (a) EXPIRATION OF AUTHORIZATIONS AFTER THREE
12 YEARS.—Except as provided in subsection (b), all author-
13 izations contained in titles I through VI for military con-
14 struction projects, land acquisition, family housing
15 projects and facilities, and contributions to the North At-
16 lantic Treaty Organization Infrastructure program (and
17 authorizations of appropriations therefor) shall expire on
18 the later of—

- 19 (1) October 1, 1997; or
20 (2) the date of the enactment of an Act author-
21 izing funds for military construction for fiscal year
22 1998.

23 (b) EXCEPTION.—Subsection (a) shall not apply to
24 authorizations for military construction projects, land
25 acquisition, family housing projects and facilities, and

1 contributions to the North Atlantic Treaty Organization
2 Infrastructure program (and authorizations of appropria-
3 tions therefor), for which appropriated funds have been
4 obligated before the later of—

5 (1) October 1, 1997; or

6 (2) the date of the enactment of an Act author-
7 izing funds for fiscal year 1998 for military con-
8 struction projects, land acquisition, family housing
9 projects and facilities, or contributions to the North
10 Atlantic Treaty Organization Infrastructure pro-
11 gram.

12 **SEC. 702. EXTENSION OF AUTHORIZATIONS OF CERTAIN**
13 **FISCAL YEAR 1992 PROJECTS.**

14 (a) EXTENSIONS.—Notwithstanding section 2701 of
15 the Military Construction Authorization Act for Fiscal
16 Year 1992 (division B of Public Law 102–190, 105 Stat.
17 1535), authorizations for the projects set forth in the ta-
18 bles in subsection (b), as provided in section 101, 102,
19 301, or 601 of that Act, shall remain in effect until Octo-
20 ber 1, 1995, or the date of the enactment of an Act au-
21 thorizing funds for military construction for fiscal year
22 1996, whichever is later.
