12 **SEC. 6. CONDITION FOR TRANSFER.**

13 *No vessel may be transferred under this Act or any*
 14 *other provision of law until the Secretary of Defense cer-*
 15 *tifies in writing to Congress that, after the transfer—*

16 *(1) the amphibious lift capacity remaining*
 17 *available in the Navy is sufficient in all lift cat-*
 18 *egories to transport 2½ Marine Corps expeditionary*
 19 *brigades simultaneously; and*

20 *(2) the amphibious lift capacity planned to be*
 21 *available in the Navy under the future-years defense*
 22 *program will be sufficient in all lift categories,*
 23 *throughout the period covered by the future-years de-*

1 *fense program, to transport 2½ Marine Corps expedi-*
2 *tionary brigades simultaneously.*

3 **SEC. 7. USE OF PROCEEDS.**

4 *The proceeds derived from a transfer authorized by this*
5 *Act that are received in a fiscal year shall be credited to*
6 *the appropriation for the Navy for such fiscal year for oper-*
7 *ation and maintenance and shall be available, for the same*
8 *period as the appropriation to which credited, for operation*
9 *and maintenance of amphibious vessels.*
