To expand the boundary of the Weir Farm National Historic Site in the State of Connecticut.

Mr. FRANKS of Connecticut (for himself, Mrs. KENNELLY, Mr. SHAYS, Mr. GEJDENSON, Mrs. JOHNSON of Connecticut, and Ms. DELAURO) introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To expand the boundary of the Weir Farm National Historic Site in the State of Connecticut.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Weir Farm National
5 Historic Site Expansion Act of 1994”.

6 **SEC. 2. PURPOSE.**

7 The purpose of this Act is to preserve the last re-
8 maining undeveloped parcels of the historic Weir Farm
9 that remain in private ownership by including the parcels

1 within the boundary of the Weir Farm National Historic
2 Site.

3 **SEC. 3. BOUNDARY ADJUSTMENT.**

4 (a) ADJUSTMENT.—Section 4(b) of the Weir Farm
5 National Historic Site Establishment Act of 1990 (104
6 Stat. 1171) is amended—

7 (1) by striking out “and” at the end of para-
8 graph (1);

9 (2) by striking out the flush material below
10 paragraph (2); and

11 (3) by adding at the end the following:

12 “(3) the approximately 2-acre parcel of land sit-
13 uated in the town of Wilton, Connecticut, designated
14 as lot 18 on a map entitled ‘Revised Map of Section
15 I, Thunder Lake at Wilton, Connecticut, Scale 1”=
16 100’, October 27, 1978, Ryan and Faulds Land
17 Surveyors, Wilton, Connecticut’, that is on file in the
18 office of the town clerk of the town of Wilton, and
19 therein numbered 3673; and

20 “(4) the approximately 0.6-acre western portion
21 of a parcel of land situated in the town of Wilton,
22 Connecticut, designated as Tall Oaks Road on the
23 map referred to in paragraph (3).”.

1 (b) GENERAL DEPICTION.—Section 4 of such Act, as
2 amended by subsection (a), is further amended by adding
3 at the end the following:

4 “(c) GENERAL DEPICTION.—The parcels referred to
5 in paragraphs (1) through (4) of subsection (b) are all
6 as generally depicted on a map entitled ‘Boundary Map,
7 Weir Farm National Historic Site’, dated March 1994.
8 Such map shall be on file and available for public inspec-
9 tion in the appropriate offices of the National Park
10 Service.”.
