## A BILL

To extend the Administrative Conference of the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION.**

4 *The first sentence of section 596 of title 5, United*  
5 *States Code, is amended to read as follows: "There are au-*

1 *thorized to be appropriated to carry out the purposes of this*  
2 *subchapter not more than \$2,600,000 for fiscal year 1995,*  
3 *\$2,700,000 for fiscal year 1996, \$2,800,000 for fiscal year*  
4 *1997, and \$2,900,000 for fiscal year 1998.”.*

5 **SEC. 2. CHAIRMAN’S COMPENSATION.**

6 (a) *EXECUTIVE SCHEDULE RATE.*—Section 593(b)(1)  
7 *of title 5, United States Code, is amended by striking the*  
8 *period and “The Chairman is entitled to pay at the highest*  
9 *rate established by statute for the chairman of an independ-*  
10 *ent regulatory board or commission, and” and inserting a*  
11 *comma and “who shall be paid at the rate specified for level*  
12 *III of the Executive Schedule and who”.*

13 (b) *CONFORMING AMENDMENT.*—Section 5314 of title  
14 *5, United States Code, is amended by adding at the end*  
15 *the following:*

16 “Chairman, Administrative Conference of the  
17 United States.”.

18 **SEC. 3. MEMBERS’ CAPACITY.**

19 *Section 593 of title 5, United States Code, is*  
20 *amended—*

21 (1) *in subsection (b)(6), by striking out the last*  
22 *two sentences, and*

23 (2) *by redesignating subsection (c) as subsection*

24 (d) *and by adding after subsection (b) the following:*

1       “(c)(1) *The Chairman shall select the members of the*  
2 *Conference authorized by subsection (b)(6) in a manner*  
3 *which will provide broad representation of the views of pri-*  
4 *vate citizens and utilize diverse experience. Such members*  
5 *shall be members of the practicing bar, scholars in the field*  
6 *of administrative law or government, or others specially in-*  
7 *formed by knowledge and experience with respect to Federal*  
8 *administrative procedure.*

9       “(2) *The members of the Conference authorized by sub-*  
10 *section (b)(6) shall participate in the activities of the Con-*  
11 *ference solely as private individuals without official respon-*  
12 *sibility on behalf of the Government of the United States*  
13 *and, therefore, shall not be considered to hold an office of*  
14 *profit or trust for purposes of eighth clause of Section 9*  
15 *of Article I of the Constitution.”.*

16 **SEC. 4. QUORUM.**

17       *Section 595(a) of title 5, United States Code, is*  
18 *amended by adding after and below paragraph (2) the fol-*  
19 *lowing: “A majority of the members of the Conference shall*  
20 *constitute a quorum with regard to any final action taken*  
21 *under paragraph (1) or (2).”.*
