Mr. KLINK introduced the following bill; which was referred jointly to the Committees on Ways and Means, Energy and Commerce, and Agriculture

## A BILL

To reinstate the emergency unemployment compensation program.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION OF PROGRAM.**

4 (a) GENERAL RULE.—Sections 102(f)(1) and  
5 106(a)(2) of the Emergency Unemployment Compensation  
6 Act of 1991 (Public Law 102–164, as amended) are each  
7 amended by striking “February 5, 1994” and inserting  
8 “August 5, 1994”.

9 (b) MODIFICATION OF FINAL PHASEOUT.—Para-  
10 graph (2) of section 102(f) of such Act is amended—

1 (1) by striking “February 5, 1994” and insert-  
2 ing “August 5, 1994”, and

3 (2) by striking “April 30, 1994” and inserting  
4 “September 30, 1994”.

5 (c) CONFORMING AMENDMENT.—Subsection (e) of  
6 section 101 of such Act is amended by striking “February  
7 5, 1994” each place it appears and inserting “August 5,  
8 1994”.

9 (d) EFFECTIVE DATE.—The amendments made by  
10 this section shall apply to weeks of unemployment begin-  
11 ning after February 5, 1994.

12 **SEC. 2. TREATMENT OF RAILROAD WORKERS.**

13 (a) GENERAL RULE.—

14 (1) Paragraphs (1) and (2) of section 501(b) of  
15 the Emergency Unemployment Compensation Act of  
16 1991 (Public Law 102–164, as amended) are each  
17 amended by striking “February 5, 1994” and insert-  
18 ing “August 5, 1994”.

19 (2) Subsection (a) of section 501 of such Act is  
20 amended by striking “February 1994” and inserting  
21 “August 5, 1994”.

22 (b) TERMINATION OF BENEFITS.—Subsection (e) of  
23 section 501 of such Act is amended—

24 (1) by striking “February 5, 1994” and insert-  
25 ing “August 5, 1994”, and

1           (2) by striking “April 30, 1994” and inserting  
2           “September 30, 1994”.

3           (c) EFFECTIVE DATE.—The amendments made by  
4 this section shall apply to days of unemployment after  
5 February 5, 1994.

6 **SEC. 3. EXTENSION FUNDED BY REPEAL OF EXPORT EN-**  
7                           **HANCEMENT PROGRAM OF DEPARTMENT OF**  
8                           **AGRICULTURE.**

9           (a) IN GENERAL.—Section 301 of the Agricultural  
10 Trade Act of 1978 (7 U.S.C. 5651) is hereby repealed.

11          (b) EFFECTIVE DATE.—The amendment made by  
12 subsection (a) shall apply to fiscal years beginning after  
13 the date of the enactment of this Act.
