AN ACT

To extend and make amendments to the President John F. Kennedy Assassination Records Collection Act of 1992.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “President John F.
5 Kennedy Assassination Records Collection Extension Act
6 of 1994”.

7 **SEC. 2. EXTENSION OF ACT.**

8 Section 7(o)(1) of the President John F. Kennedy
9 Assassination Records Collection Act of 1992 (44 U.S.C.
10 2107 note) is amended—

1 (1) by striking “2 years” and inserting “3
2 years”; and

3 (2) by striking “2-year” and inserting “3-year”.

4 **SEC. 3. AMENDMENTS RELATING TO REVIEW BOARD**
5 **POWERS.**

6 Section 8(j)(1) of the President John F. Kennedy As-
7 sassination Records Collection Act of 1992 (44 U.S.C.
8 2107 note) is amended—

9 (1) in subparagraph (E) by striking “and”
10 after the semicolon;

11 (2) in subparagraph (F) by striking the period
12 and inserting “; and”; and

13 (3) by adding at the end the following:

14 “(G) use the Federal Supply Service in the
15 same manner and under the same conditions as
16 other departments and agencies of the United
17 States; and

18 “(H) use the United States mails in the
19 same manner and under the same conditions as
20 other departments and agencies of the United
21 States.”.

22 **SEC. 4. AMENDMENTS RELATING TO REVIEW BOARD PER-**
23 **SONNEL.**

24 (a) SECURITY CLEARANCE FOR REVIEW BOARD PER-
25 SONNEL.—Section 8 of the President John F. Kennedy

1 Assassination Records Collection Act of 1992 (44 U.S.C.
2 2107 note) is amended by adding at the end the following:

3 “(e) SECURITY CLEARANCE REQUIRED.—An individ-
4 ual employed in any position by the Review Board (includ-
5 ing an individual appointed as Executive Director) shall
6 be required to qualify for any necessary security clearance
7 prior to taking office in that position, but may be offered
8 the position before qualifying for that clearance.”.

9 (b) APPOINTMENT AND TERMINATION OF STAFF,
10 GENERALLY.—Section 8(b) of the President John
11 F. Kennedy Assassination Records Collection Act of 1992
12 (44 U.S.C. 2107 note) is amended by striking
13 “(b) STAFF.—” and all that follows through the end of
14 paragraph (1) and inserting the following:

15 “(b) STAFF.—(1) The Review Board, without regard
16 to the civil service laws, may appoint and terminate addi-
17 tional personnel as are necessary to enable the Review
18 Board and its Executive Director to perform the duties
19 of the Review Board.”.

20 (c) REVIEW BOARD ADMINISTRATIVE STAFF.—Sec-
21 tion 8(b)(2) of the President John F. Kennedy Assassina-
22 tion Records Collection Act of 1992 (44 U.S.C. 2107 note)
23 is amended—

1 (1) by striking “A person” and inserting “(A)
2 Except as provided in subparagraph (B), a person”;
3 and

4 (2) by adding at the end the following:

5 “(B) An individual who is an employee of the Govern-
6 ment may be appointed to the staff of the Review Board
7 if in that position the individual will perform only adminis-
8 trative functions.”.

9 **SEC. 5. TECHNICAL CORRECTION.**

10 Section 6(1) of the President John F. Kennedy As-
11 sassination Records Collection Act of 1992 (44 U.S.C.
12 2107 note) is amended in the matter preceding subpara-
13 graph (A) by inserting “record” after “the assassination”.
