## A BILL

To authorize noncompetitive, career or career-conditional appointments for employees of the Criminal Justice Information Services of the Federal Bureau of Investigation who do not relocate to Clarksburg, West Virginia.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Criminal Justice Infor-  
5        mation Services Placement Assistance Act”.

1 **SEC. 2. NONCOMPETITIVE CAREER OR CAREER-**  
2 **CONDITIONAL APPOINTMENTS FOR**  
3 **NONRELOCATING EMPLOYEES OF THE CRIMI-**  
4 **NAL JUSTICE INFORMATION SERVICES OF**  
5 **THE FBI.**

6 (a) IN GENERAL.—An individual described in sub-  
7 section (b) may be appointed noncompetitively, under a  
8 career or career-conditional appointment, to a position in  
9 the competitive service if—

10 (1) the individual meets the qualification re-  
11 quirements prescribed by the Office of Personnel  
12 Management for the position to which appointed;

13 (2) the last previous Federal employment of the  
14 individual was as an employee of the Criminal Jus-  
15 tice Information Services Division of the Federal  
16 Bureau of Investigation; and

17 (3) the appointment is effected on or before  
18 September 30, 1999.

19 (b) INDIVIDUAL DESCRIBED.—An individual de-  
20 scribed in this subsection is an individual who—

21 (1) on the date of the enactment of this Act—

22 (A) is an employee of the Criminal Justice  
23 Information Services Division of the Federal  
24 Bureau of Investigation; and

25 (B) is serving in an appointed position (i)  
26 to be relocated from Washington, District of

1 Columbia, to Clarksburg, West Virginia, and  
2 (ii) that is excepted by law or regulation from  
3 the competitive service; and  
4 (2) has not relocated with his or her position in  
5 the Criminal Justice Information Services Division  
6 to Clarksburg, West Virginia.
