## CONCURRENT RESOLUTION

Directing the Clerk of the House of Representatives to make technical corrections in the enrollment of H.R. 3370.

1       *Resolved by the House of Representatives (the Senate*  
2 *concurring)*, That, in the enrollment of the bill (H.R.  
3 3370) to delay the implementation of certain provisions  
4 of the Biggert-Waters Flood Insurance Reform Act of  
5 2012, and for other purposes, the Clerk of the House of  
6 Representatives shall make the following corrections:

7           (1) In section 12—

1 (A) in the matter preceding the new sub-  
2 section added by the amendment made by such  
3 section, strike “, as amended by the preceding  
4 provisions of this Act, is further” and insert  
5 “is”; and

6 (B) in the new subsection added by the  
7 amendment made by such section, strike “(e)”  
8 and insert “(d)”.

9 (2) In section 14, before the closing quotation  
10 marks that immediately precede the period at the  
11 end insert “and”.

12 (3) In section 30—

13 (A) in the matter that precedes paragraph  
14 (1), strike “is” and insert the following: “, as  
15 amended by section 27 of this Act, is further”;

16 (B) in paragraph (1)—

17 (i) in the matter that precedes sub-  
18 paragraph (A), strike “subparagraph (B)”  
19 and insert “subparagraph (C)”; and

20 (ii) in subparagraph (A)—

21 (I) strike “subparagraph (A)”  
22 and insert “subparagraph (B)”; and

23 (II) strike “subparagraph (D)”  
24 and insert “subparagraph (E)”;

1 (C) in paragraph (2), strike “and (C) as  
 2 subparagraphs (D), (E), and (G)” and insert  
 3 “(C), and (D) as subparagraphs (D), (E), (F),  
 4 and (H)”;

5 (D) in paragraph (3), in the matter pre-  
 6 ceding the new subparagraphs inserted by the  
 7 amendment made by such paragraph, strike  
 8 “subparagraph (B)” and insert “subparagraph  
 9 (D)”;

10 (E) in paragraph (4)—

11 (i) in the matter preceding the new  
 12 subparagraph inserted by the amendment  
 13 made by such paragraph, strike “subpara-  
 14 graph (E)” and insert “subparagraph  
 15 (F)”;

16 (ii) in the new subparagraph inserted  
 17 by the amendment made by such para-  
 18 graph, strike “(F)” and insert “(G)”.
