Mr. MURTHA introduced the following bill; which was referred to the Committee on Ways and Means

## A BILL

To increase the number of weeks for which emergency unemployment compensation is payable, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. INCREASE IN NUMBER OF WEEKS FOR WHICH**  
4 **EMERGENCY UNEMPLOYMENT COMPENSA-**  
5 **TION IS PAYABLE.**

6 Subparagraph (A) of section 102(b)(2) of the Emer-  
7 gency Unemployment Compensation Act of 1991 (Public  
8 Law 102-164, as amended) is amended by adding at the  
9 end thereof the following new clause:

1           “(vii) ADDITIONAL ENTITLEMENT.—  
2           Effective with respect to weeks beginning  
3           after the date of the enactment of this  
4           clause—

5                     “(I) notwithstanding clause (vi),  
6                     the reduction under clause (ii) shall  
7                     not apply in determining the amount  
8                     payable from any account from which  
9                     emergency unemployment compensa-  
10                    tion was paid for any week beginning  
11                    before June 13, 1992,

12                    “(II) the applicable limit other-  
13                    wise determined under this subpara-  
14                    graph (after the application of  
15                    subclause (I)) shall be increased by  
16                    13, and

17                    “(III) the percentage otherwise  
18                    applicable under paragraph (1)(A)  
19                    shall be increased by 50 percentage  
20                    points.

21           Adjustments similar to those provided in  
22           the preceding sentence shall be made to  
23           the provisions of section 501 of this Act.”

1 **SEC. 2. REDUCTION IN DEDUCTION FOR CERTAIN EX-**  
2 **PENSES FOR MEALS AND ENTERTAINMENT.**

3 (a) GENERAL RULE.—Paragraph (1) of section  
4 274(n) of the Internal Revenue Code of 1986 is amended  
5 by striking “80 percent” and inserting “70 percent”.

6 (b) CLERICAL AMENDMENT.—The subsection head-  
7 ing of subsection (n) of section 274 of such Code is  
8 amended by striking “80 PERCENT” and inserting “70  
9 PERCENT”.

10 (c) EFFECTIVE DATE.—The amendments made by  
11 this section shall apply to amounts paid or incurred after  
12 the date of the enactment of this section.
