## AN ACT

To authorize the acquisition and protection of nationally significant battlefields and associated sites of the Revolutionary War and the War of 1812 under the American Battlefield Protection Program.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “American Battlefield  
3 Protection Program Amendments Act of 2013”.

4 **SEC. 2. REVOLUTIONARY WAR AND WAR OF 1812 AMERICAN**  
5 **BATTLEFIELD PROTECTION.**

6 Section 7301(c) of the Omnibus Public Land Man-  
7 agement Act of 2009 (Public Law 111–11) is amended  
8 as follows:

9 (1) In paragraph (1)—

10 (A) by striking subparagraph (A) and in-  
11 serting the following:

12 “(A) **BATTLEFIELD REPORT.**—The term  
13 ‘battlefield report’ means, collectively—

14 “(i) the report entitled ‘Report on the  
15 Nation’s Civil War Battlefields’, prepared  
16 by the Civil War Sites Advisory Commis-  
17 sion, and dated July 1993; and

18 “(ii) the report entitled ‘Report to  
19 Congress on the Historic Preservation of  
20 Revolutionary War and War of 1812 Sites  
21 in the United States’, prepared by the Na-  
22 tional Park Service, and dated September  
23 2007.”; and

24 (B) in subparagraph (C)(ii), by striking  
25 “Battlefield Report” and inserting “battlefield  
26 report”.

1           (2) In paragraph (2), by inserting “eligible sites  
2 or” after “acquiring”.

3           (3) In paragraph (3), by inserting “an eligible  
4 site or” after “acquire”.

5           (4) In paragraph (4), by inserting “an eligible  
6 site or” after “acquiring”.

7           (5) In paragraph (5), by striking “An” and in-  
8 serting “An eligible site or an”.

9           (6) By redesignating paragraph (6) as para-  
10 graph (9).

11           (7) By inserting after paragraph (5) the fol-  
12 lowing new paragraphs:

13           “(6) WILLING SELLERS.—Acquisition of land  
14 or interests in land under this subsection shall be  
15 from willing sellers only.

16           “(7) REPORT.—Not later than 5 years after the  
17 date of the enactment of this subsection, the Sec-  
18 retary shall submit to Congress a report on the ac-  
19 tivities carried out under this subsection, including  
20 a description of—

21           “(A) preservation activities carried out at  
22 the battlefields and associated sites identified in  
23 the battlefield report during the period between  
24 publication of the battlefield report and the re-  
25 port required under this paragraph;

1           “(B) changes in the condition of the bat-  
2           tlegrounds and associated sites during that period;  
3           and

4           “(C) any other relevant developments re-  
5           lating to the battlefields and associated sites  
6           during that period.

7           “(8) PROHIBITION ON LOBBYING.—

8           “(A) IN GENERAL.—None of the funds  
9           provided pursuant to this section may be used  
10          for purposes of lobbying any person or entity  
11          regarding the implementation of this section or  
12          be granted, awarded, contracted, or otherwise  
13          be made available to any person, organization,  
14          or entity that participates in such lobbying.

15          “(B) LOBBYING DEFINED.—For purposes  
16          of this paragraph, the term ‘lobbying’ means to  
17          directly or indirectly pay for any personal serv-  
18          ice, advertisement, telegram, telephone call, let-  
19          ter, printed or written matter, or other device  
20          intended or designed to influence in any man-  
21          ner a Member of Congress, a jurisdiction, or an  
22          official of any government to favor, adopt, or  
23          oppose by vote or otherwise, any legislation,  
24          law, ratification, policy, land use plan (including  
25          zoning), or appropriation of funds before or

1 after the introduction of any bill, resolution, or  
2 other measure proposing such legislation, law,  
3 ratification, policy, or appropriation.”.

4 (8) In paragraph (9) (as redesignated by para-  
5 graph (6)), by striking “2013” and inserting  
6 “2018”.
