Mr. THOMAS of Wyoming introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To authorize the Secretary of the Interior to transfer to the Goshen Irrigation District, Wyoming, certain lands and irrigation structures relating to the Fort Laramie Division of the North Platte Project.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TRANSFER TO GOSHEN IRRIGATION DISTRICT.**

4 (a) AUTHORIZATION.—The Secretary of the Interior
5 is authorized to transfer to the Goshen Irrigation District,
6 Wyoming, without cost to the district, title to such lands,
7 easements, ditches, laterals, canals, drains, and other
8 rights-of-way, together with all appurtenant structures

1 which the United States has acquired in connection with
2 the Fort Laramie Division of the North Platte Project
3 that are used solely for the purpose of serving Goshen Irrig-
4 gation District lands in Wyoming and which the Secretary
5 determines are necessary to enable the Goshen Irrigation
6 District to carry out operation and maintenance with re-
7 spect to that portion of the facilities to be transferred. The
8 title to such lands, easements, ditches, laterals, canals,
9 drains, and other rights-of-way, together with all appur-
10 tenant structures located in Wyoming that are for the pur-
11 pose of jointly serving Goshen Irrigation District lands in
12 Wyoming and Gering-Ft. Laramie lands in Nebraska, may
13 be transferred to the Goshen Irrigation District upon mu-
14 tual agreement by the Secretary and the Goshen Irrigation
15 District.

16 (b) CONDITION.—Any transfer under this Act shall
17 be subject to the condition that the district assumes the
18 responsibility for the operation and maintenance portion
19 of the project works in a manner necessary to ensure that
20 the United States obligation to deliver water to the
21 Gering-Ft. Laramie Irrigation District shall be main-
22 tained.

23 (c) INTERESTS RETAINED BY UNITED STATES.—
24 Title to and management and operation of the reservoirs
25 and related water supply works necessary for their protec-

1 tion and operation shall remain in the United States, un-
2 less otherwise provided by an Act of Congress. The United
3 States shall incur no further expense on behalf of the Go-
4 shen Irrigation District for the operation and mainte-
5 nance, rehabilitation, or replacement of the irrigation, de-
6 livery, drainage, and related facilities transferred under
7 this Act.

8 (d) LIABILITY.—The district shall assume all liability
9 with respect to such transferred facilities and shall indem-
10 nify the United States against all such liability.

11 (e) CONTRACTUAL OBLIGATIONS.—Nothing con-
12 tained herein shall relieve the Goshen Irrigation District
13 from any provisions or requirements of its existing con-
14 tracts (1926 Contract and 1952 Amendatory Contract)
15 with the United States except conveyance of title to the
16 facilities as provided for by this Act.
