A BILL

1 **SECTION 1. SHORT TITLE; REFERENCES TO TITLE 38, UNITED STATES CODE.**

3 (a) SHORT TITLE.—This Act may be cited as the
4 Veterans' Compensation Rates Codification Act of 1993.

5 (b) REFERENCES.—Except as otherwise expressly
6 provided, whenever in this Act an amendment or repeal
7 is expressed in terms of an amendment to, or repeal of,
8 a section or other provision, the reference shall be consid-
9 ered to be made to a section or other provision of title
10 38, United States Code.
