Mr. JOHNSTON of Florida introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

For the relief of James B. Stanley.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. APPROPRIATION OF FUNDS.**

4 (a) PAYMENT.—The Secretary of the Treasury shall
5 pay, out of any money in the Treasury not otherwise ap-
6 propriated, \$400,577 to James B. Stanley.

7 (b) BASIS.—The payment required by subsection (a)
8 shall be to compensate James B. Stanley for the physical,

1 psychological, and economic injuries sustained by him as
2 a result of the administration to him, without his knowl-
3 edge, of lysergic acid diethylamide by United States Army
4 personnel in 1958.

5 **SEC. 2. SATISFACTION OF CLAIMS.**

6 The payment made pursuant to section 1(a) shall be
7 in full satisfaction of all claims James B. Stanley may
8 have against the United States for—

9 (1) the injuries received by him as described in
10 section 1; and

11 (2) for any injuries received by him subsequent
12 to his discharge from the United States Army that
13 are the result of the injuries described in section 1.

14 **SEC. 3. INELIGIBILITY FOR ADDITIONAL BENEFITS.**

15 James B. Stanley shall not be eligible for any com-
16 pensation or benefits from the Department of Veterans
17 Affairs or the Department of Defense for any injury re-
18 ceived by him as described in section 1.

19 **SEC. 4. LIMITATION OF ATTORNEYS' OR AGENTS' FEES.**

20 It shall be unlawful for an amount of more than 10
21 per centum of the amount paid pursuant to section 1 to
22 be paid to or received by any attorney or agent of James
23 B. Stanley for any service rendered in connection with the
24 payment made by this Act. Any person who violates this
25 section shall be guilty of an infraction and shall be subject

- 1 to a fine in the amount provided in title 18, United States
- 2 Code.
