A BILL

Relating to the tariff treatment of pharmaceutical grade phospholipids and soybean oil.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PHARMACEUTICAL GRADE PHOSPHOLIPIDS.**

4 (a) IN GENERAL.—

5 (1) AMENDMENT.—Chapter 29 of the Har-
6 monized Tariff Schedule of the United States is
7 amended by striking subheading 2923.20.00 and in-
8 serting the following:

2923.20.10	Lecithins and other phospho-aminolipids: Egg phospholipids, pharmaceutical grade meeting requirements of the United States Food and Drug Administration for use in intravenous fat emulsions	1.5%	Free (A,E,IL,J) 0.8% (CA)	10%
2923.20.20	Other	2.2¢/kg. + 4/5%	Free (A*,E,IL,J) 1.1¢/kg. + 2.2% (CA)	16.5¢/kg. + 30%

1 (2) EFFECTIVE DATE.—(A) The amendment
2 made by paragraph (1) shall apply to articles en-
3 tered, or withdrawn from warehouse for consump-
4 tion, on or after the 15th day after the date of the
5 enactment of this Act.

6 (B) Notwithstanding section 514 of the Tariff
7 Act of 1930 or any other provision of law, upon
8 proper request filed with the appropriate customs of-
9 ficer before the 90th day after the date of the enact-
10 ment of this Act, any entry—

11 (i) that was made after March 29, 1991
12 and before the 15th day after the date of the
13 enactment of this Act; and

14 (ii) with respect to which there would have
15 been a lesser duty if the amendment made by
16 paragraph (1) applied to such entry,
17 shall be liquidated or reliquidated as if such amend-
18 ment applied to such entry.

19 (b) RATE OF DUTY IF PROPOSED AGREEMENT OR
20 DECLARATION IS ADOPTED.—

1 (1) **CONDITIONAL AMENDMENT.**—Subject to
2 paragraph (2), subheading 2923.20.10 of the Har-
3 monized Tariff Schedule of the United States is
4 amended—

5 (A) by striking the rate appearing in the
6 General column and inserting “Free”; and

7 (B) by striking any matter appearing in
8 the Special column.

9 (2) **CONDITION.**—The amendment made by
10 paragraph (1) shall take effect on the date that an
11 agreement or declaration that grants duty-free sta-
12 tus to articles described in subheading 3004.90 of
13 the Harmonized Tariff Schedule of the United
14 States enters into force and effect with respect to
15 the United States.

16 **SEC. 2. PHARMACEUTICAL GRADE SOYBEAN OIL.**

17 (a) **CONDITIONAL AMENDMENT.**—Subject to sub-
18 section (b), subheading 1507.90.20 of the Harmonized
19 Tariff Schedule of the United States is amended—

20 (1) by striking the rate appearing in the Gen-
21 eral column and inserting “Free”; and

22 (2) by striking any matter appearing in the
23 Special column.

24 (b) **CONDITION.**—The amendment made by sub-
25 section (a) shall take effect on the date that an agreement

1 or declaration that grants duty-free status to articles de-
2 scribed in subheading 3004.90 of the Harmonized Tariff
3 Schedule of the United States enters into force and effect
4 with respect to the United States.
