Ms. SLAUGHTER from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for the consideration of the bill (H.R. 670) to require the Secretary of Health and Human Services to ensure that pregnant women receiving assistance under title X of the Public Health Service Act are provided with information and counseling regarding their pregnancies, and for other purposes.

- 1 *Resolved*, That at any time after the adoption of this
- 2 resolution the Speaker may, pursuant to clause 1(b) of
- 3 rule XXIII, declare the House resolved into the Committee

1 of the Whole House on the state of the Union for consider-
2 ation of the bill (H.R. 670) to require the Secretary of
3 Health and Human Services to ensure that pregnant
4 women receiving assistance under title X of the Public
5 Health Service Act are provided with information and
6 counseling regarding their pregnancies, and for other pur-
7 poses. The first reading of the bill shall be dispensed with.
8 General debate shall be confined to the bill and shall not
9 exceed one hour equally divided and controlled by the
10 chairman and ranking minority member of the Committee
11 on Energy and Commerce. After general debate the bill
12 shall be considered as read for amendment under the five-
13 minute rule. No amendment to the bill shall be in order
14 except those printed in the report of the Committee on
15 Rules accompanying this resolution. Each amendment
16 may be offered only in the order printed, may be offered
17 only by the named proponent or a designee, shall be con-
18 sidered as read, shall be debatable for the time specified
19 in the report equally divided and controlled by the pro-
20 ponent and an opponent, shall not be subject to amend-
21 ment except as specified in the report, and shall not be
22 subject to a demand for division of the question in the
23 House or in the Committee of the Whole. The amendment
24 in the form of a motion to strike specified in the report
25 to be offered by Representative Bartlett of Maryland shall

1 not be in order if the text proposed to be stricken has
2 been rewritten in its entirety by earlier amendment. At
3 the conclusion of consideration of the bill for amendment
4 the Committee shall rise and report the bill to the House
5 with such amendments as may have been adopted. The
6 previous question shall be considered as ordered on the
7 bill and amendments thereto to final passage without in-
8 tervening motion except one motion to recommit.

9 SEC. 2. House Resolution 81 is hereby laid on the
10 table.
