Mr. HALL of Ohio, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 2200) to authorize appropriations to the National Aeronautics and Space Administration for research and development, space flight, control, and data communications, construction of facilities, research and program management, and Inspector General, and for other purposes.

- 1       *Resolved*, That at any time after the adoption of this
- 2 resolution the Speaker may, pursuant to clause 1(b) of
- 3 rule XXIII, declare the House resolved into the Committee

1 of the Whole House on the state of the Union for consider-  
2 ation of the bill (H.R. 2200) to authorize appropriations  
3 to the National Aeronautics and Space Administration for  
4 research and development, space flight, control, and data  
5 communications, construction of facilities, research and  
6 program management, and Inspector General, and for  
7 other purposes. The first reading of the bill shall be dis-  
8 pensed with. Points of order against consideration of the  
9 bill for failure to comply with clause 2(l)(6) of rule XI  
10 are waived. General debate shall be confined to the bill  
11 and shall not exceed one hour equally divided and con-  
12 trolled by the chairman and ranking minority member of  
13 the Committee on Science, Space, and Technology. After  
14 general debate the bill shall be considered for amendment  
15 under the five-minute rule. It shall be in order to consider  
16 as an original bill for the purpose of amendment under  
17 the five-minute rule the amendment in the nature of a sub-  
18 stitute recommended by the Committee on Science, Space,  
19 and Technology now printed in the bill. The committee  
20 amendment in the nature of a substitute shall be consid-  
21 ered by title rather than by section. Each title shall be  
22 considered as read. At the conclusion of consideration of  
23 the bill for amendment the Committee shall rise and re-  
24 port the bill to the House with such amendments as may  
25 have been adopted. Any Member may demand a separate

1 vote in the House on any amendment adopted in the Com-  
2 mittee of the Whole to the bill or to the committee amend-  
3 ment in the nature of a substitute. The previous question  
4 shall be considered as ordered on the bill and amendments  
5 thereto to final passage without intervening motion except  
6 one motion to recommit with or without instructions.
