Mr. DERRICK from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2295) making appropriations for foreign operations, export financing, and related programs for the fiscal year ending September 30, 1994, and making supplemental appropriations for such programs for the fiscal year ending September 30, 1993, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee

1 of the Whole House on the State of the Union for consid-
2 eration of the bill (H.R. 2295) making appropriations for
3 foreign operations, export financing, and related programs
4 for the fiscal year ending September 30, 1994, and mak-
5 ing supplemental appropriations for such programs for the
6 fiscal year ending September 30, 1993, and for other pur-
7 poses. The first reading of the bill shall be dispensed with.
8 All points of order against consideration of the bill are
9 waived. After general debate, which shall be confined to
10 the bill and the amendment in the nature of a substitute
11 recommended by the Committee on Appropriations and
12 which shall not exceed one hour equally divided and con-
13 trolled by the chairman and ranking minority member of
14 the Committee on Appropriations, the pending question
15 shall be the adoption of the amendment in the nature of
16 a substitute recommended by the Committee on Appro-
17 priations now printed in the bill. The committee amend-
18 ment in the nature of a substitute shall be designated and
19 shall be debatable for twenty minutes equally divided and
20 controlled by the chairman and ranking minority member
21 of the Committee on Appropriations. All points of order
22 against the committee amendment in the nature of a sub-
23 stitute, and against provisions in the bill if so amended,
24 are waived. If the committee amendment in the nature of
25 a substitute is adopted, then the bill as so amended shall

1 be considered as the original bill for the purpose of further
2 amendment under the five-minute rule and shall be consid-
3 ered as read. No further amendment shall be in order ex-
4 cept those printed in the report of the Committee on Rules
5 accompanying this resolution. Each amendment may be
6 offered only in the order printed, may be offered only by
7 the named proponent or a designee, shall be considered
8 as read, shall be debatable for the time specified in the
9 report equally divided and controlled by the proponent and
10 an opponent, shall not be subject to amendment except
11 as specified in the report, and shall not be subject to a
12 demand for division of the question in the House or in
13 the Committee of the Whole. At the conclusion of consider-
14 ation of the bill for amendment the Committee shall rise
15 and report the bill to the House with such amendments
16 as may have been finally adopted. Any Member may de-
17 mand a separate vote in the House on any amendment
18 adopted in the Committee of the Whole to the bill or to
19 the committee amendment in the nature of a substitute.
20 The previous question shall be considered as ordered on
21 the bill and amendments thereto to final passage without
22 intervening motion except one motion to recommit with
23 or without instructions.
