RESOLUTION

Waiving certain points of order against the bill (H.R. 2490) making appropriations for the Department of Transportation and related agencies for the fiscal year ending September 30, 1994, and for other purposes.

1 *Resolved*, That points of order against consideration
2 of the bill (H.R. 2490) making appropriations for the De-
3 partment of Transportation and related agencies for the
4 fiscal year ending September 30, 1994, and for other pur-
5 poses, for failure to comply with clause 7 of rule XXI are
6 waived. During consideration of the bill, all points of order

1 against provisions in the bill for failure to comply with
2 clause 2 or 6 of rule XXI are waived except as follows:
3 beginning on page 17, line 14, through line 24; beginning
4 on page 18, line 16, through line 20; beginning on page
5 20, line 4, through line 22; beginning on page 23, line
6 8, through line 12; beginning with “: *Provided*’ on page
7 27, line 2, through “1341” on line 6; beginning on page
8 48, line 11, through page 49, line 8; beginning on page
9 51, line 16, through line 23; beginning on page 53, line
10 7, through line 22; beginning on page 54, line 15, through
11 page 55, line 14; beginning on page 56, line 1, through
12 page 57, line 9; beginning on page 57, line 14, through
13 page 58, line 11; and beginning on page 58, line 15,
14 through page 59, line 2. Where points of order are waived
15 against only part of a paragraph, a point of order against
16 matter in the balance of the paragraph may be applied
17 only within the balance of the paragraph and not against
18 the entire paragraph. Amendments en bloc offered by Rep-
19 resentative Carr of Michigan or a designee may amend
20 portions of the bill not yet read for amendment and por-
21 tions of the bill already passed in the reading, shall be
22 considered as read, and shall not be subject to a demand
23 for division of the question in the House or in the Commit-
24 tee of the Whole. The amendments en bloc specified in
25 the report of the Committee on Rules accompanying this

1 resolution to be offered by Representative Tauzin of Lou-
2 isiana or a designee may amend portions of the bill not
3 yet read for amendment, shall be considered as read, and
4 shall not be subject to a demand for division of the ques-
5 tion in the House or in the Committee of the Whole.
