Mr. BONIOR, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 1964) to authorize appropriations for the Maritime Administration for fiscal year 1994, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 1964) to authorize appropriations
6 for the Maritime Administration for fiscal year 1994, and
7 for other purposes. The first reading of the bill shall be

1 dispensed with. General debate shall be confined to the
2 bill and shall not exceed one hour equally divided and con-
3 trolled by the chairman and ranking minority member of
4 the Committee on Merchant Marine and Fisheries. After
5 general debate the bill shall be considered for amendment
6 under the five-minute rule. It shall be in order to consider
7 as an original bill for the purpose of amendment under
8 the five-minute rule the amendment in the nature of a sub-
9 stitute recommended by the Committee on Merchant Ma-
10 rine and Fisheries now printed in the bill. Each section
11 of the committee amendment in the nature of a substitute
12 shall be considered as read. Points of order against the
13 committee amendment in the nature of a substitute for
14 failure to comply with clause 5(a) of rule XXI are waived.
15 It shall be in order at any time to consider the amend-
16 ments en bloc printed in the report of the Committee on
17 Rules accompanying this resolution, if offered by the
18 chairman of the Committee on Merchant Marine and Fish-
19 eries or a designee. The amendments en bloc shall be con-
20 sidered as read and shall not be subject to a demand for
21 division of the question in the House or in the Committee
22 of the Whole. Points of order against the amendments en
23 bloc for failure to comply with clause 7 of rule XVI are
24 waived. At the conclusion of consideration of the bill for
25 amendment the Committee shall rise and report the bill

1 to the House with such amendments as may have been
2 adopted. Any Member may demand a separate vote in the
3 House on any amendment adopted in the Committee of
4 the Whole to the bill or to the committee amendment in
5 the nature of a substitute. The previous question shall be
6 considered as ordered on the bill and amendments thereto
7 to final passage without intervening motion except one
8 motion to recommit with or without instructions.
