RESOLUTION

Waiving points of order against the conference report to accompany the bill (H.R. 2264) to provide for reconciliation pursuant to section 7 of the concurrent resolution on the budget for fiscal year 1994.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider the conference report to ac-
3 company the bill (H.R. 2264) to provide for reconciliation
4 pursuant to section 7 of the concurrent resolution on the
5 budget for fiscal year 1994. All points of order against
6 the conference report and against its consideration are

1 waived. The conference report shall be considered as read.
2 The conference report shall be debatable for six hours,
3 with one hour equally divided and controlled by the chair-
4 man and ranking minority member of the Committee on
5 Ways and Means; twenty minutes equally divided and con-
6 trolled by the chairman and ranking minority member of
7 the Committee on Agriculture; twenty minutes equally di-
8 vided and controlled by the chairman and ranking minor-
9 ity member of the Committee on Armed Services; twenty
10 minutes equally divided and controlled by the chairman
11 and ranking minority member of the Committee on Bank-
12 ing, Finance and Urban Affairs; twenty minutes equally
13 divided and controlled by the chairman and ranking mi-
14 nority member of the Committee on Education and Labor;
15 twenty minutes equally divided and controlled by the
16 chairman and ranking minority member of the Committee
17 on Energy and Commerce; twenty minutes equally divided
18 and controlled by the chairman and ranking minority
19 member of the Committee on Foreign Affairs; twenty min-
20 utes equally divided and controlled by the chairman and
21 ranking minority member of the Committee on the Judici-
22 ary; twenty minutes equally divided and controlled by the
23 chairman and ranking minority member of the Committee
24 on Merchant Marine and Fisheries; twenty minutes equal-
25 ly divided and controlled by the chairman and ranking mi-

1 nority member of the Committee on Natural Resources;
2 twenty minutes equally divided and controlled by the
3 chairman and ranking minority member of the Committee
4 on Post Office and Civil Service; twenty minutes equally
5 divided and controlled by the chairman and ranking mi-
6 nority member of the Committee on Public Works and
7 Transportation; twenty minutes equally divided and con-
8 trolled by the chairman and ranking minority member of
9 the Committee on Veterans' Affairs; and one hour equally
10 divided and controlled by the chairman and ranking mi-
11 nority member of the Committee on the Budget. The pre-
12 vious question shall be considered as ordered on the con-
13 ference report to final adoption without intervening mo-
14 tion except one motion to recommit, which may not con-
15 tain instructions and on which the previous question shall
16 be considered as ordered. After disposition of the con-
17 ference report, no further consideration of the bill shall
18 be in order except pursuant to a subsequent order of the
19 House.
