RESOLUTION

Providing amounts from the contingent fund of the House for the expenses of investigations and studies by certain committees of the House in the second session of the One Hundred Third Congress.

10 *section 202(j) of such Act.*

16 *SEC. 5. In addition to any other activity referred to*
17 *in this resolution, the Committee on House Administration,*
18 *using funds from the amount specified with respect to that*
19 *Committee in section 2—*

20 *(1) shall, through House Information Systems,*
21 *develop, operate, maintain, and improve computer*
22 *and information services for the House, including di-*
23 *rect computer and information systems support for*
24 *Members, committees, administrative offices, and*

1 *other governmental entities, and shall conduct nec-*
2 *essary investigations and studies of such services;*

3 *(2) is authorized to oversee any reimbursement*
4 *for services described in paragraph (1) and any ex-*
5 *penditure of amounts so reimbursed; and*

6 *(3) is authorized to provide for professional de-*
7 *velopment programs, office and personnel manage-*
8 *ment consultation services, and periodic publication*
9 *of handbooks, guides, bulletins, and other items nec-*
10 *essary for the House.*

11 *SEC. 6. Payments under this resolution shall be made*
12 *on vouchers authorized by the committee involved, signed*
13 *by the chairman of such committee, and approved by the*
14 *Committee on House Administration.*

15 *SEC. 7. Amounts shall be available under this resolu-*
16 *tion for investigations and studies carried out during the*
17 *period beginning at noon on January 3, 1994, and ending*
18 *immediately before noon on January 3, 1995.*

19 *SEC. 8. Amounts made available under this resolution*
20 *shall be expended in accordance with regulations prescribed*
21 *by the Committee on House Administration.*

22 *SEC. 9. The Committee on House Administration shall*
23 *have authority to make adjustments in amounts for inves-*
24 *tigations and studies under section 2, if necessary to comply*
25 *with an order of the President issued under section 254 of*

- 1 *the Balanced Budget and Emergency Deficit Control Act*
- 2 *of 1985 or to conform to any reduction in appropriations*
- 3 *for the purposes of such section 2.*
