A BILL

To amend the Act establishing the Lower East Side
Tenement National Historic Site, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Lower East Side Tene-*
5 *ment National Historic Site Amendments Act”.*

6 **SEC. 2. AMENDMENTS.**

7 *Public Law 105–378 is amended—*

8 *(1) in section 101(a)—*

9 *(A) in paragraph (4), by striking “the*
10 *Lower East Side Tenement at 97 Orchard Street*
11 *in New York City is an outstanding survivor”*
12 *and inserting “the Lower East Side Tenements*
13 *at 97 and 103 Orchard Street in New York City*
14 *are outstanding survivors”; and*

15 *(B) in paragraph (5), by striking “the*
16 *Lower East Side Tenement is” and inserting*
17 *“the Lower East Side Tenements are”;*

18 *(2) in section 102—*

19 *(A) in paragraph (1), by striking “Lower*
20 *East Side Tenement found at 97 Orchard Street”*
21 *and inserting “Lower East Side Tenements*
22 *found at 97 and 103 Orchard Street”; and*

23 *(B) in paragraph (2), by striking “which*
24 *owns and operates the tenement building at 97*
25 *Orchard Street” and inserting “which owns and*

1 *operates the tenement buildings at 97 and 103*
2 *Orchard Street*”;

3 (3) *in section 103(a), by striking “the Lower*
4 *East Side Tenement at 97 Orchard Street, in the City*
5 *of New York, State of New York, is designated” and*
6 *inserting “the Lower East Side Tenements at 97 and*
7 *103 Orchard Street, in the City of New York, State*
8 *of New York, are designated”;* and

9 (4) *in section 104(d), by striking “the property*
10 *at 97 Orchard Street” and inserting “the properties*
11 *at 97 and 103 Orchard Street”.*
