Mr. BEILENSON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (S. 208) to reform the concessions policies
6 of the National Park Service, and for other purposes. The
7 first reading of the bill shall be dispensed with. Points of
8 order against consideration of the bill for failure to comply
9 with section 302(f) of the Congressional Budget Act of

1 1974 are waived. General debate shall be confined to the
2 bill and shall not exceed one hour equally divided and con-
3 trolled by the chairman and ranking minority member of
4 the Committee on Natural Resources. After general debate
5 the bill shall be considered for amendment under the five-
6 minute rule. It shall be in order to consider as an original
7 bill for the purpose of amendment under the five-minute
8 rule the amendment in the nature of a substitute rec-
9 ommended by the Committee on Natural Resources now
10 printed in the bill, modified by the amendment printed in
11 the report of the Committee on Rules accompanying this
12 resolution. Each section of the committee amendment in
13 the nature of a substitute, as modified, shall be considered
14 as read. Points of order against the committee amendment
15 in the nature of a substitute, as modified, for failure to
16 comply with clause 5(a) of rule XXI are waived. At the
17 conclusion of consideration of the bill for amendment the
18 Committee shall rise and report the bill to the House with
19 such amendments as may have been adopted. Any Member
20 may demand a separate vote in the House on any amend-
21 ment adopted in the Committee of the Whole to the bill
22 or to the committee amendment in the nature of a sub-
23 stitute, as modified. The previous question shall be consid-
24 ered as ordered on the bill and amendments thereto to

- 1 final passage without intervening motion except one mo-
- 2 tion to recommit with or without instructions.
