Mr. MOAKLEY, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4003) to authorize appropriations for fiscal year 1995 for certain maritime programs of the Department of Transportation, to amend the Merchant Marine Act, 1936, as amended, to revitalize the United States-flag merchant marine, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee

1 of the Whole House on the state of the Union for consider-
2 ation of the bill (H.R. 4003) to authorize appropriations
3 for fiscal year 1995 for certain maritime programs of the
4 Department of Transportation, to amend the Merchant
5 Marine Act, 1936, as amended, to revitalize the United
6 States-flag merchant marine, and for other purposes. The
7 first reading of the bill shall be dispensed with. All points
8 of order against consideration of the bill are waived. Gen-
9 eral debate shall be confined to the bill and shall not ex-
10 ceed one hour, with thirty minutes equally divided and
11 controlled by the chairman and ranking minority member
12 of the Committee on Merchant Marine and Fisheries and
13 thirty minutes equally divided and controlled by the chair-
14 man and ranking minority member of the Committee on
15 Ways and Means. After general debate the bill shall be
16 considered for amendment under the five-minute rule. It
17 shall be in order to consider as an original bill for the
18 purpose of amendment under the five-minute rule the
19 amendment in the nature of a substitute recommended by
20 the Committee on Merchant Marine and Fisheries now
21 printed in the bill, modified by the amendment rec-
22 ommended by the Committee on Ways and Means now
23 printed in the bill and by the amendment printed in part
24 1 of the report of the Committee on Rules accompanying
25 this resolution. The committee amendment in the nature

1 of a substitute, as modified, shall be considered as read.
2 All points of order against the committee amendment in
3 the nature of a substitute, as modified, are waived. No
4 amendment directly or indirectly changing title II of the
5 committee amendment in the nature of a substitute, as
6 modified, shall be in order except the amendment printed
7 in part 2 of the report of the Committee on Rules. That
8 amendment may be offered only by a Member designated
9 in the report, shall be considered as read, shall be debat-
10 able for the time specified in the report equally divided
11 and controlled by the proponent and an opponent, and
12 shall not be subject to amendment. All points of order
13 against the amendment printed in part 2 of the report
14 are waived. At the conclusion of the consideration of the
15 bill for amendment the Committee shall rise and report
16 the bill to the House with such amendments as may have
17 been adopted. Any Member may demand a separate vote
18 in the House on any amendment adopted in the Commit-
19 tee of the Whole to the bill or to the committee amend-
20 ment in the nature of a substitute, as modified. The pre-
21 vious question shall be considered as ordered on the bill
22 and amendments thereto to final passage without inter-
23 vening motion except one motion to recommit with or
24 without instructions.

1 SEC. 2. In the engrossment of H.R. 4003, the Clerk
2 shall insert the text of H.R. 2151, as passed by the House,
3 as a new title I and shall redesignate the succeeding titles
4 accordingly.
