IN THE HOUSE OF REPRESENTATIVES

Mr. BONIOR, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of a joint resolution and a bill relating to most-favored-nation treatment for the People's Republic of China.

1 *Resolved*, That upon the adoption of this resolution
2 it shall be in order to consider in the House the joint reso-
3 lution (H. J. Res. 373) disapproving the extension of non-
4 discriminatory treatment (most-favored-nation treatment)
5 to the products of the People's Republic of China, and
6 for other purposes. All points of order against the joint
7 resolution and against its consideration are waived. The

1 joint resolution shall be debatable for eighty minutes
2 equally divided and controlled by Representative Solomon
3 of New York and Representative Gibbons of Florida or
4 their designees. Pursuant to sections 152 and 153 of the
5 Trade Act of 1974, the previous question shall be consid-
6 ered as ordered on the joint resolution to final passage
7 without intervening motion. The provisions of sections 152
8 and 153 of the Trade Act of 1974 shall not apply to any
9 other joint resolution disapproving the extension of most-
10 favored-nation treatment to the People's Republic of
11 China for the remainder of the One Hundred Third Con-
12 gress.

13 SEC. 2. After disposition of the joint resolution (H.
14 J. Res. 373), the Speaker may, pursuant to clause 1(b)
15 of rule XXIII, declare the House resolved into the Com-
16 mittee of the Whole House on the state of the Union for
17 consideration of the bill (H.R. 4590) to provide conditions
18 for renewing nondiscriminatory (most-favored-nation)
19 treatment for the People's Republic of China. The first
20 reading of the bill shall be dispensed with. All points of
21 order against the bill and against its consideration are
22 waived. General debate shall be confined to the bill and
23 the amendments made in order by this resolution and shall
24 not exceed one hour equally divided and controlled by the
25 chairman and ranking minority member of the Committee

1 on Ways and Means. After general debate the bill shall
2 be considered for amendment under the five-minute rule
3 and shall be considered as read. No amendment shall be
4 in order except those printed in the report of the Commit-
5 tee on Rules accompanying this resolution. Each amend-
6 ment may be offered only by a Member designated in the
7 report, shall be considered as read, shall be debatable for
8 the time specified in the report equally divided and con-
9 trolled by the proponent and an opponent, and shall not
10 be subject to amendment. All points of order against the
11 amendments printed in the report are waived. If more
12 than one of the amendments printed in the report is
13 adopted, only the last to be adopted shall be considered
14 as finally adopted and reported to the House. At the con-
15 clusion of consideration of the bill for amendment the
16 Committee shall rise and report the bill to the House with
17 such amendment as may have been finally adopted. The
18 previous question shall be considered as ordered on the
19 bill and any amendment thereto to final passage without
20 intervening motion except one motion to recommit with
21 or without instructions.
